Fire and Emergency Services Superannuation Act 1985

Fire and Emergency Services (Superannuation Fund) Amendment Regulations (No. 2) 2003

Made by the Governor in Executive Council.

1. Citation

These regulations may be cited as the *Fire and Emergency Services (Superannuation Fund) Amendment Regulations (No. 2) 2003*.

2. The regulations amended

The amendments in these regulations are to the *Fire and Emergency Services (Superannuation Fund) Regulations 1986**.

3. Regulation 3 amended

 - (ii) who, immediately before becoming such a member, was not a Category C member;

TOWN PLANNING SCHEME AVAILABLE FOR INSPECTION

City of Fremantle
City Planning Scheme No. 4

Ref: 853/2/5/8

Notice is hereby given that the local government of the City of Fremantle has prepared the abovementioned Town Planning Scheme for the purpose of:

- 1. setting out the Council's planning aims and intentions for the Scheme Area, including individual precincts;
- 2. setting aside land as reserves for public purposes;
- 3. zoning land within the Scheme Area for the purposes defined in the Scheme;
- 4. controlling and guiding land use and development;
- 5. setting out procedures for the assessment and determination of planning applications;
- 6. making provision for the administration and enforcement of the Scheme; and
- 7. addressing other matters contained in the Schedule 1 of the Town Planning Act.

The Western Australian Planning Commission advises as follows:

1. Leighton:

The Commission has required that the Leighton Marshalling Yards area be omitted from City Planning Scheme No. 4 (CPS No. 4) at this stage as it is to be the subject of Amendment 1074/33 to the Metropolitan Region Scheme (MRS) and Amendment No. 61 to the City's current Town Planning Scheme No. 3. Both of those amendments are undergoing statutory public consultation processes. It is anticipated that the amendments will be ready for finalisation prior to the finalisation of CPS No. 4; consequently, the outcomes of those amendments will be included in the final version of CPS No. 4.

2. Fremantle Eastern Bypass:

The Commission has required that the land the subject of the existing MRS reserve for the Eastern Bypass be omitted from City Planning Scheme No. 4 (CPS No. 4) at this stage as it is to be the subject of Amendment 1055/33 to the MRS and Amendment No. 57 to the City of Fremantle Town Planning Scheme No. 3. Both of those amendments are undergoing statutory public consultation processes. It is anticipated that the amendments will be ready for finalisation prior to the finalisation of CPS No. 4; consequently, the outcomes of those amendments will be included in the final version of CPS No. 4.

3. Regional Transport Matters:

The Commission has required that apart from the Fremantle Eastern Bypass, CPS No. 4 is to reflect all other existing MRS regional transport reserves. While the Commission recognises that the results of the following studies, namely the Direct Rail Link to North Quay, the Freight Network Review and the Fremantle to Rockingham Transitway, may impact on CPS No. 4 in the future, CPS No. 4 does not intend to pre-empt the outcomes of these regional studies.

Plans and documents setting out and explaining the Town Planning Scheme have been deposited at Council Offices, Town Hall Centre, 8 William Street, Fremantle and at the Western Australian Planning Commission, Albert Facey House, 469 Wellington Street, Perth, and will be available for inspection during office hours up to and including 17 October 2003.

Submissions on the Town Planning Scheme may be made in writing on Form No 4 and lodged with the undersigned on or before 17 October 2003.

OCCUPATIONAL SAFETY AND HEALTH REGULATIONS 1996

Exemption Certificate Pursuant to Regulation 2.13

(No. 19 of 2003)

I, Brian Thomas Bradley, WorkSafe Western Australia Commissioner, hereby grant a temporary exemption to Arrowmist Pressure Cleaning from the requirements of Regulations 5.14, 5.50 & 5.51 of the *Occupational Safety and Health Regulations 1996* to enable two 90 minute tests of an asbestos tile cleaning method using wet garnet blasting on low pressure at 36 Gardiner Road, Como.

This exemption is subject to the following conditions:

- The cleaning takes place within a fully sealed enclosure.
- The enclosure has an airlock type entrance.
- A fine water mist spray is installed within the enclosure and operates while tile cleaning is undertaken.
- All windows, doors and other inlets are fully sealed.
- Airborne monitoring is conducted during tile cleaning to determine the concentration of asbestos fibres generated during the process.
- Appropriate personal protective equipment, including positive pressure air supplied respirators and disposable overalls, is worn by all persons within the enclosure.

• All equipment used within the enclosure is decontaminated after use.

This exemption expires on 26 July 2003.
