# **Labour Relations Reform (Consequential Amendments) Regulations 2003**

## CONSERVATION AND LAND MANAGEMENT ACT 1984

Two Peoples Bay Nature Reserve 1995-2005

Notice of Proposed Amendment to Management Plan

The Conservation Commission of Western Australia advises that an amendment is proposed to the Two Peoples Bay Nature Reserve Management Plan.

In 1995 the Management Plan proposed to change the tenure of the reserve from nature reserve to national park to reflect the high levels of recreational use. Subsequent representations from the public and other key stakeholders have put forward the case for the reserve's tenure to remain as nature reserve. If the reserve were to remain as nature reserve, the level of recreational use will remain as at the time of gazettal of this proposed amendment. Any subsequent changes to the level of recreational use could only occur following a further amendment, or the preparation of a new management plan.

This proposal to retain the Nature Reserve status of Two Peoples Bay Nature Reserve is open for public comment. A notice appearing in the "Government Gazette" on 16 May 2003 stated a closing date for submissions as 8 August 2003. The closing date for submissions is now extended to 10 October 2003
