HERITAGE OF WESTERN AUSTRALIA ACT 1990

ENTRY OF PLACES IN THE REGISTER OF HERITAGE PLACES

Notice is hereby given in accordance with Section 51(2) of the Heritage of Western Australia Act 1990 that, pursuant to directions from the Minister for Heritage, the places described in Schedule 1 have been entered in the Register of Heritage Places on a permanent basis with effect from today.

Schedule 1

Description of Place

Cole's Shaft (fmr) at Summit View, Armadale; Lt 49 on DP 33541 being R 46948 the whole of the land contained in CLT V 3130 F 42.

Fremantle Court House & Police Station Complex at 39 Henderson Street, Fremantle; Lt 2135 on DP 221172, being CR 24043 & being the whole of the land comprised in CLT V 3120 F 863. Lt 2136 on DP 221172, being CR 46289 & being the whole of the land comprised in CLT V 3120 F 864.

Jarrah Tree, Armadale at Cnr Third Road and Church Avenue, Armadale; That pt of Lt 14 on DP 187801, & being pt of the land comprised in C/T V 2204 F 500 as is defined in HCWA survey No. 9009 prepared by Steffanoni Ewing & Cruickshank Pty. Ltd.

Kulahea at 4 Forrest Street, Cottesloe; Lt 120 on D 83711, being the whole of the land comprised in C/T V 1953 F 594.

Mahogany Inn at 4260 Great Eastern Highway, Mahogany Creek; That ptn of Lt 1 on D 42757 being part of the land contained in C/T V 1726 F 341 as is defined in HCWA survey No. 1693 prepared by Steffanoni Ewing & Cruickshank Pty Ltd.

Midland Inn at 408 Great Eastern Highway, Midland; Lt 102 and part of Lt 104 on P 3052 (sheet 1), being part of the land comprised in C/T V 1559 F 844.

Narra Tarra Homestead, Outbuildings & Cemetery at Former East Chapman Road, Howatharra; Ptn of Narra Tarra Estate Lt 11 & being part of the land comprised in C/T V 2047 F 248. Victoria Loc 873 & being the whole of the land comprised in C/T V 27 F 98 as together are defined in HCWA Survey No. 6353 as prepared by Warren King & Company & Midland Survey Services.

Norseman Post Office at 82 Prinsep Street cnr Ramsay Street, Norseman; Norseman Lt 48 being the whole of the land contained in C/T V 1967 F 765.

Northampton Roads Board Building at Hampton Road (North West Coastal Highway), Northampton; Lt 31 on DP 222925 being the whole of the land comprised in C/T V 408 F 57.

Railway Water Tank, Corrigin at Corrigin railway reserve, alongside Connelly Parade, Corrigin; Ptn of unnumbered Railway Reserve on P 3787 as is defined in HCWA Survey No. 8190 as prepared by Warren King & Company and Midland Survey Services.

Site of Buildings, Burt Way at 3-8 Burt Way and 96-98 and 102-104 Terrace Road, East Perth; Lts 991 & 992 on DP 35286 being the whole of the land contained in C/Ts V 2224 F 837 & V 2224 F 838.

Pursuant to directions from the Minister for Heritage, notice is hereby given in accordance with Section 49(1) of the Heritage of Western Australia Act 1990 that it is proposed that the places described in Schedule 2 be entered in the Register of Heritage Places. The Heritage Council invites submissions on the proposal which must be in writing & should be forwarded to the address below not later than 21 October 2003. The places will be entered in the Register on an interim basis with effect from today.

Description of Place

Claremont Council Offices & Surroundings at 308 Stirling Highway Cnr Bay View Terrace, Claremont; Melville Suburban Lt 143 being the whole of R 6452, being the whole of the land comprised in CLR V 3095 F 941.

Geraldton Drill Hall at Cnr Lester & Cathedral Avenues, Geraldton; Geraldton Town Lt 28 & part of Geraldton Town Lt 29 being part of the land contained in C/T V 1036 F 17.

Moreton Terrace & Point Leander Drive Fig Trees, Dongara at Moreton Terrace and Point Leander Drive, Dongara; Lt 12 on D 88837 being the whole of the land contained in C/T V 2218 F 360 together with that ptn of the Moreton Terrace road reserve as is defined by HCWA Survey No. 4367 as prepared by Cadgraphics WA.
