Shire of Boddington

Health Local Laws 2003

Made by the Council of the Shire of Boddington under section 342 of the *Health Act* 1911 in accordance with subdivision 2 of Division 2 of Part 3 of the *Local* Government Act 1995.

Citation

1. These Local Laws may be cited as the "Shire of Boddington Health Local Laws 2003".

Incorporation by Reference

2. (i) In these Local Laws, "The Shire of Williams Health Local Laws 2000"—

- (a) means *The Shire of Williams Health Local Laws 2000* published in the *Government Gazette*, special edition number 93, on the 11 May 2001; and
- (b) does not include any amendments that might be made to those Local Laws

(ii) Subject to the modifications set out in the Schedule, *The Shire of Williams Health Local Laws 2000* are incorporated with and form part of these Local Laws.

Repeal

3. (1) The Health Local Laws adopted by the Marradong Road Board and published in the *Government Gazette* on 8 July 1938, and amended from time to time are repealed;

(2) The Health Local Laws adopted by the Marradong Road Board on 12 August 1953 and published in the *Government Gazette* on 13 November 1953, and amended from time to time are repealed;

Shire of Chittering

Cemeteries Local Laws 2003

Under the powers conferred by the Cemeteries Act 1986, the Shire of Chittering resolved on the 16th day of January 2003 to adopt the Model Local Law (Cemeteries) 1998 published in the *Government Gazette* on 12 May 1998 in relation to the Chittering Cemetery, with such modifications as are here set out.

1. Preliminary

1.1 In construing the following modifications, where a modification requires the renumbering of a clause, subclause or paragraph, subsequent modifications have been drafted on the basis that the renumbering has been effected.

1.2 Wherever the name of the Local Government is to be inserted, insert "Shire of Chittering".

1.3 Wherever the name of the Local Law is to be inserted, insert "Cemeteries Local Law 2003".

1.4 Wherever the address of the Local Government is to be inserted, insert "Great Northern Highway, (PO Box 70) Bindoon".

2. Application clause inserted

2.1 Renumber clauses 1.2 and 1.3 to ``1.3" and ``1.4" respectively.

- 2.2 Insert the following new clause-
 - "1.2 Application

This Local Law applies to the Chittering Cemetery, Gray Road, Bindoon.

Delete paragraph (d).

11. Part 5, Division 2-Cremation

In Part 5, delete the whole of Division 2-Cremation.

12. Part 5, Division 3—Placement of Ashes

In Part 5—

- (a) renumber Division 3 to "Division 2";
- (b) renumber clause 5.12 to "5.7"; and
- (c) delete clauses 5.13 and 5.14.

13. Second Schedule

In the Second Schedule, delete the prefix "19" where it is used as part of the date an alleged offence occurred and substitute "20".

 - (a) a business letter;
 - (b) a written communication issued by the holder of the licence to the effect that a person owes or does not owe money to him or her (being a statement of account);

- (c) a receipt (being a written acknowledgment of payment);
- (d) a written quotation of a price for particular goods or services;
- (e) a written offer to contract for goods or services;
- (f) an invoice (being a written communication identifying goods or services that have been provided, and the prices of those goods or services).

25B. Records to be kept of work carried out

- The holder of a plumbing contractor's licence must keep a record relating to plumbing work carried out under his or her general direction and control or supervised by him or her.
- (2) A record required by subregulation (1) must be in a form approved by the Board and must show
 - (a) the full name of each licensee or apprentice involved in the carrying out of the work;
 - (b) the residential or business address of that person;
 - (c) the number and class of the licence held by that person; and
 - (d) the period for which that person was involved in the carrying out of the work.
- (3) A record required by subregulation (1) must be kept at the licence holder's principal place of business.
- (4) A person required by subregulation (1) to keep a record must keep the record for at least one year after the end of the period to which the record relates.
- (5) A person who has a record required by subregulation (1) must produce the record for inspection upon being requested to do so by the Board or a person authorised by the Board.Penalty: \$5 000.






