1. This order may be cited as the *Recreational Abalone Fishery (Revocation) Order 2003*.

**Commencement**

2. This order comes into operation on the day on which *Fish Resources Management Amendment Regulations (No. 8) 2003* come into operation.

**Revocation**

3. The notices specified in the Schedule, which were made under the *Fisheries Act 1905* and continued in force under regulation 186 of the *Fish Resources Management Regulations 1995* as if they were orders made under section 43 of the Act, are revoked.

1. This order may be cited as the *Prawn Hand Trawl Net (Revocation) Order 2003*.

**Commencement**

2. This order comes into operation on the day on which *Fish Resources Management Amendment Regulations (No. 8) 2003* come into operation.

**Revocation**

3. Notice number 172 published in the *Government Gazette* of 21 December 1984 (p 4177), which was made under the *Fisheries Act 1905* and was continued in force under regulation 186 of the *Fish Resources Management Regulations 1995* as if it were an order made under section 43 of the Act, is revoked.

## RECREATIONAL FISHING (PERMITTED FISHING METHODS) AMENDMENT ORDER 2003

Order No. 19 of 2003

FD 1620/98 [572]

Made by the Minister under section 43.

**Citation**

1. This order may be cited as the *Recreational Fishing (Permitted Fishing Methods) Amendment Order 2003*.

**Commencement**

2. This order comes into operation on the day on which *Fish Resources Management Amendment Regulations (No. 8) 2003* come into operation.

**Order amended**

3. The amendments in this order are to the *Recreational Fishing (Permitted Fishing Methods) Order 1991\**.

**Clause 4 deleted and inserted**

4. Clause 4 is deleted and the following clause is inserted instead —

**“Exemption**

4. The provisions of this order apply to all persons other than —

- (a) the holder of a commercial fishing licence when engaged in fishing from a licensed fishing boat;
- (b) a person who does not hold a commercial fishing licence when engaged in fishing by line.”
