Shire of Gnowangerup

#### LOCAL GOVERNMENT PROPERTY LOCAL LAW

Under the powers conferred by the *Local Government Act 1995* and under all other powers enabling it, the Council of the Shire of Gnowangerup resolved on 12 November 2003 to make the following local law—

The Shire of Kojonup Local Government Property Local Law as published in the *Government Gazette* of 16 May 2000, is adopted as a local law of the Shire of Gnowangerup, with the modifications which follow:—

#### 1. Preliminary

1.1 In construing the following modifications, where a modification requires the renumbering of a clause, subclause or paragraph, subsequent modifications have been drafted on the basis that the renumbering has been effected.

1.2 Wherever the "Shire of Kojonup" is mentioned in the local law substitute "Shire of Gnowangerup".

#### 2. Clause 1.5—Repeal

Delete subclause 1.5(1) and substitute—

"1.5 (1) The following local laws are repealed—

- (a) the Management of Road Board Halls published in the *Government Gazette* of 8 April 1926;
- (b) the control of Commons published in the Government Gazette of 29 October 1926, as amended in the Government Gazette of 24 December 1936 and 1 September 1939;
- (c) the control of Library published in the *Government Gazette* of 28 March 1947;

- (d) the control of Fishing published in the *Government Gazette* of 19 December 1947;
- (e) the control of Saleyards published in the *Government Gazette* of 18 January 1952;
- (f) the control of Halls—Scale of Charges published in the Government Gazette of 27 May 1955;
- (g) the control of Parks, Roads, Camping, Firearms etc published in the *Government Gazette* of 8 February 1957;
- (h) the Management of Swimming Pool and Aylmore Park published in the Government Gazette of 25 June 1958, as amended in the Government Gazette of 12 December 1961;
- (i) the control of Public Hall published in the *Government Gazette* of 25 August 1958, as amended in the *Government Gazette* of 17 August 1960 and 26 July 1972;
- (j) the control of Fishing published in the *Government Gazette* of 26 September 1968;
- (k) the control of Safety, Decency, Convenience and Comfort of Persons in Respect of Bathing published in the *Government Gazette* of 13 January 1971;
- (l) the control of Fishing published in the *Government Gazette* of 29 December 1972, as amended in the *Government Gazette* of 22 March 1974, 26 April 1974, 7 February 1975 and 11 July 1975; and
- (m) the Use of Vehicles on Council Land published in the *Government Gazette* of 6 September 1985.

#### 3 Part 2—Determinations in respect to local government property

3.1 In clause 2.2 subclause (3) paragraph (b), insert "(5)" after "subclause";

3.2 In clause 2.7 subclause (1) paragraph (f), insert " and" after "property;"; and

3.3 In clause 2.7 subclause (1) paragraph (g) delete "device;" and substitute "device."

#### 4. Clause 3.13—Activities needing a permit

- 4.1 In subclause (1)—
  - (a) In paragraph (g) subparagraph (ii) delete "stand" and substitute "stop";
  - (b) In paragraph (n), after ";" delete "or";
  - (c) In paragraph (o) after "property" and insert "; or"; and
  - (d) Insert the paragraph—
    - "(p) conduct or take part in any gambling game or contest, or bet, or offer to bet, publicly.".

#### 5. Part 5—Matters Relating to Particular Local Government Property

5.1 Renumber clauses 5.5 to 5.7 inclusive to 5.3 to 5.5 respectively.

5.2 In Division 1, immediately after clause 5.1, insert—

"Consumption of food or drink may be prohibited

 $5.2~\mathrm{A}$  person shall not consume any food or drink in an area where consumption is prohibited by a sign.".
