Special Provisions

1.0 Subdivision Guide Plan

- 1.1 Subdivision of Special Rural Zone No 30 shall generally be in accordance with the Subdivision Guide Plan endorsed by the Chief Executive Officer.
- The Western Australian Planning Commission may approve minor variations to 1.2the Subdivision Guide Plan, however, further breakdown of lot sizes will be considered to be contrary to the Scheme.

2.0 Zone Objectives

- To provide for rural residential subdivision and development in a manner which—
 - Minimises adverse impacts on and protects the natural resources of the site including native flora and fauna, creeks and wetlands

- Is sympathetic to the picturesque landscape of the Torbay locality
- Ensures adequate protection of life and property from bush fires
- Avoids conflict with existing or future agricultural uses on the Rural zoned land to the north
- Capitalises on the visual and other physical characteristics the site offers for rural residential homesites and associated development
- Incorporates safe and convenient non-vehicular public access linking Hortin Road and Coombes Road
- Achieves improvements to the environmental qualities of the site.
- 3.0 Planning Approval and Permitted Uses
 - 3.1 All development including any clearing of vegetation and construction of any buildings requires the approval of Council. In addition to the necessary site plan and construction details, all applications for Planning Consent for buildings shall include the following—
 - (a) A Fire Protection Plan demonstrating compliance with the requirements outlined under these provisions at Section 8.0 "Water Supply for Domestic Use and Fire Fighting" and Section 9.0 "Bushfire Management and Control"; and
 - (b) Details of the external materials and colours to be used on the walls and roofs of the proposed buildings.
 - 3.2 Dwelling houses are a permitted use (subject to Planning Approval).
 - 3.3 The following uses may be permitted at Council's discretion—
 - (a) Livestock grazing and dams on Lots A-F and H-O inclusive as shown on the Subdivision Guide Plan subject to the provisions under "4.0" below and provided they are located outside of "Conservation of Flora and Fauna Protection Areas" shown on the Subdivision Guide Plan. Dams are to be located in accordance with the setbacks detailed in Clause 5.1 and will not be permitted in visually sensitive areas. These uses are prohibited on all other lots.
 - (b) Bed and Breakfast Establishment forming part of the dwelling and limited to 3 guest rooms.
 - (c) Home Occupation.
 - 3.4 In order to protect native fauna the keeping of cats is prohibited.
 - 3.5 Development approval for all dwellings shall be subject to installation of an onsite effluent disposal system located and designed to the satisfaction of Council.
- 4.0 Intensive Agriculture and the Keeping Of Stock
 - 4.1 Intensive agricultural pursuits such as piggeries, and commercial scale horticulture and viticulture are not permitted.
 - 4.2 Where Council approves the keeping of stock it shall be subject to—
 - (a) the protection of remnant vegetation by stock proof fencing; and
 - (b) animal numbers not exceeding stocking rates recommended by Agriculture WA.
 - 4.3 Where in the opinion of Council the continued presence of animals on any portion of the land is contributing to land/soil degradation or dust pollution, notice may be served on the owner of the land, requiring immediate removal of those animals specified in the notice, and rehabilitation of the land affected within 3 months. In the event such action is not taken, Council may carry out such works as a deemed necessary, with all costs being borne by the landowner.
- 5.0 Boundary Setbacks and Location of Buildings and Fences
 - 5.1 The minimum boundary setbacks for all buildings including dwellings, outbuildings and tanks shall be as follows—
 - (a) "Rural" zoned land to the north 100 metres
 - (b) Coombes and Cosy Corner Roads 50 metres
 - (c) Motel Boundary 30 metres
 - (d) All other boundaries 20 metres
 - 5.2 All buildings shall be located such that—
 - (a) They meet the setback requirements under Clause 5.1;
 - (b) Where a "Building Envelope" is shown on the Subdivision Guide Plan, they are located within that envelope;
 - (c) They are located outside of the "Conservation of Flora and Fauna", "Landscape Protection" and "Creek Protection" areas shown on the Subdivision Guide Plan; and
 - (d) Any outbuilding is to be located within 40 metres of a dwelling, or visa versa.
 - 5.3 Boundary fences and dams shall not be permitted within the "Conservation of Flora and Fauna" areas shown on the Subdivision Guide Plan.

- 5.4 Buildings shall be sited to allow a surrounding building protection zone not less than 20 metres wide to be established in a manner which preferably avoids, or otherwise minimises, encroachment into the "Conservation of Flora and Fauna Areas" shown on the Subdivision Guide Plan.
- 6.0 Building Design, Materials and Colours
 - 6.1 Houses shall not exceed 7.5 metres in height, which is measured vertically from the natural ground level. Dwellings and outbuildings shall be designed to and be constructed of materials that blend with the landscape. Zincalume and pale or "off-white" colours shall not be permitted.
 - 6.2 Cut and fill of the site shall be kept to a minimum with preference given to split level development and the breaking up of the building mass.
 - 6.3 Driveways shall be designed to minimise visual impact and erosion by as far as possible being aligned with the contours of the site and planted with native trees and shrubs. Storm water shall be attenuated to ensure erosion does not occur.
 - 6.4 Dams shall not be permitted unless they are contoured into the site to the satisfaction of Council.
- 7.0 Protection of Flora and Fauna and Revegetation/Landscaping
 - 7.1 All clearing requires the approval of Council.
 - 7.2 No clearing of native vegetation shall occur except for—
 - (a) Clearing to comply with the requirements of the Bush Fires Act 1954;
 - (b) Clearing to provide for construction of an approved building and an associated building protection zone as required under Clause 9.3;
 - (c) Limited clearing for fuel reduction to provide for the establishment of a fire hazard separation zone as required under Clause 9.4;
 - (d) Removal of trees which are dead, diseased or dangerous;
 - (e) Limited thinning of vegetation to provide for views; and
 - (f) Clearing to gain vehicular access to an approved dwelling or any other clearing which may be approved by Council.
 - 7.3 Council will request the Commission to impose a condition at the time of subdivision for revegetation and fencing of the land within the "Wildlife Corridors" shown on the Subdivision Guide Plan to the satisfaction of Council. Such revegetation shall be—
 - (a) Comprised of local native understorey and overstorey species; and
 - (b) Maintained by the subdivider for a period of at least three years.
 - 7.4 Council may request the Commission to impose a condition at the time of subdivision for the erection of stock proof fencing to protect the "Conservation of Flora and Fauna" areas shown on the Subdivision Guide Plan, and other areas of vegetation worthy of protection.
 - 7.5 On cleared lots Council may request landscaping/treeplanting as a condition of development approval for dwelling houses.
- 8.0 Water Supply for Domestic Use and Fire Fighting
 - 8.1 Each dwelling shall be provided with a water supply tank with minimum capacity of 92,000 litres (20,000 gallons) and adequate roof catchment to supply the tank.
 - 8.2 The following requirements shall be applied at the development approval stage for dwelling houses—
 - (a) Each property shall at all times store a minimum of 10,000 litres of water for fire fighting purposes in an area readily accessible to fire fighting appliances, and each owner shall replenish water used by firefighters at the owner's cost;
 - (b) If the fire fighting supply forms part of the domestic supply the water outlet for domestic use shall have a take-off point above the bottom of the tank such that 10,000 litres of water always remains for structural fire fighting purposes;
 - (c) To enable standardisation of access to this supply, each private domestic vessel shall be fitted with a blanking cap and ball valve at the bottom of the tank. This coupling and valve shall be installed and maintained in a correct operating condition at all times at the property owner's expense.
- 9.0 Bushfire Management and Control
 - 9.1 At the time of subdivision Council may request the Commission to impose a condition requiring construction of the strategic firebreaks shown on the Subdivision Guide Plan to a standard suitable for year round emergency access by two wheel drive vehicles and heavy duty fire appliances.
 - 9.2 Where a lot is traversed by a strategic firebreak, the lot owner shall maintain, and ensure access is always available along, the break, to the satisfaction of Council. Fencing or gates shall only be permitted across a strategic firebreak at the discretion of and to the satisfaction of Council.

9.3 Building protection zones in accordance with the following table shall be established and maintained around all buildings to the satisfaction of Council.

- 9.4 Where possible within the confines of the lot, a hazard separation zone at least 100 metres in radius shall be established around each habitable building.
- 9.5 Fire fuel levels in the common hazard separation zone shown on Lots P, Q and R on the Subdivision Guide Plan shall be reduced by properly supervised cool burns and/or slashing to the satisfaction of Council at the subdivision stage. Once established, fuel levels in all hazard separation zones shall maintained at satisfactory levels by individual landowners to the satisfaction of Council.
- 9.6 Turn around areas shall be provided for fire appliances at house sites and along driveways to the satisfaction of Council.
- 9.7 Dwellings in areas which are classified as being extreme, high or medium fire hazards shall be designed and constructed in accordance with Australian Standard 3959.
- $9.8\,$ At the time of subdivision Council will request the Commission to impose conditions requiring—
 - (a) upgrading of the existing water supply for fire fighting purposes near the corner of Coombes and Hortin Roads or provision of a new supply; and
 - (b) arrangements to ensure prospective purchasers of lots within the Special Rural area are provided with information which specifies the requirements and responsibilities of landowners for protection of life and property from bush fires to the satisfaction of FESA and local government.

10.0 Effluent Disposal

- 10.1 Effluent disposal shall be the responsibility of the individual landowner.
- 10.2 The disposal of liquid and/or solid wastes shall be carried out with an effluent disposal system approved by Council and the Health Department of Western Australia.
- 10.3 Except as provided for under 10.4 below, effluent disposal systems are to be located a minimum 50m from seasonal watercourses (for Alternative Treatment Units) or 100m where a conventional septic system is used.
- 10.4 On Lot A on the Subdivision Guide Plan Council will allow either an alternative amended soil treatment and disposal system within the building envelope, or a system which pumps treated effluent to a disposal area within the lot which satisfies the required setbacks from water courses.
- 10.5 No more than one effluent disposal system is permitted per lot.
- 11.0 Notification of Prospective Purchasers of Scheme Provisions

Council shall ensure prospective purchasers of land within the subdivision are provided with a copy of the following prior to entering into an agreement to purchase any property within the zone—

- (a) These special provisions and the Subdivision Guide Plan applicable to the zone;
- (b) An information sheet which lists the flora and fauna species prevalent in the area, and explains the wildlife corridor across Lots 2 and 5; and
- (c) An information sheet regarding the management and control of invasive weeds.
