2. Commencement

These regulations come into operation on the day on which section 70(1) of the *Business Tax Review (Assessment) Act (No. 2) 2003* comes into operation.

The amendment in these regulations is to the *Stamp Regulations 2003**.

8. Vehicles (s. 76B(1), definition of "market value")

- (a) motor cars;
- (b) motor cycles; and
- (c) motor wagons,

(as defined in the *Road Traffic Act 1974* as in force on the commencement of the *Stamp Amendment Regulations 2004*) other than heavy vehicles (as defined in section 76B(1) of the Act).

ENERGY OPERATORS (POWERS) ACT 1979

WESTERN POWER CORPORATION

Order

- 1. In Western Power's opinion the provision, distribution and supply of electricity is likely to be affected and supply may be interrupted, curtailed or terminated because of unprecedented and unexpected load growth.
- 2. Western Power declares that a System Emergency, as defined in section 57(1) of the *Energy Operators (Powers) Act 1979*, exists and Orders that from 06:00 hours on 18 February 2004 the following restrictions shall apply to the use of electricity supplied to customers via the South West Interconnected System—
 - 2.1 Industrial, Commercial and other Non-Domestic Customers.
 - 2.1.1 Electricity must not be used for—

- (a) Air-conditioning. (Air circulating fans can be used to the extent absolutely necessary for ventilation);
- (b) Industrial purposes unless supply is essential to prevent serious damage to plant and Western Power has given its prior written approval to that use;
- (c) Refrigeration (including deep freezing), except the extent absolutely necessary to prevent loss or deterioration of stock;
- (d) Display, window, sign, decorative, advertising and all external lighting;
- (e) Recreational, sporting and entertainment purposes, except in cinemas and theatres where use is limited to meet the minimum requirements for projection, safety and security;
- (f) Pumping water, except with the prior written approval of Western Power;
- 2.1.2 All automatic time switches controlling lighting, pumping and all other loads must be switched off.
- 2.1.3 Only one lift or escalator or half the lifts or escalators (which ever is the greater) installed in any building, structure or premises may be used.
- 2.1.4 Not more than one third of the electric lighting installed in any building, structure or premises may be used at any one time.

2.2 Domestic Customers

- 2.2.1 The use of electricity shall be restricted to the essential needs and without limiting that general restriction the following specific restrictions apply—
 - (a) Airconditioning and water heaters; must not be used, unless required for the treatment of an illness or the comfort of persons suffering from an illness;
 - (b) Cooking; limited to the use of one:-
 - · hot plate:
 - · oven;
 - grill; or
 - · microwave appliance,

at a time;

- (c) Internal lighting, limited to two (2) rooms at a time;
- (d) External lighting; must not be used;
- (e) Refrigeration (including deep freezing); must not be used except the extent absolutely necessary to prevent loss or deterioration of food;
- (f) Water reticulation and swimming pool; must not be used and automatic time switches must be turned off.
- 3. This Order shall cease to have effect 7 days from the date in clause 2, unless previously renewed, varied or cancelled.
- 4. For the purposes of this Order the South West Interconnected System means the interconnected electricity supply system which extends between Geraldton (including Kalbarri), Kalgoorlie and Albany.

ORDERS

Upon hearing Ms Fiona Vernon, Counsel Assisting the Medical Board, and Ms Gillian Braddock SC and Mr Robert Nash, Counsel for Dr Chai Thiam Tan, on the allegations contained in the Notice of Inquiry issued 25 September 2003, the Board finds Dr Chai Thiam Tan guilty of improper conduct in a professional respect pursuant to section 13(1)(a) of the *Medical Act 1894* and the Board orders that—

- 1. Dr Tan be reprimanded;

- 4. The practitioner is to pay the reasonable costs of the inquiry, which if not agreed between the solicitors for the Practitioner and the solicitors assisting the Board, will then be fixed by the Board after receiving further written submissions in that regard.

1. PART 4—GENERAL DEVELOPMENT REQUIREMENTS

After Clause 4.15—"COMMERCIAL VEHICLE PARKING" inserting the following—

4.16 RECREATIONAL VEHICLE PARKING

- 4.16.1 Parking of one (1) recreational vehicle in the Residential zone shall be permitted as of right and without the need for Council approval provided that the vehicle does not exceed 3 metres in height, 2.5 metres in width and 8 metres in length.
- 4.16.2 The Council may in writing approve a variation to Clause 4.16.1 provided the Council is satisfied in the circumstances that the variation will not adversely affect the amenity of the area surrounding the subject land. Surrounding landowners and occupants may be invited to comment on the proposed variation in accordance with the "D" use provisions contained within Clause 6.6.2.

- 4.16.3 In supporting a variation to Clause 4.16.1, Council shall impose the following in addition to any other requirements—
 - (i) The vehicle(s) shall be parked entirely on the subject lot and shall be located on a hard standing area behind the facade of the dwelling, or alternatively the vehicle being parked within a garage.
 - (ii) The vehicle(s) shall not be started or manoeuvred on site between the hours of 10.00 pm and 6.00 am.
- 4.16.4 Any approval of the Council granted under Clauses 4.16.2 and 4.16.3 is personal to the person to whom it is granted, is not capable of being transferred or assigned to any other person, and does not run with the land in respect of which it is granted.

2. SCHEDULE 1 (CLAUSE 1.9) INTERPRETATIONS

After the definition of the term "recreation centre" insert the following-

recreational vehicle: means a vehicle whether licensed or not which is used, designed or modified for recreational use, mobile accommodation or similar purposes and without limiting the generality of the foregoing; includes any mobile home, caravan, campervan and any wheeled attachment to any of them which is rated by the manufacturer as being suitable to carry loads of not more than 1.5 tonnes. The term shall not include a vehicle designed for use as a passenger car, or a van, 4WD, utility or light truck that is rated by the manufacturer as being suitable to carry loads of not more than 1.5 tonnes. The term shall not include a boat, yacht or any other similar watercraft.


