**HERITAGE OF WESTERN AUSTRALIA ACT 1990****AMENDED ENTRY IN THE REGISTER OF HERITAGE PLACES**

In accordance with the requirements of Section 54(5) of the Heritage of Western Australia Act 1990, the Heritage Council hereby gives notice that it has amended the entry in the Register on a permanent basis in respect of the Place being Victoria Park Rotunda, Kalgoorlie.

The reason for the amendment is to give effect to an agreement transferring ownership of the Rotunda which was previously situated in Victoria Park, Kalgoorlie to the City of Kalgoorlie-Boulder and the consequent relocation in 2001 of the Rotunda from Victoria Park, Kalgoorlie to Hammond Park, Kalgoorlie. A Heritage Agreement has been executed between the Heritage Council and the City of Kalgoorlie-Boulder to ensure further conservation of the Rotunda. The Heritage Council has also amended the name of the Place to Hammond Park Rotunda reflecting the new location. The amended description of the Place in the Register is—

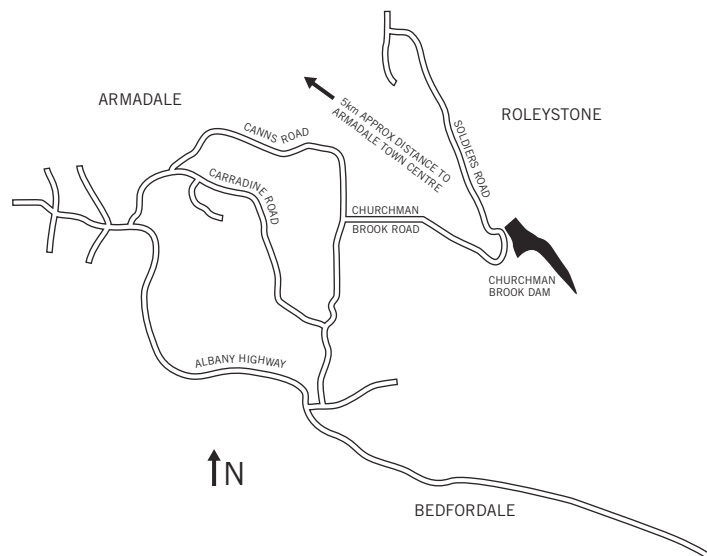
