7. Application fees

- (1) For the purposes of sections 25 and 29 of the Act
 - (a) the fee for an application under section 22(1) of the Act by a person whose education qualifications were obtained in Western Australia is the fee set out in item 1 of Schedule 2:
 - (b) the fee for an application under section 22(1) of the Act by a person whose education qualifications were obtained outside Western Australia, but who is not eligible to apply for registration under section 22(3), is the fee set out in item 1A of Schedule 2;
 - (c) the fee for an application under section 22(3) of the Act is the fee set out in item 1B of Schedule 2; and
 - (d) the fee for an application under section 22A, 24 or 25 of the Act is the fee set out in relation to the respective section in item 1C of Schedule 2.

(2) In subrule (1), "education qualifications" means the education qualifications referred to in rule 4(1)(e).

Special Control Area Provisions

APPLICATION—

The provisions of the Flinders Residential Development Special Control Area are applicable to all lots identified on an approved Outline Development Plan or Subdivision Plan, for residential R12.5 and R20 ('Dx') development.

PURPOSE—

To provide development control and guidance for single residential R12.5 and R20 ('duplex'—two group dwellings) development within the Flinders subdivision.

OBJECTIVES—

The objectives of these provisions are to achieve the following—

- Provide a high level of amenity.
- Create an attractive, desirable and responsive environment.
- To create a safe and interesting streetscape and ensure that development enhances rather than detracts from it.
- Provide for and protect a unique suburban residential character for the area.
- Promote and encourage climate sensitive and passive energy efficient design.
- Promote retention of stormwater on site.
- Promote waterwise gardening.

DEVELOPMENT REQUIREMENTS—

All development shall comply with the following development standards, unless otherwise approved by Council—

- 1.0 Development and Subdivision of Lots
- 1.1 All lot sizes are to be defined by an approved Outline Development Plan, Subdivision Plan or Structure Plan, and are deemed to be single residential R12.5 or R20 ('Duplex'—two group dwellings) unless otherwise designated on an approved Outline Development Plan or on an approved Plan of Subdivision.
- 1.2 Council shall not support further subdivision or amalgamation of single residential lots that would have the effect of increasing residential density.
- 2.0 Setbacks
- 2.1 All buildings shall be set back a minimum of five metres from any street boundary.
- 2.2 No garages, carports, sheds, balconies, verandahs or the like shall extend into the street setback area.
- 3.0 Building Form
- 3.1 All dwellings shall have eaves.
- 3.2 The street frontage entrance to dwellings shall be clearly defined.
- 3.3 Balconies shall be constructed on street and rear facades only and should be designed to protect the privacy of adjacent properties.
- 4.0 Building Height
- 4.1 The vertical distance at any point from natural ground level to the uppermost part of the building above that point (roof ridge, parapet, or wall) shall be no higher than 8 metres.
- 4.2 Natural ground level shall be deemed to be the finished ground level established as part of the subdivision of the land preceding development.

Description of Land

Special Control Area Provisions

- 5.0 Fencing
- 5.1 Front fencing is not required. Where a front fence is to be constructed forward of the building or the street setback, the following provisions shall apply
 - a. Solid fencing shall be no higher than 750 millimetres; or
 - b. Fences may be up to 1.8 metres, where the section of the fence higher than 750 millimetres has a minimum of 60% visual permeability with the exception of piers and posts that may be constructed up to 200 millimetres higher than the infill panels.
- 5.2 All front and side fences forward of the building or street setback, whichever is the greater, or adjacent to public open space, should be constructed in the same materials as, or be aesthetically compatible with the residence on that lot.
- 5.3 All fencing for rear and side boundaries with the exception of fencing forward of the building or street setback area, whichever is the greater, shall be 1.8 metres in height from ground level as set down in 4.2.
- 5.4 No fibre cement fencing shall be permitted.

- 5.6 No fences shall be constructed of second hand materials, except where the use of such materials has been specifically proposed because of its aesthetic qualities and where the use of such materials integrates with the character or architecture of the building, and the Council approves such use.
- 6.0 Retaining Walls, Excavation and Fill
- 6.1 No retaining walls shall be permitted forward of the building or front setback, whichever is the greater, unless required as part of an architectural theme or garden feature unless it has been designed and constructed of the same materials or approved similar materials as those provided by the developer and approved by the Council.
- 6.2 Unless required for a garden feature, under croft parking or approved swimming pool, no lot shall be excavated or filled forward of the building or front setback, whichever is the greater, from finished ground level as set down in Clause 4.2.
- 7.0 Standard of Construction
- 7.1 No new, relocated or jinkered transportable dwellings are permitted.
- 7.2 No second hand materials shall be permitted in the construction of any external walls or roofing of any residence or outbuilding constructed on any lot, except where the use of such materials has been specifically proposed because of its aesthetic qualities and where the use of such materials integrates with the character or architecture of the building, and such use is approved by the Council.
- 7.3 No reflective materials shall be permitted in the construction of any external walls or roofing of any residence or outbuilding constructed on any lot without due regard to Council Policy, except where the use of such materials has been specifically proposed because of its aesthetic qualities and where the use of such materials integrates with the character or architecture of the building and is approved by the Council
- 7.4 All dwellings are to be predominantly masonry construction or an acceptable exterior combination of masonry and/or composite materials approved by the Council. Predominantly shall be defined as 50% or greater of the wall area, and does not include roofing materials or windows.

- 3. Deleting and replacing Clause 5.2.4 to read as follows—
 - 5.2.4 Residential Design Codes—Variations and Exclusions
 - (a) In order to maintain the standard of setback that has been established within the Scheme Area, the Residential Design Codes shall be varied by—
 - (i) in Code R17.5, the minimum front setback shall be 7.5 metres.
 - (ii) in the R12.5 and R17.5 Codes, the minimum rear setback shall be 7.5 metres
 - (b) In the Townsite of Gibson, on the west side of the Esperance-Coolgardie Highway, (which is named Reynolds Street within this Townsite) between Gibson and Jenkins Streets, a minimum setback of 12.5 metres shall apply, to provide for the future extension of the service road.
 - (c) Development in Flinders shall be in accordance with the provisions of Special Control Area 2—Flinders Residential Development Special Control Area in Appendix 13.
- 4. Amending the Scheme Maps accordingly.


