# **Public Trustee Amendment Regulations 2004**

Made by the Governor in Executive Council.

## 1. Citation

These regulations may be cited as the *Public Trustee Amendment Regulations 2004*.

## 2. The regulations amended

The amendments in these regulations are to the *Public Trustee Regulations 1942*\*.

#### **3.** Second Schedule amended

The Second Schedule item 9A is repealed and the following item is inserted instead —

#### 9A. Fees payable in respect of frozen or confiscated property under the *Criminal Property Confiscation Act 2000*

The fees payable to the Public Trustee for performing functions under the *Criminal Property Confiscation Act 2000* in relation to frozen or confiscated property where the gross capital value of the property exceeds \$2 000 are as follows —

(a) an amount calculated at the rate of \$113 for each hour (or part of an hour) of work performed in relation to the property, other than work connected with the disposal of the property; and

(b) where the Public Trustee disposes of the property, an amount equal to 2.75% of the gross amount realised on the disposal of the property.

#### FISH RESOURCES MANAGEMENT ACT 1994

PROHIBITION ON RECREATIONAL FISHING FOR MOLLUSCS AND SEA URCHINS ORDER 2004 Order No. 3 of 2004

FD 1620/98 [586]

Made by the Minister under section 43.

#### Citation

1. This order may be cited as the Prohibition on Recreational Fishing for Molluscs and Sea Urchins Order 2004.

#### Interpretation

2. In this order unless the contrary intention appears—

- "abalone, squid, octopus, cuttlefish and mussels" means fish of those common names described by the scientific classifications opposite those names in column 2 of Schedule 7 of the *Fish Resources Management Regulations 1995*;
- "Gastropoda" includes any whelks, turban shells, top shells, periwinkles, baler shells and giant conch shells but excludes any abalone;
- "Marmion Marine Park" means all WA waters reserved as Marine Park Reserve No. 1 under section 13 of the *Conservation and Land Management Act 1984* by an order in Council published in the *Gazette* on 13 March 1987 at p. 628;
- "mollusc" means fish of the Phylum Mollusca except abalone, squid, octopus and cuttlefish;
- "Shoalwater Islands Marine Park" means all WA waters reserved as Marine Park Reserve No. 5 under section 13 of the *Conservation and Land Management Act 1984* by an order in Council published in the *Gazette* on 25 May 1990 at p. 2393.

#### Prohibition on recreational fishing for molluscs

3. (1) A person must not engage in recreational fishing for any molluscs of the Class Gastropoda or echinoderms of the Class Echinoida by any means in any of the waters described in Schedule 1 other than at a time and in an area provided for in Schedule 2.

(2) Notwithstanding subclause (1), recreational fishing for any-

- (a) molluscs or echinoderms of the Class Echinoida is prohibited at all times in the Marmion Marine Park; and
- (b) molluscs except mussels or echinoderms of the Class Echinoida is prohibited at all times in the Shoalwater Islands Marine Park.

#### Schedule 1

#### Waters to which this order applies

(1) All that portion of the Indian Ocean within 800 metres of the highwater mark on the West Australian mainland between the mouth of the Greenough River and the northern boundary of Lot 1 Victoria Location 3501 commonly known as Flat Rocks Car Park.

(2) All waters of the Indian Ocean between a line drawn due west from Cape Bouvard and a line drawn due west from the mainland through the northern most point of Wedge Island.

#### Schedule 2

#### Non-prohibited fishing times and areas

Molluscs of the Class Gastropoda or echinoderms of the Class Echinoida may be taken—

- (a) during the period commencing 7 a.m. and ending 8.30 a.m. on any of the 6 consecutive Sundays in any year commencing with the first Sunday in November in that year in—
  - (i) all that portion of the Indian Ocean within 800 metres of the highwater mark on the West Australian mainland between the mouth of the Greenough River and the northern boundary of Lot 1 Victoria Location 3501 commonly known as Flat Rocks Car Park;

- (ii) all that portion of the Indian Ocean within 800 metres of the high water mark on the West Australian mainland between a line drawn due west from Cape Bouvard and a line drawn due west from the mainland through the northern most point of Wedge Island excluding—
  - (A) the boundaries of the Marmion Marine Park;
  - (B) all waters contained within the boundary of the Shoalwater Islands Marine Park;
- (b) at any time on any of the 6 consecutive Sundays in any year commencing with the first Sunday in November in that year in all waters of the Indian Ocean westward of the waters described in paragraph (a)(ii) of Schedule 2 excluding—
  - (i) the boundaries of the Marmion Marine Park;
  - (ii) all waters contained within the boundary of the Shoalwater Islands Marine Park; and
  - (iii) all that portion of the Indian Ocean within 800 metres of the high water mark of Rottnest Island.
