#### LOCAL GOVERNMENT ACT 1995

City of Perth

ACTIVITIES ON THOROUGHFARES AND TRADING IN THOROUGHFARES AND PUBLIC PLACES AMENDMENT LOCAL LAW 2004

Under the powers conferred by the Local Government Act 1995 and under all other powers enabling it, the Council of the City of Perth resolved on 22 June 2004 to make the Activities on Thoroughfares and Trading in Thoroughfares and Public Places Amendment Local Law 2004.

#### ARRANGEMENT

PART 1—PRELIMINARY—Clauses 1-3 PART 2—ACTIVITIES ON THOROUGHFARES AND TRADING IN THOROUGHFARES AND PUBLIC PLACES—Clause 4

#### PART 1-PRELIMINARY

#### Title

1 This local law may be cited as the Activities on Thoroughfares and Trading in Thoroughfares and Public Places Amendment Local Law 2004.

#### Commencement

2 This local law comes into operation 14 days after the date of its publication in the *Government Gazette*.

#### **Purpose and Intent**

3 The purpose of Activities on Thoroughfares and Trading in Thoroughfares and Public Places Amendment Local Law 2004 is to permit portable directional real estate signs to be placed or erected on a thoroughfare on an infrequent or occasional basis only to direct attention to a residence during the hours of a home open.

The effect of the Activities on Thoroughfares and Trading in Thoroughfares and Public Places Amendment Local Law 2004 is to provide clarity within the Activities on Thoroughfares and Trading in Thoroughfares and Public Places Local Law 1999 on dealing with real estate signs.

#### PART 2—ACTIVITIES ON THOROUGHFARES AND TRADING IN THOROUGHFARES AND PUBLIC PLACES

#### Amendment

4 The Activities on Thoroughfares and Trading in Thoroughfares and Public Places Local Law 1999 published in the *Government Gazette* on 1 November 2000 including amendments, is hereby amended in the following manner—

4.1 Insert the following new definition in clause 3.1-

"real estate sign" means a portable direction sign which is used for the purpose of advertising a residential home open.

4.2 Delete the existing definition of "advertising sign" in clause 3.1 and insert the following—

"advertising sign" means a sign used for the purpose of advertisement and includes an "election sign" and "real estate sign".

4.3 Delete the existing title in clause 3.2 and insert the following new title—

"Advertising signs, election signs and real estate signs".

4.4 Renumber clause 3.2(3) to new clause number 3.2(4) throughout the local law including schedules.

4.5 Insert the following new sub clause 3.2(3)—

"(3) Notwithstanding subclause (1), a real estate sign may be placed or erected on a thoroughfare on an infrequent or occasional basis only to direct attention to a residence during the hours of a home open. A licensed Real Estate Agent must be in attendance at the home open for the duration whilst the signs are placed or erected on a thoroughfare.".

I, Patrick Walker, Commissioner for Fair Trading in and for the State of Western Australia being satisfied that a Consumer Affairs Authority, namely Reba Meagher, Minister for Fair Trading in and for the State of New South Wales, has by notice dated 8 March 2004 published in the New South Wales *Government Gazette* on 12 March 2004 prohibited the supply of goods described in the Schedule hereto.

Now I, pursuant to section 23R(4) and (5) of the Consumer Affairs Act-

- 1. revoke the Order published in the WA *Government Gazette* No. 114 of 4 December 1987 at page 4350, conditionally prohibiting the supply of goods being frames intended to support infants in baths;
- 2. prohibit the supply of goods specified in Schedule 1 except where such goods are supplied in accordance with the conditions specified in Schedule 2; and
- 3. declare this Order commences on 1 August 2004.

SCHEDULE 1

Goods designed to support babies while they are being bathed.

SCHEDULE 2

In this Schedule, "Warning" means a warning containing-

- (a) a notice stating "WARNING—Children have DROWNED while using bath aids. This is NOT a safety device. ALWAYS keep baby within arm's reach. NEVER leave baby in care of children."; and
- (b) two safety alert symbols, with the symbols placed immediately to the left and right of the notice.

For the purposes of paragraph (b) of the definition of "Warning", the safety alert symbol comprises an exclamation point inside an equilateral triangle with a base of at least 30 millimetres, as follows—



#### Conditions

1. The goods and any packaging in which the goods are supplied must bear the Warning.

- 2. On both the goods and any packaging in which the goods are supplied-
  - (a) that part of the Warning consisting of the notice must bear—
    - (i) the word "WARNING" in capital letters of at least 10 millimetres in height;
    - (ii) the words "DROWNED", "NOT", "ALWAYS" AND "NEVER" in capital letters of at least 5 millimetres in height;
    - (iii) the remaining words in lower case of at least 2.5 millimetres in height;
  - (b) the Warning must be—
    - (i) permanently affixed to the goods and any packaging;
    - (ii) prominently and conspicuously displayed; and
    - (iii) in a contrasting colour to the colour of the goods and of any packaging.

3. The Warning on the goods must-

- (a) be on the upper surface of the goods;
- (b) be visible to a person when a baby is in the goods; and
- (c) not contain any ink, colouring or other material that may run or fade when the goods are subjected to bathing conditions.

4. Any packaging in which the goods are supplied or any sign, advertisement or statement relating to or attached to the goods must not contain any indication by words, pictures or otherwise that is inconsistent with the Warning.

5. If the packaging in which the goods are supplied is colourless and transparent and the Warning on the goods is clearly legible to a person through the packaging, the Warning is not required on that packaging.


