## NOTICE OF ENTRY OF PLACES IN THE REGISTER OF HERITAGE PLACES

Notice is hereby given in accordance with Section 51(2) of the Heritage of Western Australia Act 1990 that, pursuant to directions from the Minister for Heritage, the places described in Schedule 1 have been entered in the Register of Heritage Places on a permanent basis with effect from today.

## Schedule 1

**Description of Place**

**Black Range Church** at Cnr Oroya and Thaduna Sts, Sandstone; Lt 244 on DP 223094 being the whole of the land contained in C/T V 2176 F 505.

**Coffee Pot and Waggrakine Well** at Chapman Valley Road Nr Coffee Pot Drive, Waggrakine; That pt of Lt 1455 on DP 246636, and being pt of the land comprised in C/T V 1463 F 904 as is defined on HCWA Survey Drawing No. 0475 as prepared by Steffanoni Ewing & Cruickshank Pty Ltd.

**Elders Wool Stores** at 38 Cantonment Street, Fremantle; Lt 201 on P 24212 being the whole of the land contained in C/T V 2208 F 338.

**Levi Wallis Cottage** at 251 Stanhope Road, Walliston; Lt 22 on D 55820, being the whole of the land comprised in C/T V 1535 F 880.

Pursuant to directions from the Minister for Heritage, notice is hereby given in accordance with Section 49(1) of the Heritage of Western Australia Act 1990 that it is proposed that the places described in Schedule 2 be entered in the Register of Heritage Places. The Heritage Council invites submissions on the proposal which must be in writing and should be forwarded to the address below not later than 31 August 2004. The places will be entered in the Register on an interim basis with effect from today.

## Schedule 2

**Description of Place**

**Guildford Town Hall & Library** at Cnr Meadow Street and James Street, Guildford; Lt 188 on DP 222550 being the whole of the land contained in C/T V 74 F 13.

**Pagoda, Como** at 111 Melville Parade, Como; That ptn of Lt 1 on Strata Plan 31338 being part of the land contained in C/T V 2077 F 1 and ptn of common property of Strata Plan 31338 together with ptn of Melville Parade as is defined in HCWA Survey Drawing No. 2403 prepared by Warren King & Company and Midland Survey Services.

**Stirk Cottage** at 18 Kalamunda Road, Kalamunda; Those ptns of Canning Locs 101 and 205 being part of the land contained in C/T V 1034 F 773 as is defined by HCWA Survey Drawing No. 1253 as prepared by Steffanoni Ewing & Cruickshank Pty Ltd.

**The Cliffe** at 25 Bindaring Parade, Peppermint Grove; Ptn of Swan Loc 84 and being (firstly) pt of each of Lts 25, 26 and 27 on P 3783 (Sheet 1) and (secondly) pt of each of Lts 28 and 29 on D 8903 and being the whole of the land in C/T V 1265 F 334.
