Clause 8.2

Change "entry of departure" to "entry or departure"

Clause 10.16

Change "When a member of the Council or committee, no reference is to be made to matters unnecessary for that purpose" to "When a member of the Council or committee makes a personal explanation, no reference is to made to matter unnecessary for that purpose".

Clause 12.4(2)

Change "cause" to "causes".

Clause 12.7(1)

Change "cause" to "causes".

PROPOSED CHANGES TO THE ROYAL KINGS PARK TENNIS CLUB

The Authority gives notice consistent with the Kings Park and Botanic Garden Management Plan 2004-2009 concerning a major project for the 105 year old Royal Kings Park Tennis Club (RKPTC) heritage precinct.
