BUSH FIRES ACT 1954

City of Canning FIREBREAK REQUIREMENTS

Notice to all Owners and/or Occupiers of land within the City of Canning

Pursuant to the powers contained in Section 33 of the *Bush Fires Act 1954*, you are hereby required on or before 31st October 2004 or within 14 days after the date of you becoming an owner or occupier should this be after 31st October 2004 and thereafter up to and including 31st March 2005 to have a firebreak clear of all flammable material at least three (3) metres wide immediately inside all external boundaries of the land and also immediately surrounding all buildings situated in the land. You are additionally required to clear and remove all vegetation overhanging adjacent properties and remove all dense vegetation from vacant properties and install further firebreaks on the land if necessary to achieve this.

If it is considered impracticable for any reason to clear firebreaks or carry out other work as required by this notice, you may apply to the Council or a duly authorised officer not later than 14 October 2004 for permission to install firebreaks in alternative locations on the land. If the Council or a duly authorised officer does not grant permission, you shall comply with the requirements of this notice.

Flammable material is defined for the purpose of this notice to include bush, (as defined in the Bush Fires Act) boxes, cartons, paper and like flammable materials, rubbish and also any other combustible matter, but does not include green standing trees or plants in gardens or lawns.

The penalty for failing to comply with the requirements of this notice is a penalty of not less than \$250 or more than \$5,000 and such person in default is also liable, whether prosecuted or not, to pay the costs of a private contractor being engaged by the City of Canning to carry out the required work.

 - (i) A maximum total floor space of $4,000m^2$ NLA for Shop uses.
 - (ii) Medical Centre not to exceed a maximum floor space of $1,6000m^2$ which may include a pharmacy not greater than $200m^2$ NLA.
 - (iii) Fast food outlets not to exceed 400m² NLA of floor space.
 - (iv) Personal Services not to exceed 180m² NLA of floor space.
 - (v) Other activities not included or detailed above to a maximum of $400m^2$ NLA of floor space.
