#### AMENDMENT TO STANDING ORDERS LOCAL LAW

Under the powers conferred by the abovementioned Act and all other powers enabling it, the Council of the City of Nedlands hereby records having resolved on the 27th day of July 2004 to make the following local law.

The Standing Orders Local Law made by the City of Nedlands and published in the *Government Gazette* on 5 January 2004 is hereby amended in the following manner—

- 1. Amend clause 25(2) by inserting paragraph (h) that states "Clause 25(2) does not apply to a person who is a member of a committee referred to in section 5.9(2)(f) of the *Local Government Act 1995* and clause 77(4)(f) of this local law."
- 2. Delete subclause (i) in clause 25(4)(a).
- 3. Delete the words "either (i) or" in clause 25(4)(b).
- 4. Amend clause 26(6) by deleting the words "under Division IV" and inserting instead the words "under Part 5 Division 4".
- 5. Amend clause 29(2) by deleting the words "by completing the form prescribed" and inserting instead the words "by completing the form adopted by the local government relating to Public Address Sessions."
- 6. Clause 53(1) is amended by deleting the words "the Council Chamber" and inserting after the word "from" the following "participating in debate (but without losing their right to cast votes)."
- 7. Clause 72(4) is amended by deleting the word "Councillor" and inserting instead the words "members of the council or committee".
- 8. Clause 72(4) is further amended by inserting after the words 'Other wise the motion shall not be entertained' a new subclause (4)(c) that states "Clause 72(4) does not apply to the change of a decision unless the effect of the change would be that the decision would be revoked or would become substantially different.
- 9. Amend clause 72(6) by deleting the words "as per paragraph (4) of this clause" and inserting instead the words "as per paragraphs (4) and (5) of this clause"
- 10. Amend clause 72(7)(c) by deleting the words "as are required by paragraph (4)" and inserting instead the words "as are required by paragraphs (4) and (5)."
- 11. Amend clause 72(7)(c) by deleting the words "the requirements for a notice motion" and inserting instead the words "the requirements for a notice of motion."
- 12. Clause 72(5)(a) is amended by inserting the words "by that kind of majority" after the words special majority.
- 13. Clause 77(2) is amended by inserting the following at the end of the subclause "This subclause does not apply to persons who are appointed to be members of the committee under subsection (4) or (5) under the Local Government Act 1995 and clauses 77(6) or (7) under this local law."
- 14. Amend clause 77(5) by inserting the words 'or (b)' immediately after the words "...referred to in item (a)...", and deleting the words "...paragraph (4)(a)..." and replacing them with the words 'clause 77(2)'.
- 15. Amend clause 77(5) by deleting the words "appointed under paragraph (4)(a)" and inserting instead the words "appointed under subclause (2)."
- 16. Amend clause 78 by deleting the words "pursuant to clause 25(7)" and inserting instead the words "pursuant to clause 25(6)."
- 17. Amend clause 83(3)(b) by deleting the words "under Division 4" and inserting instead the words "under Part 5 Division 4."
- 18. Amend clause 90(1) by deleting the words "provisions of subdivision 4 of Part 5" and inserting instead the words "provisions of Subdivision 4, Division 2 of Part 5."
- 19. Delete clause 92.
- 20. Amend clause 12 Order of Business Ordinary Meeting by bringing the existing paragraphs (f) Public Question Time and (g) Public Address forward such that they immediately follow paragraph (b) Present/Apologies/Leave of Absence Previously Approved and accordingly renumber all paragraphs from (c) to (g).

- Easter Group-All Western Australian waters bounded by a line commencing at the intersection of 28° 38.400' south latitude and 113° 52.400' east longitude; thence extending east along the parallel to the intersection of 28° 38.400' south latitude and 113° 53.000' east longitude; thence south along the meridian to the intersection of 28° 42.000' south latitude and 113° 53.000' east longitude; thence west along the parallel to the intersection of 28° 42.000' south latitude and 113° 51.200' east longitude; thence north north westerly along the geodesic to the intersection of 28° 40.217' south latitude and 113° 50.183' east longitude; thence north east along the geodesic to the commencement point.
- 4. Southern Group—All Western Australian waters bounded by a line commencing at the intersection of 28° 50.750' south latitude and 113° 59.350' east longitude; thence extending east along the parallel to the intersection of 28° 50.750' south latitude and 114° 02.000' east longitude; thence south along the meridian to the intersection of 28° 53.500' south latitude and 114° 02.000' east longitude; thence west along the parallel to the intersection of 28° 53.500' south latitude and 114° 01.500' east longitude; thence north westerly by north along the geodesic to the commencement point.


