Citation

1. This order may be cited as the Water Services Licensing Transfer Order (Ord) 2004.

Definitions

2. In this Transfer Order—

“**Schedule**” means the document identified as the Schedule to this order and signed by the Minister;

“**statutory assets owner**” means the Water Corporation established by section 4 of the Water Corporation Act 1995; and

“**transferee**” means the Ord Irrigation Asset Mutual Co-operative Limited.

Transfer of assets

3. The assets that are the property of the statutory assets owner and are described in the columns headed “Asset #”, “Channel #” and “Description” in the Schedule are to be transferred to the transferee.

Affected land
