Conservation and Land Management Act 1984

**Muiron Islands Marine Management Area
(Classified Waters) Notice 2005**

Made by the Minister for the Environment under section 62(1b) of the Act.

1. Citation

This notice is the *Muiron Islands Marine Management Area (Classified Waters) Notice 2005*.

2. Interpretation

(1) In this notice —

“approved management plan” means the management plan for the Muiron Islands Marine Management Area approved by the Minister under sections 14 and 60 of the Act, as notified in the *Gazette* of 14 January 2005;

“high water mark” means the ordinary high water mark at spring tides;

“low water mark” means the ordinary low water mark at spring tides;

“Muiron Islands Marine Management Area” means all waters reserved as a marine management area with the name “Muiron Islands Marine Management Area” and classified as of Class “A” by the *Muiron Islands Marine Management Area Order 2004*, published in the *Gazette* of 30 November 2004.

(2) A reference in this notice to a geographic coordinate is a reference to the coordinate in accordance with the Geocentric Datum of Australia 1994 (GDA 94).

3. Classification of conservation areas

All waters of the Muiron Islands Marine Management Area referred to in Schedule 1 are classified under section 62(1b) of the Act as conservation areas, and the permitted uses and activities described in the approved management plan in relation to conservation areas may be carried out within those areas.

Schedule 1 — Conservation areas

[cl. 3]

1. Sunday Island Conservation Area

All that portion of the Muiron Islands Marine Management Area, contained within and bounded by a line —

- (a) commencing at a point north-east of Sunday Island at the intersection of latitude 21°41.75'S and longitude 114°25.65'E;
- (b) from there extending west along latitude 21°41.75'S to longitude 114°24.85'E;
- (c) from there extending generally south along longitude 114°24.85'E to latitude 21°43.05'S;
- (d) from there extending east along latitude 21°43.05'S to longitude 114°25.65'E; and
- (e) from there extending north along longitude 114°25.65'E to the point described in paragraph (a).

2. North Muiron Conservation Area

All that portion of the Muiron Islands Marine Management Area, contained within and bounded by a line —

- (a) commencing on the high water mark of south-west North Muiron Island at longitude 114°21.55'E;
- (b) from there extending south along longitude 114°21.55'E to latitude 21°40.3'S;
- (c) from there extending east along latitude 21°40.3'S to longitude 114°23.45'E;
- (d) from there extending north along longitude 114°23.45'E to latitude 21°38.85'S;
- (e) from there extending west along latitude 21°38.85'S to the high water mark on the south-west side of North Muiron Island; and
- (f) from there extending generally south-westerly and westerly along the high water mark to the point described in paragraph (a).

3. South Muiron Conservation Area

All that portion of the Muiron Islands Marine Management Area, contained within and bounded by a line —

- (a) commencing on the high water mark of north-west South Muiron Island at latitude 21°39.55'S;
- (b) from there extending west along latitude 21°39.55'S to longitude 114°18.35'E;
- (c) from there extending south along longitude 114°18.35'E to latitude 21°41.00'S;
- (d) from there extending east along latitude 21°41.00'S to the high water mark on the western side of South Muiron Island; and
- (e) from there extending generally north-easterly along the high water mark to the point described in paragraph (a).

Conservation and Land Management Act 1984

Ningaloo Marine Park (Classified Waters) Notice 2005

Made by the Minister for the Environment under section 62(1a) of the Act.

1. Citation

This notice is the *Ningaloo Marine Park (Classified Waters) Notice 2005*.

2. Interpretation

(1) In this notice —

“approved management plan” means the management plan (including the indicative management plan) for the Ningaloo Marine Park approved by the Minister under sections 14 and 60 of the Act, as notified in the *Gazette* of 14 January 2005;

“high water mark” means the ordinary high water mark at spring tides;

“low water mark” means the ordinary low water mark at spring tides;

“Ningaloo Marine Park” means all waters reserved as Class “A” Marine Reserve No. 2 under section 13 of the Act, by the *Ningaloo Marine Park (Alteration of Boundaries) Order 2004*, published in the *Gazette* of 30 November 2004 and named in that order as the Ningaloo Marine Park.

(2) A reference in this notice to a geographic coordinate is a reference to the coordinate in accordance with the Geocentric Datum of Australia 1994 (GDA 94).

3. Classification of sanctuary areas

All waters of the Ningaloo Marine Park referred to in Schedule 1 are classified under section 62(1a) of the Act as sanctuary areas, and the permitted uses and activities described in the approved management plan in relation to sanctuary zones may be carried out in the zones described within those areas.

4. Classification of special purpose areas

All waters of the Ningaloo Marine Park referred to in Schedule 2 are classified under section 62(1a) of the Act as

special purpose areas, and the permitted uses and activities described in the approved management plan in relation to sanctuary zones may be carried out in the zones described within those areas.

5. Classification of recreational areas

All waters of the Ningaloo Marine Park referred to in Schedule 3 are classified under section 62(1a) of the Act as recreational areas, and the permitted uses and activities described in the approved management plan in relation to sanctuary areas may be carried out in the waters described in that Schedule.

6. Classification of general use area

All waters of the Ningaloo Marine Park referred to in Schedule 4 are classified under section 62(1a) of the Act as a general use area, and the permitted uses and activities described in the approved management plan in relation to general use areas may be carried out in the waters described within that Schedule.

7. *Ningaloo Marine Park (Classified Waters) Notice 1991* cancelled

The *Ningaloo Marine Park (Classified Waters) Notice 1991* is cancelled.

Schedule 1 — Sanctuary areas

[cl. 3]

1. Bundege Sanctuary Zone

All that portion of the Ningaloo Marine Park, contained within and bounded by a line —

- (a) commencing on the high water mark at latitude 21°52.4833'S;
- (b) from there extending east along latitude 21°52.4833'S to longitude 114°10.95'E;
- (c) from there extending north along longitude 114°10.95'E to latitude 21°51.3167'S;
- (d) from there extending west along latitude 21°51.3167'S to the high water mark; and
- (e) from there extending south along the high water mark to the point described in paragraph (a).

2. Murat Sanctuary Zone

All that portion of the Ningaloo Marine Park, contained within and bounded by a line —

- (a) commencing at a point east of Point Murat at the intersection of latitude 21°49.55'S and longitude 114°13.00'E;
- (b) from there extending north along longitude 114°13.00'E to latitude 21°48.55'S;
- (c) from there extending west along latitude 21°48.55'S to a point 100 metres seaward of and normal to the high water mark;

- (d) from there extending generally south easterly along a line constantly 100 metres seaward of and normal to the high water mark to a point on the northern boundary of the Commonwealth Communication Pier Excision;
- (e) from there extending south-easterly, south-westerly and north-westerly along the boundary of that Excision to a point 100 metres seaward of and normal to the high water mark;
- (f) from there extending south-westerly along a line constantly 100 metres seaward of and normal to the high water mark to latitude 21°49.55'S; and
- (g) from there extending east along latitude 21°49.55'S to the point described in paragraph (a).

3. Lighthouse Bay Sanctuary Zone

All that portion of the Ningaloo Marine Park, contained within and bounded by a line —

- (a) commencing at a point north of North West Cape at the intersection of latitude 21°46.55'S and longitude 114°10.35'E;
- (b) from there extending west along latitude 21°46.55'S to longitude 114°07.9667'E;
- (c) from there extending south to a point on longitude 114°07.9667'E, 100 metres seaward of and normal to the high water mark;
- (d) from there extending generally north-easterly and south-easterly along a line constantly 100 metres seaward of and normal to the high water mark to longitude 114°10.35'E; and
- (e) from there extending north along longitude 114°10.35'E to the point described in paragraph (a).

4. Jurabi Sanctuary Zone

All that portion of the Ningaloo Marine Park, contained within and bounded by a line —

- (a) commencing at a point north of Jurabi Point at the intersection of latitude 21°50.8760'S and longitude 113°59.8'E;
- (b) from there extending south to a point on longitude 113°59.8'E, 100 metres seaward of and normal to the high water mark;
- (c) from there extending generally north-easterly along a line constantly 100 metres seaward of and normal to the high water mark to longitude 114°01.8'E;
- (d) from there extending north along longitude 114°01.8'E to latitude 21°50.35'S;
- (e) from there extending west along latitude 21°50.35'S to longitude 114°00.7746'E; and
- (f) from there extending generally south-west along the geodesic to the point described in paragraph (a).

5. Tantabiddi Sanctuary Zone

All that portion of the Ningaloo Marine Park, contained within and bounded by a line —

- (a) commencing at a point west of Tantabiddi Creek at the intersection of latitude 21°54.5667'S and longitude 113°58.1333'E;
- (b) from there extending generally north-west along the geodesic to a point at the intersection of latitude 21°54.3667'S and longitude 113°57.9'E;
- (c) from there extending generally south-westerly along the geodesic to a point at the intersection of latitude 21°54.6667'S and longitude 113°57.5'E;
- (d) from there extending generally south-easterly along the geodesic to a point at the intersection of latitude 21°54.9'S and longitude 113°57.6667'E; and
- (e) from there extending generally north-easterly to the point described in paragraph (a).

6. Mangrove Sanctuary Zone

All that portion of the Ningaloo Marine Park, contained within and bounded by a line —

- (a) commencing on the high water mark at latitude 21°56.7'S;
- (b) from there extending west along latitude 21°56.7'S to longitude 113°55.05'E;
- (c) from there extending generally southerly along the geodesic to a point at the intersection of latitude 21°57.55'S and longitude 113°54.85'E;
- (d) from there extending south along longitude 113°54.85'E to latitude 21°58.4'S; and
- (e) from there extending north along the high water mark to the point described in paragraph (a).

7. Lakeside Sanctuary Zone

All that portion of the Ningaloo Marine Park, contained within and bounded by a line —

- (a) commencing on the high water mark at latitude 22°02.1667'S;
- (b) from there extending west along latitude 22°02.1667'S to longitude 113°54.5333'E;
- (c) from there extending south along longitude 113°54.5333'E to latitude 22°02.3333'S; and
- (d) from there extending generally northerly along the high water mark to the point described in paragraph (a).

8. Mandu Sanctuary Zone

All that portion of the Ningaloo Marine Park, contained within and bounded by a line —

- (a) commencing on the high water mark at latitude 22°04.35'S;
- (b) from there extending west along latitude 22°04.35'S to longitude 113°52.959'E;

- (c) from there extending generally southerly along the geodesic to a point at the intersection of latitude 22°09.65'S and longitude 113°51.2856'E;
- (d) from there extending east along latitude 22°09.65'S to the high water mark; and
- (e) from there extending generally northerly along the high water mark to the point described in paragraph (a).

9. Osprey Sanctuary Zone

All that portion of the Ningaloo Marine Park, contained within and bounded by a line —

- (a) commencing on the high water mark at latitude 22°14.9226'S;
- (b) from there extending west to a point on latitude 22°14.9226'S, 100 metres seaward of and normal to the high water mark;
- (c) from there extending generally northerly along a line constantly 100 metres seaward of and normal to the high water mark to latitude 22°13.3'S;
- (d) from there extending west along latitude 22°13.3'S to the limit of Western Australian coastal waters;
- (e) from there extending generally southerly along the limit of Western Australian coastal waters to latitude 21°19.5'S;
- (f) from there extending east to a point on latitude 21°19.5'S, 100 metres seaward of and normal to the high water mark;
- (g) from there extending generally northerly along a line constantly 100 metres seaward of and normal to the high water mark to latitude 22°18.4284'S;
- (h) from there extending east along latitude 22°18.4284'S to the high water mark; and
- (i) from there extending generally northerly along the high water mark to the point described in paragraph (a).

10. Winderabandi Sanctuary Zone

All that portion of the Ningaloo Marine Park, contained within and bounded by a line —

- (a) commencing 100 metres seaward of and normal to the high water mark at latitude 22°22.8'S;
- (b) from there extending west along latitude 22°22.8'S to longitude 113°43.9602'E;
- (c) from there extending generally southerly along the geodesic to a point at the intersection of latitude 22°29.75'S and longitude 113°40.4682'E;
- (d) from there extending east along latitude 22°29.75'S to a point 100 metres seaward of and normal to the high water mark; and
- (e) from there extending northerly, easterly and again northerly along a line constantly 100 metres seaward of and normal to the high water mark to the point described in paragraph (a).

11. Cloates Sanctuary Zone

All that portion of the Ningaloo Marine Park, contained within and bounded by a line —

- (a) commencing on the high water mark at latitude 22°35.0'S;
- (b) from there extending west along latitude 22°35.0'S to the limit of Western Australian coastal waters;
- (c) from there extending generally southerly along the limit of Western Australian coastal waters to latitude 22°54.65'S;
- (d) from there extending east along latitude 22°54.65'S to the high water mark;
- (e) from there extending generally northerly along the high water mark to latitude 22°46.5504'S;
- (f) from there extending west to a point on latitude 22°46.5504'S, 100 metres seaward of and normal to the high water mark;
- (g) from there extending generally north-westerly, westerly and northerly along a line constantly 100 metres seaward of and normal to the high water mark to latitude 22°39.3942'S;
- (h) from there extending east along latitude 22°39.3942'S to the high water mark; and
- (i) from there extending generally northerly along the high water mark to the point described in paragraph (a).

12. Bateman Sanctuary Zone

All that portion of the Ningaloo Marine Park, contained within and bounded by a line —

- (a) commencing on the high water mark at latitude 23°02.7'S;
- (b) from there extending west along latitude 23°02.7'S to longitude 113°47.2'E;
- (c) from there extending south along longitude 113°47.2'E to latitude 23°04.45'S;
- (d) from there extending east along latitude 23°04.45'S to the high water mark; and
- (e) from there extending generally northerly along the high water mark to the point described in paragraph (a).

13. Maud Sanctuary Zone

All that portion of the Ningaloo Marine Park, contained within and bounded by a line —

- (a) commencing on the high water mark at the intersection of latitude 23°07.1568'S and longitude 113°45.7272'E;
- (b) from there extending generally north-westerly along the geodesic to the intersection of latitude 23°05.928'S and longitude 113°44.6118'E;
- (c) from there extending generally northerly along the geodesic to the intersection of latitude 23°04.2084'S and longitude 113°44.5722'E;
- (d) from there extending generally south-westerly along the geodesic to the intersection of latitude 23°05.0328'S and longitude 113°43.68'E;

- (e) from there extending generally southerly along the geodesic to the intersection of latitude 23°08.6964'S and longitude 113°44.742'E;
- (f) from there extending generally south along the geodesic to the intersection of latitude 23°09.4998'S and longitude 113°44.742'E;
- (g) from there extending generally southerly along the geodesic to the intersection of latitude 23°10.3968'S and longitude 113°44.8794'E;
- (h) from there extending east to a point on latitude 23°10.3968'S 100 metres seaward of and normal to the high water mark;
- (i) from there extending generally northerly along a line constantly 100 metres seaward of and normal to the high water mark to a point at the intersection of latitude 23°09.4476'S and longitude 113°45.8646'E;
- (j) from there extending generally northerly along the geodesic to a point at the intersection of latitude 23°09.1812'S and longitude 113°46.0428'E;
- (k) from there extending generally northerly along a line constantly 100 metres seaward of and normal to the high water mark to latitude 23°08.7498'S;
- (l) from there extending east along latitude 23°08.7498'S to the high water mark; and
- (m) from there extending generally northerly along the high water mark to the point described in paragraph (a).

14. Pelican Sanctuary Zone

All that portion of the Ningaloo Marine Park, contained within and bounded by a line —

- (a) commencing on the high water mark at latitude 23°20.7006'S;
- (b) from there extending west to a point on latitude 23°20.7006'S, 100 metres seaward of and normal to the high water mark;
- (c) from there extending generally northerly along a line constantly 100 metres seaward of and normal to the high water mark to latitude 23°17.65'S;
- (d) from there extending west along latitude 23°17.65'S to the limit of Western Australian coastal waters;
- (e) from there extending generally southerly along the limit of Western Australian coastal waters to latitude 23°26.25'S;
- (f) from there extending east to a point on latitude 23°26.25'S, 100 metres seaward of and normal to the high water mark;
- (g) from there extending generally northerly along a line constantly 100 metres seaward of and normal to the high water mark to latitude 23°24.6'S;
- (h) from there extending east along latitude 23°24.6'S to the high water mark; and
- (i) from there extending generally northerly along the high water mark to the point described in paragraph (a).

15. Cape Farquhar Sanctuary Zone

All that portion of the Ningaloo Marine Park, contained within and bounded by a line —

- (a) commencing on the low water mark at latitude 23°33.9'S;
- (b) from there extending west along latitude 23°33.9'S to longitude 113°35.7'E;
- (c) from there extending south along longitude 113°35.7'E to latitude 23°38.5'S;
- (d) from there extending east along latitude 23°38.5'S to the low water mark; and
- (e) from there extending generally north-easterly along the low water mark to the point described in paragraph (a).

16. Gnarlaloo Bay Sanctuary Zone

All that portion of the Ningaloo Marine Park, contained within and bounded by a line —

- (a) commencing on the low water mark at longitude 113°32.75'E;
- (b) from there extending north along longitude 113°32.75'E to latitude 23°45.1'S;
- (c) from there extending west along latitude 23°45.1'S to longitude 113°30.9'E;
- (d) from there extending south along longitude 113°30.9'E to latitude 23°47.75'S;
- (e) from there extending east along latitude 23°47.75'S to the low water mark; and
- (f) from there extending generally north easterly and south easterly along the low water mark to the point described in paragraph (a).

17. 3 mile Sanctuary Zone

All that portion of the Ningaloo Marine Park, contained within and bounded by a line —

- (a) commencing on the low water mark at latitude 23°51.0'S;
- (b) from there extending west along latitude 23°51.0'S to longitude 113°29.35'E;
- (c) from there extending south along longitude 113°29.35'E to latitude 23°52.55'S;
- (d) from there extending east along latitude 23°52.55'S to the low water mark; and
- (e) from there extending generally north-easterly along the low water mark to the point described in paragraph (a).

18. Turtles Sanctuary Zone

All that portion of the Ningaloo Marine Park, contained within and bounded by a line —

- (a) commencing on the low water mark at latitude 23°56.85'S;
- (b) from there extending west along latitude 23°56.85'S to longitude 113°24.7'E;

- (c) from there extending south along longitude 113°24.7'E to latitude 23°59.15'S;
- (d) from there extending east along latitude 23°59.15'S to the low water mark; and
- (e) from there extending generally northerly along the low water mark to the point described in paragraph (a).

Schedule 2 — Special purpose areas

1. Special Purpose (benthic protection) Zone Mandu

All that portion of the Ningaloo Marine Park, contained within and bounded by a line —

- (a) commencing on the north west corner of Mandu sanctuary zone at the intersection of latitude 22°04.35'S and longitude 113°52.959'E;
- (b) from there extending west along latitude 22°04.35'S to the limit of Western Australian coastal waters;
- (c) from there extending generally southerly along the limit of Western Australian coastal waters to latitude 22°09.65'S;
- (d) from there extending east along latitude 22°09.65'S to the south-west corner of Mandu sanctuary zone at longitude 113°51.2856'E;
- (e) from there extending generally northerly along the geodesic to the point described in paragraph (a).

2. Special Purpose (Shore Based Activities) Zone Murat — south

All that portion of the Ningaloo Marine Park, contained within and bounded by a line —

- (a) commencing on the low water mark boundary of Ningaloo Marine Park at latitude 21°49.55'S;
- (b) from there extending east to a point on latitude 21°49.55'S, 100 metres seaward of and normal to the high water mark;
- (c) from there extending generally north-easterly along a line constantly 100 metres seaward of and normal to the high water mark to the southern boundary of the Commonwealth Communication Pier Excision;
- (d) from there extending generally north-westerly to the low water mark boundary of Ningaloo Marine Park;
- (e) from there generally south-westerly along the low water mark to the point described in paragraph (a).

3. Special Purpose (Shore Based Activities) Zone Murat — north

All that portion of the Ningaloo Marine Park, contained within and bounded by a line —

- (a) commencing on the low water mark boundary of Ningaloo Marine Park at latitude 21°48.55'S;
- (b) from there extending generally south-easterly along the low water mark to the northern boundary of the Commonwealth Communication Pier Excision;

- (c) from there extending generally south-easterly to a point on the northern boundary of the Commonwealth Communication Pier Excision 100 metres seaward of and normal to the high water mark;
- (d) from there extending generally north-westerly along a line constantly 100 metres seaward of and normal to the high water mark to latitude 21°48.55'S; and
- (e) from there extending west along latitude 21°48.55'S to the point described in paragraph (a).

4. Special Purpose (Shore Based Activities) Zone Lighthouse Bay

All that portion of the Ningaloo Marine Park, contained within and bounded by a line —

- (a) commencing on the low water mark boundary of Ningaloo Marine Park at longitude 114°10.35'E;
- (b) from there extending north to a point on longitude 114°10.35'E, 100 metres seaward of and normal to the high water mark;
- (c) from there extending generally north-westerly and south-westerly along a line constantly 100 metres seaward of and normal to the high water mark, to longitude 114°07.9667'E;
- (d) from there extending south along longitude 114°07.9667'E to the low water mark; and
- (e) from there extending generally north-easterly and south-easterly along the low water mark to the point described in paragraph (a).

5. Special Purpose (Shore Based Activities) Zone Jurabi

All that portion of the Ningaloo Marine Park, contained within and bounded by a line —

- (a) commencing on the high water mark at longitude 114°10.8'E;
- (b) from there extending north to a point on longitude 114°10.8'E, 100 metres seaward of and normal to the high water mark;
- (c) from there extending generally south-westerly along a line constantly 100 metres seaward of and normal to the high water mark, to longitude 113°59.8'E;
- (d) from there extending south along longitude 113°59.8'E to the high water mark; and
- (e) from there extending generally north-easterly from the high water mark to the point described in paragraph (a).

6. Special Purpose (Shore Based Activities) Zone Osprey-north

All that portion of the Ningaloo Marine Park, contained within and bounded by a line —

- (a) commencing on the high water mark boundary of Ningaloo Marine Park at latitude 22°13.3'S;
- (b) from there extending west to a point on latitude 22°13.3'S, 100 metres seaward of and normal to the high water mark;

- (c) from there extending generally southerly along a line constantly 100 metres seaward of and normal to the high water mark to latitude 22°14.9226'S;
- (d) from there extending east along latitude 22°14.9226'S to the high water mark; and
- (e) from there extending generally northerly along high water mark to the point described in paragraph (a).

7. Special Purpose (Shore Based Activities) Zone Osprey-south

All that portion of the Ningaloo Marine Park, contained within and bounded by a line —

- (a) commencing on the high water mark boundary of Ningaloo Marine Park at latitude 22°18.4284'S;
- (b) from there extending west to a point on latitude 22°18.4284'S 100 metres seaward of and normal to the high water mark;
- (c) from there extending generally southerly along a line constantly 100 metres seaward of and normal to the high water mark to latitude 21°19.5'S;
- (d) from there extending east along latitude 21°19.5'S to the high water mark; and
- (e) from there extending generally northerly along high water mark to the point described in paragraph (a).

8. Special Purpose (Shore Based Activities) Zone Winderabandi

All that portion of the Ningaloo Marine Park, contained within and bounded by a line —

- (a) commencing on the high water mark boundary of Ningaloo Marine Park at latitude 22°22.8'S;
- (b) from there extending west to a point on latitude 22°22.8'S, 100 metres seaward of and normal to the high water mark;
- (c) from there extending generally southerly, westerly and again southerly along a line constantly 100 metres seaward of and normal to the high water mark to latitude 22°29.75'S;
- (d) from there extending east along latitude 22°29.75'S to the high water mark; and
- (e) from there extending generally northerly along the high water mark to the point described in paragraph (a).

9. Special Purpose (Shore Based Activities) Zone Cloates

All that portion of the Ningaloo Marine Park, contained within and bounded by a line —

- (a) commencing on the high water mark boundary of Ningaloo Marine Park at latitude 22°39.3942'S;
- (b) from there extending west to a point on latitude 22°39.3942'S, 100 metres seaward of and normal to the high water mark;
