LOCAL GOVERNMENT ACT 1995

Town of Claremont

PARKING AND PARKING FACILITIES AMENDMENT LOCAL LAW

That under the powers conferred by the *Local Government Act 1995* (the Act) and under all the powers enabling it, the Council of the Town of Claremont resolved on 1 March 2005 to amend the Parking and Parking Facilities Local Law which was published in the *Government Gazette* on 12 December 2003 as follows—

1. At the end of Part 9, insert—

" PART 10-RESIDENTIAL PARKING PERMITS

10.1 Residential Parking Permits

(1) An occupier of a lot fronting the subject thorough fare may apply for permits to park two vehicles on the thorough fare.

(2) An application for a permit must be made in the form determined by the Town of Claremont.

(3) The Town may in respect of an application for $\operatorname{permit}(s)$ for the purpose of subclause $1-\!\!-\!\!$

- (a) Approve it;
- (b) Approve it subject to the conditions as the local government considers appropriate; or
- (c) Refuse to approve it.

(4) Where the Town makes a decision under paragraph (a) or (b) of subclause 3, it shall issue any permit in the form determined by it to the person who applied for the permit(s).

(5) A permit issued for the purpose of subclause (1) will be an annual permit issued for a period not exceeding one year and expiring on 31 December in the year of issue.

(6) Every permit issued for the purpose of subclause (1) is to specify—

- (a) A permit number;
- (b) The residential address to which the permit is issued;
- (c) The name of the thoroughfare to which the exemption applies; and
- (d) The date on which it expires.

10.2 Conditions of Exemption for Residential Parking Permits

Where the parking of a vehicle on any part of a thorough fare within the district is prohibited for more than the specified time, the holder of a permit under clause 10.1 is exempted from such prohibitions if—

- (a) The vehicle is parked on a thoroughfare specified in the permit, but not adjacent to retail premises where the parking of all vehicles is subject to a time restriction.
- (b) The permit is placed on the dashboard in a prominent position; and
- (c) The period in respect of which the permit was issued has not expired.

10.3 Register of Residential Parking Permits

The Town shall maintain a Register of Residential Parking Permits which shall record the— $\,$

- (a) Number assigned to that permit;
- (b) Name and address of the person to whom the permit is issued;
- (c) Name of the thoroughfare to which the permit applies; and
- (d) Date on which the residential parking permit expires.

10.4 Lost or Misplaced Parking Permits

In the event that the person to whom a Residential Parking Permit was issued loses or misplaces that permit, then the original permit shall be cancelled and a new permit may be issued which shall be valid only until the expiry date of the permit it replaces.

10.5 Fees & Charges

The fees and charges in relation to this section will be set in accordance with Part 6 Division 5 and Subdivision 2 of the *Local Government Act 1995*.".

- 2. Renumber all parts thereafter.
- 3. In the Table of Contents, delete the Heading 'PART 10-PENALTIES' and substitute 'PART 11-PENALTIES'. Renumber clauses '10.1', '10.2' and '10.3' to '11.1', '11.2' and '11.3' respectively. After Part 9, insert—

PART 10—RESIDENTIAL PARKING PERMITS

- 10.1 Residential Parking Permits
- 10.2 Conditions of Exemption for Residential Parking Permits
- 10.3 Register of Residential Parking Permits
- 10.4 Lost or Misplaced Parking Permits
- 10.5 Fees & Charges ".

POISONS ACT 1964

POISONS (SECTION 24) NOTICE 2005

Made by the Commissioner of Health under section 24.

Citation

1. This notice may be cited as the Poisons (Section 24) Notice 2005.

Revocation

2. The Poisons (Section 24) Notice 1992* is revoked.

Interpretation

3. In this notice, unless the contrary intention appears—

"Agvet Code of Western Australia" has the same meaning as it has in the Agricultural and Veterinary Chemicals (Western Australia) Act 1995;

"approved" means approved by the Commissioner of Health;

- "licensed fumigator" means a person licensed under regulation 36 of the *Health (Pesticides)* Regulations 1956;
- "pesticide operator" means pesticide operator as defined under regulation 62 of the *Health* (*Pesticides*) Regulations 1956;

"Pesticides Regulations" means the Health (Pesticides) Regulations 1956;

- "primary producers" means persons whose land is used for any or all of the following businesses—
 - (a) an agricultural business but not a forestry or reafforestation business;
 - (b) a grazing, horticultural, viticultural, apicultural, pig-raising or poultry farming business;

"registered label" means a label approved under Part 2 of the Agvet Code of Western Australia

Conditions etc. Imposed under section 24 (5) of the Act

4. (1) Subject to subclause (2) the conditions and restrictions under which a poison included in Schedule 7 that is referred to in column 1 of the Table to this clause may be sold or supplied are referred to in column 2 of the Table opposite the poison to which those conditions and restrictions apply.

(2) The conditions and restrictions referred to in subclause (1) shall not affect—

- (a) the supply to and use by persons approved by the Commissioner of Health for research, or other specific purposes;
- (b) the sale by persons licensed to manufacture and distribute or sell by wholesale to retailers licensed, in accordance with the *Poisons Regulations 1965*, to sell such poisons;
- (c) the sale by persons licensed to manufacture and distribute or sell by wholesale to commercial pesticide firms or pesticide operators licensed under the Pesticides Regulations to use these poisons in accordance with the registered label or licence issued under the Pesticides Regulations;
- (d) the use and possession of poisons, contained in the notice by registered commercial pesticide firms or licensed pesticide operators for use in accordance with licences issued under the Pesticides Regulations;
- (e) the sale by persons licensed to manufacture and distribute or sell poisons included in Schedule 7 by wholesale or by retail to industrial users holding permits under section 25 of the Act; and
- (f) the use and possession of poisons included in Schedule 7 by industrial users holding permits under section 25 of the Act.

The Western Australian Planning Commission is readvertising a proposed amendment to the Metropolitan Region Scheme for the Alkimos–Eglinton area in the City of Wanneroo. Further public comment is invited.

Purpose

As a result of meetings between landowners and stakeholders, the original proposal has been modified. The modifications relate to the realignment of Marmion Avenue generally further eastwards and to east-west roads where they connect with Marmion Avenue. The other main elements of the proposed amendment as previously advertised remain the same, and are—

- Relocation of Waste Water and Ground Water Treatment Plants, improving access to the regional beach at Alkimos;
- Changes to land reserved for Parks and Recreation, to improve coastal access and create a town park at Alkimos; and
- Reduction of the area reserved for the Alkimos Central City Area.

Full details of the amendment's proposals can be found in the Commission's explanatory Amendment Report (Modified).

Environmental Review

The Environmental Protection Authority required the proposed amendment to be formally assessed by way of an Environmental Review (Assessment No. 1635). 
