#### LOCAL GOVERNMENT ACT 1995

Shire of Wyndham East Kimberley Activities in Thoroughfares and Public Places and Trading Amendment Local Law 2005

Under the powers conferred by the *Local Government Act 1995* and under all other powers enabling it, the Council of the Shire of Wyndham East Kimberley, resolved on the 19th day of April 2005 to make the following local law.

#### Citation

This local law may be cited as the "Activities in Thoroughfares and Public Places and Trading Amendment Local Law 2005."

#### **Principal Local Law**

In this local law, the Shire of Wyndham East Kimberley Activities in Thoroughfares and Public Places and Trading Local Law 2003 as adopted by the Council of the Shire of Wyndham East Kimberley by notice published in the *Government Gazette* on the 3rd of December 2003 is referred to as the principal local law.

#### **Principal Local Law Amended**

The principal local law is amended by-

- 1. Adding section 2.3[1] No gambling in a public place or on local government property stating: A person shall not undertake any gambling related activity in a public place or on local government property unless—
- 1. the person is doing so in accordance with a permit from the Shire.
- 2. Adding the following in Schedule 1 Prescribed Offences-

Clause	Description	Penalty
2.3[1]	Gambling in public place or on local government property	\$100

Adopted at an ordinary meeting of Council of the Shire of Wyndham East Kimberley held on the 19th day of April 2005.
