East Perth Redevelopment Act 1991

### East Perth Redevelopment Order 2005

Made by the Lieutenant-Governor and deputy of the Governor in Executive Council under section 18A.

**1. Citation**

This order is the *East Perth Redevelopment Order 2005*.

**2. East Perth Redevelopment Authority to provide services**

It is a function of the East Perth Redevelopment Authority to provide services to the Public Transport Authority in relation to the redevelopment of land in the Area described in Schedule 1.

#### Schedule 1 — Area

[cl. 2]

The area to which this order applies is the area of land bounded to the west by the eastern boundary of the Mitchell Freeway Road Reserve, to the north by and including the Roe Street Road Reserve, to the south by and including the Wellington Street Road Reserve, east to and including the Pier Street Road Reserve and includes the area of land which extends north-east from Pier Street along the Railway Reserve, up to the western boundary of the Lord Street Road Reserve.

Fish Resources Management Act 1994

**Fish Resources Management Amendment  
Regulations (No. 2) 2005**

Made by the Governor in Executive Council.

**1. Citation**

These regulations are the *Fish Resources Management Amendment Regulations (No. 2) 2005*.

**2. The regulations amended**

The amendments in these regulations are to the *Fish Resources Management Regulations 1995*\*.

[\* *Reprint 4 as at 14 November 2003.*

*For amendments to 11 April 2005 see Western Australian Legislation Information Tables for 2004, Table 4, p. 131, and Gazette 1 March 2005.*

**3. Regulation 3 amended**

Regulation 3(1) is amended in the definition of “gear identification number”, in paragraph (a), by deleting “allocated under regulation 124(2)(b) in respect of a recreational fishing licence held by the person; or” and inserting instead —

“

specified in accordance with —

- (i) regulation 124(2)(b) on a recreational fishing licence held by the person; or
- (ii) regulation 124A(4) on a receipt, within the meaning of that regulation, for an application for a recreational fishing licence issued to the person;

or

”.

**4. Regulation 124A inserted**

After regulation 124 the following regulation is inserted in Division 2 —

“

**124A. Recreational fishing licence receipt may have effect as if it was a recreational fishing licence**

(1) In this regulation —

“**recreational fishing licence receipt**” means a receipt issued by the Executive Director to a person who has applied for the grant, or renewal, of a recreational fishing licence.

(2) A recreational fishing licence receipt issued to an applicant has effect as if it was a recreational fishing licence granted under regulation 124 to the person until —

- (a) the Executive Director gives notice to the applicant of the outcome of the application; or
- (b) the expiration of one month after the date on which the receipt was issued,

whichever occurs first.

(3) Despite subregulation (2), a recreational fishing licence receipt does not have effect as if it was a recreational fishing licence if the applicant to whom it was issued —

- (a) was the holder of a recreational fishing licence which was cancelled, or not renewed by the Executive Director;
- (b) has been convicted of an offence against the Act;
- (c) is not in possession of the receipt when engaging in an activity specified in the receipt; or
- (d) is the holder of a commercial fishing licence and the recreational fishing licence receipt specifies that the applicant may engage in any activities other than those set out in items 2 and 4 of the Table to regulation 124.

(4) A recreational fishing licence receipt is to be in a form approved by the Executive Director and is to specify —

- (a) the same matters that are to be specified in respect of a recreational fishing licence under regulation 124(2)(a) and (b); and
- (b) the date on which the receipt was issued.
