JURIEN BAY MARINE PARK MANAGEMENT PLAN

Under section 14(9) of the *Conservation and Land Management Act 1984* (CALM Act) notice is given that the indicative management plan for the Jurien Bay Marine Park has been approved by the Minister for the Environment.

The indicative management plan was prepared in accordance with sections 13 to 14 of the CALM Act and was approved, with modifications, by the Minister for the Environment on 8 July 2004. The indicative management plan, called the Jurien Bay Marine Park Management Plan, comes into operation on the day of publication of this notice in the *Gazette*.

The indicative management plan was approved by the Minister for the Environment under section 14(7) of the CALM Act with the following modifications—

- The boundaries of the following zones have been modified (reasons for modification in parentheses)—
  - ➤ North Head Sanctuary Zone (to permit fishing along southern shoreline);
  - > Special Purpose (Scientific Reference) Zones and Special Purpose (Shore-Based Activities) Zones (to simplify the zoning scheme in relation to compliance); and
  - Booker Rocks Sanctuary Zone (to simplify the zoning scheme in relation to compliance).
- A part of the proposed North Head Sanctuary Zone was changed to become a Special Purpose (Shore-Based Activities) Zone to allow for shore-based fishing to continue in this area.
- Other minor changes were made to the boundaries of some zones to simplify the zoning scheme, increase ease of compliance by users and so increase management cost effectiveness. Where these changes were made, the original intent of the plan is maintained.
- There were amendments to the permitted activities table for the zoning scheme to reflect the changes to the zoning scheme, practical compliance issues and other issues raised through the review of public submissions.

- New management strategies were inserted for some ecological and social values.
- There were some amendments to the management strategies, management objectives and long-term management targets for some values.
- Direct management intervention (Section 8.7) was inserted.
- Provision for a mooring plan for the marine park was added (Section 9).
- Some minor changes were made to the text of the indicative management plan e.g. structure of document, formatting, minor text amendments, and timeline for implementation of management strategies.
