NOTICE OF ENTRY OF PLACES IN THE REGISTER OF HERITAGE PLACES

Notice is hereby given in accordance with Section 51(2) of the Heritage of Western Australia Act 1990 that, pursuant to directions from the Minister for Heritage, the places described in Schedule 1 have been entered in the Register of Heritage Places on a permanent basis with effect from today.

Schedule 1 Description of Place

Perth Observatory at 337 Walnut Road, Bickley; That part of State Forrest No. 22, together with ptn of Canning Locs 791 & 792, also part of State Forrest No. 22 & ptn of Reserve 6203 as shown on HCWA Drawing No. 10551 prepared by Steffanoni Ewing & Cruickshank.

The Cliffe at 25 Bindaring Parade, Peppermint Grove; Ptn of Swan Loc 84 and being (firstly) part of each of Lots 25, 26 & 27 on P 3783 (Sheet 1) & (secondly) part of each of Lots 28 & 29 on D 8903 and being the whole of the land in C/T V 1265 F 334.
