Shire of Jerramungup

PARKING AND PARKING FACILITIES LOCAL LAW

Under the powers conferred by the *Local Government Act 1995* as amended from time to time and under all other powers, the Council of the Shire of Jerramungup resolved on the nineteenth day of July 2005 to make the following local law.

The Town of Cottesloe Parking and Parking Facilities Local Law as published in the *Government Gazette* of 10 December 2001 is adopted as a local law of the Shire of Jerramungup, with the modifications which follow—

- 1. Wherever the "Town of Cottesloe" is mentioned in the local law substitute "Shire of Jerramungup".

(DISCONTINUATION OF WARD SYSTEM AND CHANGE OF REPRESENTATION) ORDER 2005

Made by the Governor in Executive Council on the recommendation of the Minister for Local Government and Regional Development.

1. Citation

This order is the District of the Shire of York (Discontinuation of Ward System and Change of Representation) Order 2005.

2. Meaning of "election"

In this order-

"election" means the next poll after the commencement of this order for the election of members to fill the vacant offices of the Council of the Shire of York.

3. Discontinuation of the ward system for the Shire of York (s.2.2 (1) (d) of the Act)

All the wards in the district of the Shire of York are abolished immediately before the day of the election.

4. Number of Councillors changed (s.2.18 (3) of the Act)

On and after the day of the election, the number of councillors for the district of the Shire of York is six instead of nine.

5. Consequential directions (s.9.62 of the Act)

Part 4 of the Act, modified to the extent necessary to give effect to clauses 3 and 4, applies to preparing for and conducting the election as if changes effected by those clauses had taken effect on the day on which this order commenced.

I recommend that the orders in clauses 3 and 4 be made as recommended by the Local Government Advisory Board.
