NOTICE OF ENTRY OF PLACES IN THE REGISTER OF HERITAGE PLACES

NOTICE OF ADVICE REGARDING REGISTRATION OF CROWN PROPERTY

In accordance with the requirements of Section 47(5) of the Heritage of Western Australia Act, the Heritage Council hereby gives notice that it has advised the Minister for Heritage that the places listed in Schedule 1 should be entered in the Register of Heritage Places on an interim basis. The Heritage Council hereby gives notice of the interim registration and invites submissions on the matter; which must be in writing and should be forwarded to the address below not later than 19 October 2005. The places listed in Schedule 1 are vested in the Crown, or in a person on behalf of the Crown, in right of the State.

Doctor's House (fmr), Norseman at 66 Talbot Street cnr Simon Street, Norseman: Lot 834 on DP 160723 being the whole of Res 35764 & being the whole of the land contained in CLT V 3030 F 826.

Pemberton-Northcliffe Railway & Railway Station including Tramway between Pemberton and Northcliffe; and Pemberton Station, Railway Crescent, Pemberton: Ptn of Pemberton Lot 116 & being pt of Res 21116, Lot 289 on DP 33537, being pt of Res 46921 & being the whole of the land contained in CLT V 3128 F 290, Lot 293 on DP 33537, being pt of Res 46921 & being the whole of the land contained in CLT V 3128 F 294, Lot 298 on DP 33537, being pt of Res 46921 & being the whole of the land contained in CLT V 3128 F 299, Unnumbered Railway Res running from Crown Res 46921 in Pemberton to its termination at Muirillup Road in Northcliffe, Unnumbered Railway Res being the subject of P 5456, together as shown on HCWA Drawing No. 4637 prepared by Steffanoni Ewing & Cruickshank Pty Ltd.
