3. Regulation 6A amended

LOCAL GOVERNMENT ACT 1995

Shire of Boddington

LOCAL LAW RELATING TO UNSIGHTLY LAND AND REFUSE, RUBBISH OR DISUSED MATERIALS ON LAND

Under the powers conferred by the *Local Government Act 1995* as amended from time to time and under all other powers enabling it, the Council of the Shire of Boddington resolved on the 16th day of August 2005 to make the "Shire of Boddington Local Law Relating to Unsightly Land and Refuse, Rubbish or Disused Materials on Land".

1. Citation

PART 1—PRELIMINARY

This local law may be cited as the Shire of Boddington Local Law relating to Unsightly Land and Refuse, Rubbish or Disused Materials on Land.

2. Definitions

- (1) In this local law, unless the context otherwise requires—
 - "**abandoned**" means being left on the land without being moved or used for it's original purpose for a period longer than 3 months;
 - "Act" means the Local Government Act 1995;
 - "**authorized person**" means a person appointed by the local government to be an authorized person for the purposes of this local law;
 - **'CEO**" means the Chief Executive Officer of the local government;
 - "district" means the district of the local government;
 - "**deposited**" means placed on the land and not used for it's original purpose for a period longer than 3 months;
 - "local government" means the Shire of Boddington;
 - "**unsightly**" has the same meaning as defined in schedule 3.1 of the *Local* Government Act 1995 as amended;
 - "material" means the substance of which things are composed and includes organic and inorganic matter;
 - "refuse, rubbish or disused material" includes-
 - (i) any abandoned or unwanted object, material or thing, whether it has any present value or not, placed on the land;
 - (ii) any motor vehicle, motor vehicle part, caravan, trailer, boat or other thing or machinery which has been parked, deposited or stored on any land, notwithstanding that it may have a value, being visible from the road or adjoining land, which in the opinion of the CEO, or an authorized person, is unsightly;
 - (iii) any wood, timber, lumber or cuttings, logs or remnants of trees, or chopped, split or chipped wood, and any like material notwithstanding that it may have a value; or
 - (iv) anything placed on the land that in the opinion of an authorized person is
 - a. unsightly;
 - b. is likely to adversely affect the health, safety, comfort, convenience or amenity of the inhabitants of that land or any other land or is likely to cause damage to that land or any other land; or
 - c. results in that land having an appearance which does not conform with the general appearance of other land in the locality.
 - "placed" means stored, deposited or put;
 - "serve" has the same meaning as defined in section 75 and 76 of the Interpretation Act 1984;
 - "stored" means placed on the land and not used for it's original purpose.

(2) Where in these local laws a duty of liability is imposed on an owner or occupier of land, the duty of liability is imposed jointly and severally on each of the owners or occupiers.

3. Object

The object and purpose of this Local Law is to ensure owners or occupiers maintain their land in a condition free of Refuse, Rubbish or Disused material that is Unsightly.

PART 2—GENERAL

4. Notices

If there is on any land, vacant or otherwise within the district, any Refuse, Rubbish or Disused Material an authorized person may issue and serve a notice signed by the Chief Executive Officer—

(1) requiring the owner or occupier to—

- (i) clean up;
- (ii) clear away;
- (iii) remove;
- (iv) shield from view by the construction of a fence or screen to the satisfaction of the local government; or
- (v) carry out any other works to achieve the object of the Local Law.

(2) requiring the owner or occupier to dispose of any Refuse, Rubbish or Disused Material.

(3) advising the owner or occupier that they have 28 days in which to lodge a notice of objection with the Chief Executive Officer of the local government.

(4) advising the owner or occupier that failure to comply with the notice may result in Court action proceeding without further notice.

(5) advising the owner or occupier that failure to comply with a notice may result in the local government carrying out the work set out in the notice, the costs of which will be recovered from the owner or occupier of the land.

5. Objection by owner or occupier

The owner or occupier of land having been served with notice under this Local Law is deemed to be an affected person under the Act, and may within 28 days of being served with a notice, lodge a notice of objection, in writing, addressed to the Chief Executive Officer.

PART 3—PENALTIES

6. Breach for failure to comply with a notice

An owner or occupier, having been served with a notice, who fails to comply with the terms of the notice within the prescribed time, commits an offence.

Penalty-

- (i) \$5,000; and
- (ii) a daily penalty of \$500.00

7. Entry and disposal of refuse, rubbish or disused materials

Where an owner or occupier fails to comply with the terms of a notice, and refuses to give the local government written permission to enter onto the land to carry out the work specified in the notice, the local government may, at the time of conviction for a breach of this Local Law make application to the Court for—

- (i) a Warrant to enter onto the land to carry out the work specified in the notice; and,
- (ii) an order that Refuse, Rubbish or Disused materials removed and impounded be confiscated and disposed of.

8. Recovery of costs

The local government may recover the cost of work that an owner or occupier fails to carry out prescribed by a notice under this Local Law as a debt due from the owner or occupier.

3. Regulation 3.98 amended


GAS STANDARDS ACT 1972

TESTING, APPROVAL AND LABELLING OF GAS APPLIANCES

The Director of Energy Safety hereby gives notice that from 9 September 2005-

- (1) Pursuant to Section 13F of the Gas Standards Act 1972 he adopts the full certification and safety certification of Type A gas appliances given in accordance with the following—
 - (a) Australian Gas Association's national Product Certification Schemes for gas appliances and components, under the published rules of those schemes, administered and operated by Australian Gas Association, 2 Park Way, Braeside, Victoria 3195; and
 - (b) SAI Global Product Compliance, Gas Safety Certification for Gas Appliances and Components, under the published rules of those schemes, administered and operated by SAI Global, 286 Sussex Street, Sydney NSW 2000.
- (2) All certifications by the Australian Gas Association since 1 January 2004 are also recognised under paragraph [1(a)] above;

- (3) Pursuant to Section 13E of the *Gas Standards Act 1972* the following bodies, through their relevantly authorised inspectors, are each recognised to be a competent authority to test and approve limited quantities of new Type A gas appliances in WA, under the delegated authority of the Director—

 - (c) Dalefield Pty Ltd
 - (d) Hi Speed Gas Pty Ltd
 - (e) Peter's Commercial Kitchens
 - (f) Strachan Plumbing and Gas;
- (4) Approval badges in the form shown—



are the recognised mark to be carried by Type A gas appliances approved under (3) above; and

FISH RESOURCES MANAGEMENT ACT 1994

PROHIBITION ON COMMERCIAL FISHING (NINGALOO MARINE PARK) ORDER 2005

Order No. $13 \ {\rm of} \ 2005$

FD 1620/98 [695]

Made by the Minister under section 43.

1. Citation

This order may be cited as the Prohibition on Commercial Fishing (Ningaloo Marine Park) Order 2005.

2. Interpretation

- In this order, unless the contrary intention appears-
 - "General Use Areas" means all of the areas specified in Schedule 3;
 - "marine aquarium fish" has the same meaning as provided for in the Marine Aquarium Fish Management Plan 1995*;
 - "Ningaloo Marine Park" means all the waters of the area specified in Schedule 2;
 - "Recreation Areas" means all the areas specified in Schedule 4;
 - "regulations" means the Fish Resources Management Regulations 1995;
 - "Sanctuary Areas" means all the areas specified in Schedule 7;
 - "Special Purpose Benthic Protection Area" means the area specified in Schedule 6;
 - "Special Purpose Shore Based Activities Areas" means all the areas specified in Schedule 5;
 - "specimen shell" has the same meaning as provided for in the Specimen Shell Management Plan 1995**.

3. Prohibition on commercial fishing

Subject to clause 4, a person must not engage in commercial fishing in any of the waters of the Ningaloo Marine Park.

4. Exceptions to the prohibition in clause 3

Clause 3 does not apply to a person who-

- (a) holds a commercial fishing licence; and
- (b) engages in an activity specified in Schedule 1.

5. Revocation

The Ningaloo Marine Park (Professional Fishing) Notice 1991, published in the Government Gazette of 11 October 1991 and which continued in force under regulation 186 of the Fish Resources Management Regulations 1995 as if it was an order made under section 43, is revoked.

Schedule 1

1. Trawling

Fishing by trawling in accordance with the *Exmouth Gulf Prawn Management Plan 1989**** in the waters of the General Use Areas that are east of North West Cape.

2. Marine Aquarium Fish and Specimen Shell

(1) Fishing for specimen shell in accordance with the Specimen Shell

Management Plan 1995 in the waters of the General Use Areas that are-

- (a) north of 21° 56.300' south latitude; or
- (b) south of 23° 7.300' south latitude.

(2) Fishing for marine aquarium fish in accordance with the Marine Aquarium Fish Management Plan 1995 in the waters of the General Use Areas that are—

- (a) north of 21° 56.300' south latitude; or
- (b) south of 23° 7.300' south latitude.

3. Line Fishing

Fishing by line, excluding longline, from a licensed fishing boat in the waters of the General Use Areas that are—

- (a) north of 21° 56.300' south latitude; or
- (b) south of 23° 7.300' south latitude.

Schedule 2

Ningaloo Marine Park

All waters bounded by a line commencing south-east of North West Cape in the Exmouth Gulf at the intersection of 21° 52.9218' south latitude and 114° 19.0812' east longitude; thence north along the meridian to the intersection with 21° 46.9218' south latitude; thence north-westerly along the geodesic to the intersection of 21° 41.45' south latitude and 114° 14.39' east longitude (the seaward limit of the coastal waters of the State); thence generally south-westerly, generally southerly and again generally south westerly along the seaward limit of the coastal waters of the State to 24° 01.8636' south latitude; thence easterly along the parallel to the intersection with the high water mark on the coastline at approximately the northern end of Red Bluff; thence generally easterly, north-easterly, northerly, and again generally north-easterly along the high water mark to the intersection with 114° 8.236' east longitude (a point on the western boundary of Lyndon Location 44); thence northerly along the meridian (the western boundary of Lyndon Location 44) to the low water mark on the coastline; thence generally north-easterly and generally south-easterly along the low water mark on the coastline (the boundaries of Lyndon Location 44) to the intersection with 21° 48.79' south latitude (the north-eastern boundary of the Commonwealth Communication Pier Excision (the area of the Exmouth Gulf described in the notice under the Lands Acquisition Act 1955 of the Commonwealth published in the Commonwealth of Australia Gazette No. 49 of 28 May 1964 at page 2027)); thence from there extending south easterly along the geodesic to the intersection of 21° 48.93' south latitude and 114° 12.05' east longitude; thence south westerly along the geodesic to the intersection of the intersection of 21° 48.93' south latitude the intersection of 21° 48.93' south latitude the intersection of 21° 48.93' south latitude and 114° 12.05' east longitude; thence south westerly

Schedule 3

General Use Areas

All waters of Ningaloo Marine Park other than the waters described in Schedule 4, Schedule 5, Schedule 6, and Schedule 7.

Schedule 4

Recreation Areas

(1) All waters bounded by a line commencing at the intersection of the high water mark on the coastline and 21° 52.9218' south latitude; thence easterly along the parallel to the intersection with 114° 12.3516' east longitude; thence northerly along the meridian to the intersection with 21° 49.55' south latitude; thence westerly along the parallel to the intersection with the high water mark on the coastline; thence generally southerly along the high water mark on the coastline; thence generally southerly along the high water mark on the coastline; thence southerly along the meridian to the intersection with 114° 10.95' east longitude; thence easterly along the parallel to the intersection with 114° 10.95' east longitude; thence southerly along the meridian to the intersection with 21° 52.4833' south latitude; thence westerly along the parallel to the intersection with 21° 52.4833' south latitude; thence generally southerly along the intersection with the high water mark on the coastline; thence generally southerly along the high water mark on the coastline; thence generally southerly along the high water mark on the coastline; thence generally southerly along the high water mark on the coastline to the intersection with the high water mark on the coastline; thence generally southerly along the high water mark on the coastline to the intersection with the high water mark on the coastline; thence generally southerly along the high water mark on the coastline to the coastline; thence westerly point.

PROHIBITION ON RECREATIONAL FISHING (NINGALOO MARINE PARK) ORDER 2005

Order No. 12 of 2005

FD 1620/98 [695]

Made by the Minister under section 43.

1. Citation

This order may be cited as the Prohibition on Recreational Fishing (Ningaloo Marine Park) Order 2005.

2. Interpretation

(1) In this order, unless the contrary intention appears—

"fishing net" has the same meaning as in regulation 3 of the regulations;

"General Use Areas" means all the areas specified in Schedule 2;

"mesh size" means the size of the mesh of a fishing net as measured in accordance with regulation 64D of the regulations;

"mollusc" means fish of the Phylum Mollusca except oysters, cuttlefish, octopus and squid;

"Ningaloo Marine Park" means all the waters of the area specified in Schedule 1;

"pointed instrument" means a speargun, harpoon, gidgie, hawaiian sling or any other similar pointed device;

"Recreation Areas" means all the areas specified in Schedule 3;

"regulations" means the Fish Resources Management Regulations 1995;

"Sanctuary Areas" means all the areas specified in Schedule 6;

"Special Purpose Benthic Protection Area" means the area specified in Schedule 5;

"Special Purpose Shore Based Activities Areas" means all the areas specified in Schedule 4.

(2) In this order, unless the contrary intention appears the following expressions have the same meaning as provided for in regulation 3(2) and Schedule 7 to the regulations—

"cod";

- "manta ray";
- "mullet";

"Queensland groper";

"wrasse".

3. Sanctuary Areas

A person must not engage in recreational fishing in the waters of the Sanctuary Areas.

4. General Use Areas

(1) A person must not engage in recreational fishing by means of a pointed instrument in the waters of the General Use Areas that are—

- (a) north of $22^{\circ} 29.7500'$ south latitude; or
- (b) south of 21° 56.300' south latitude.

(2) A person must not engage in recreational fishing in the waters of the General Use Areas by means of a fishing net.

(3) Subclause (2) does not apply to a person fishing by means of a throw net for mullet.

5. Recreation Areas

(1) A person must not engage in recreational fishing by means of a pointed instrument in

- the waters of the Recreation Areas that are-
 - (a) north of $22^{\circ} 29.7500'$ south latitude; or
 - (b) south of 21° 56.300' south latitude.

(2) A person must not engage in recreational fishing in the waters of the Recreation Areas by means of a fishing net.

(3) Subclause (2) does not apply to a person fishing by means of—

- (a) a fishing net in the waters of the areas specified in item1, item 3 or item 4 of Schedule 7; or
- (b) a throw net when fishing for mullet.

6. Special Purpose Shore Based Activities Areas

(1) A person must not engage in recreational fishing in the waters of the Special Purpose Shore Based Activities Areas.

(2) Subclause (1) does not apply to a person fishing without the use of, or in connection with the use of, a boat by means of—

- (a) a fishing line;
- (b) a fishing net in the waters of the area specified in item 2 of Schedule 7;
- (c) a throw net when fishing for mullet.

7. Special Purpose Benthic Protection Area

(1) A person must not engage in recreational fishing in the waters of the Special Purpose Benthic Protection Area.

(2) Subclause (1) does not apply to a person fishing by means of trolling.

8. Prohibition on fishing for Queensland groper, manta ray or molluscs

A person must not engage in recreational fishing in the waters of the Ningaloo Marine Park by any means for Queensland groper, manta ray or molluscs.

9. Prohibition on fishing for cod or wrasse by pointed instrument

A person must not engage in recreational fishing in the waters of the Ningaloo Marine Park by means of a pointed instrument for—

- (a) cod; or
- (b) wrasse.

10. Prohibition on fishing with the use of compressed air

A person must not engage in recreational fishing in the waters of the Ningaloo Marine Park by means of a pointed instrument with the assistance of compressed air breathing apparatus.

11. Net fishing

A person must not engage in recreational fishing in the waters of the Ningaloo Marine Park by means of a fishing net other than a throw net unless—

- (a) one end of the net is set on the foreshore above the waterline at all times;
- (b) the net is being used between the hours of 5.30 a.m. and 8.30 a.m. or 4 p.m. and 7 p.m. on any day; and
- (c) the net has a mesh size of not more than 90 millimetres.

12. Revocation

The Ningaloo Marine Park (Recreational Fishing) Notice 1991, published in the Government Gazette of 11 October 1991 and which continued in force under regulation 186 of the Fish Resources Management Regulations 1995 as if it was an order made under section 43, is revoked.

NOTICE TO ALL OWNERS /OR OCCUPIERS OF LAND (ZONE 9)

Pursuant to the powers contained in Section 33 (1) (a) & (b) of the *Bush Fires Act 1954*, you are hereby required on or before the 1st day of October, 2005 or within fourteen days of your becoming owner or occupier of land should this be after the 1st day of October, 2005 to clear firebreaks and remove flammable material from the land owned or occupied by you as specified hereunder and to have the specified land and firebreaks clear of all flammable material from the 1st day of October, 2005 up to and including the 14th day of April, 2006.
