**BUSH FIRES ACT 1954**

*Town of Victoria Park and Town of Vincent*

**2005/2006 FIREBREAK NOTICE**

Notice to all Owners and/or Occupiers of Land within the Town of Victoria Park and Town of Vincent Pursuant to the powers conferred in Section 33 of the *Bush Fires Act 1954*, you are required on or before the 30th November 2005, or within fourteen days of the date you become the owner or occupier should this be after the 30th day of November 2005 and thereafter up to and including the 30th day of April 2006, to clear inflammable matter, on land owned and/or occupied by you in accordance with the following requirements—

1. All land which is 2000 m<sup>2</sup> or less in area;  
Remove inflammable matter from the whole of the land, except living trees and shrubs; plants under cultivation and lawn, by means of ploughing, cultivating or slashing to a height of no more than 50mm.
2. All other land within the Town of Victoria Park and Town of Vincent—
  - (i) Firebreaks of a minimum width and height of 3 metres are to be cleared immediately inside all external boundaries of the land;

- (ii) Firebreaks to a minimum width of 3 metres and height of 3 metres are to be cleared immediately surrounding all buildings situated on the land; and any place where inflammable liquids and gas products are kept;
- (iii) In addition to the requirements in this clause Council may, by notice in writing require an owner and/or occupier to act as and when specified in the notice with respect to anything which is upon land and which in the opinion of Council is or is likely to be conducive to the outbreak of a bush fire or the spread or extension of a bush fire.

The term "Inflammable Matter" for the purpose of this notice includes bush (as defined in the Bush Fires Act 1954), timber, boxes, cartons, paper, rubbish and any other combustible or inflammable matter, but does not include buildings, green standing trees and bushes or growing bushes or plants in gardens or lawns.

All firebreaks must be cleared on or before 30 November in any year and thereafter maintained clear of inflammable matter up to and including 30 April in the following year.

If for any reason an owner and/or occupier considers it impractical to clear firebreaks or comply with other fire protection measures in accordance with the Notice, the owner and/or occupier may apply in writing to Council no later than 31 October in any year for a variation. If permission is not granted in writing by Council or its authorised officer, the owner and/or occupier must comply with the requirements of this Notice. Any variation granted by Council will apply only for a single Firebreak Period. A variation granted by Council shall only remain in force until 30 April in the following year.

The penalty for failing to comply with this notice is a fine of not more than \$5,000.00 and a person in default is also liable whether prosecuted or not, to pay the cost of performing the work directed in this notice if it is not carried out by the owner or occupier by the date required by this notice.

### BUSH FIRES ACT 1954

*Town of Narrogin*

#### FIREBREAK ORDER

OWNERS AND/OR OCCUPIERS OF LAND WITHIN THE MUNICIPALITY OF THE TOWN OF NARROGIN

Pursuant to the powers contained in Section 33 of the *Bush Fires Act 1954*, you are hereby required, on or before 1 November 2005 or within fourteen (14) days of you becoming the owner or occupier should this be after 1 November 2005, to clear firebreaks in accordance with the following and thereafter to maintain the firebreaks clear of flammable material up to and including 31 March 2006.

1. Where the area of land is 4050 square metres (1 acre) or less in area all flammable material on the land shall be removed by close mowing, cultivation, grubbing, approved burning or approved spraying.

2. Where the area of land exceeds 4050 square metres (1 acre) in area a firebreak corridor, at least 4.0 metres wide and 4.0 metres tall, shall be cleared of all flammable material inside all external boundaries of the land and also surrounding all buildings situated on the land by cultivation, approved burning, or approved spraying.

If it is considered to be impracticable to clear firebreaks as required by this notice, you may apply to the Council or its duly authorised officer, not later than 20 November 2005 for permission to take alternative action to abate fire hazards on the land, if permission is not granted by the Council or its duly authorised officer, you shall comply with the requirements of this notice.

The penalty for failure to comply with this notice is a fine of \$250 by infringement notice or a maximum of \$5,000 by prosecution and a person in default is also liable, whether prosecuted or not, to pay the costs of performing the work directed if not completed by the date required by this notice,

NOTE: No further notice will be given after 1 November 2005. Infringement notices will be issued immediately.

If the requirements of this notice are carried out by burning, such burning must be in accordance with Section 18 of the Bush Fires Act. Permits may be obtained from the Chief Bush Fire Control Officer.
