Conservation and Land Management Act 1984

Conservation and Land Management (Saxon Ranger Dive Wreck Restricted Area) Notice 2005

Made by the Executive Director under regulation 5 of the *Conservation and Land Management Regulations 2002*.

1. Citation

This notice is the Conservation and Land Management (Saxon Ranger Dive Wreck Restricted Area) Notice 2005.

2. Commencement

This notice comes into operation on the day after the day on which it is published in the *Gazette*.

3. Interpretation

In this notice —

- "CALM Regulations" means the Conservation and Land Management Regulations 2002;
- "commercial operations licence" has the meaning given to that term in the CALM Regulations;
- "prescribed area" means the area described in Schedule 1 and represented for information purposes in the plan in Schedule 1;
- "restricted area" means the area declared under clause 4;
- "wreck" means the Saxon Ranger dive wreck.

4. Declaration of restricted area in Shoalwater Islands Marine Park

The prescribed area is declared to be at all times a restricted area for the purposes of —

- (a) regulation 28 (cleaning etc. fish) of the CALM Regulations;
- (b) regulation 60 (anchoring of vessels) of the CALM Regulations;
- (c) regulation 61 (operation of vessels) of the CALM Regulations.

5. Prohibited activities in the restricted area

The following activities are prohibited at all times in the restricted area —

- (a) the cleaning, scaling, gutting or filleting of fish;
- (b) the anchoring of a vessel;
- (c) the operation of a vessel other than a vessel that is nominated in
 - (i) a commercial operations licence that authorises the holder to enter and use the restricted area; or
 - (ii) a permit that authorises the holder to use a mooring installed by the City of Rockingham in the restricted area,

and that is operating in the restricted area at a time in respect of which the holder is so authorised.

6. Restriction on the operation of vessels in the restricted area

A vessel must not be operated in the restricted area in a way that causes the vessel to pass over the wreck.

All that portion of Warnbro Sound commencing at the intersection of longitude 115 degrees 42 minutes 15 seconds east and latitude 32 degrees 19 minutes 33 seconds south and extending:


east along latitude 32 degrees 19 minutes 33 seconds south to longitude 115 degrees 42 minutes 22 seconds east;

thence south along longitude 115 degrees 42 minutes 22 seconds east to latitude 32 degrees 19 minutes 40 seconds south;

thence west along latitude 32 degrees 19 minutes 40 seconds south to longitude 115 degrees 42 minutes 15 seconds east;

thence north along longitude 115 degrees 42 minutes 15 seconds to the starting point,

as determined by reference to the Geocentric Datum of Australia 1994.

GENETICALLY MODIFIED CROPS FREE AREAS ACT 2003

GENETICALLY MODIFIED CROPS FREE AREAS EXEMPTION ORDER (No. 2) 2005

Made by the Minister for Agriculture and Forestry under Section 6 of the Act.

Citation

1. This is the Genetically Modified Crops Free Areas Exemption Order (No. 2) 2005.

Exemption

- 2. A person who cultivates a canola crop in Western Australia that contains genetically modified organisms is exempt from the application of section 5(1) of the Act in relation to canola cultivated for harvest in 2005 and 2006 if—
 - (a) the genetically modified organisms are of a type licensed under the Commonwealth *Gene Technology Act 2000* for intentional release into the environment;
 - (b) the crop contains no more than 0.9 per cent of genetically modified organisms; and
 - (c) the crop is derived from seed containing no more than 0.5 per cent of genetically modified organisms.

BUILDING AND CONSTRUCTION LEVY EXEMPTION NOTICE 2005

Made by the Minister for Education and Training under section 25A(1)(b) of the *Building and Construction Training Fund and Levy Collection Act 1990*.

Citation

1. This is the Building and Construction Levy Exemption Notice 2005.

Criteria for exemption

- 2. The following Conditions apply in relation to the carrying out of construction work for charitable purposes by a project owner—
 - (a) that the land on which the construction work is carried out is owned or to be owned by an incorporated body that is a charitable organisation; and
 - (b) that the instrument of conveyance or transfer conveying or transferring the land to the charitable organisation and on which the construction work is carried out or is to be carried out is granted an exemption under section 75A of the *Stamp Act 1921*.

 - 5.15.3 Council shall require subdivision and development to have regard to, and be generally consistent with Local Planning Policy: Old Swanbourne Hospital Precinct;
 - 5.15.4 Notwithstanding the provisions of Table 1: Use Class Table, and in accordance with the Development Plan referred to in 5.15(a), the following uses are 'AA'
 - i. Caretakers Dwelling
 - ii. Carpark

 - vi. Dwelling House—Single

 - 5.15.5 Prior to Council considering any application for subdivision and/or development on the site, in accordance with clause 3.8 of the Scheme, the applicant shall submit an Outline Development Plan for the approval of the Council, in consultation with the Heritage Council of Western Australia;
 - 5.15.6 Prior to Council considering any application for subdivision and/or development on the site, a revised Conservation Plan for the site shall be completed to the satisfaction of the Heritage Council of Western Australia in accordance with the Government Heritage Property Disposal Process;
 - 5.15.7 Prior to Council considering any application and/or development on the site, a Heritage Agreement shall be completed to the satisfaction of the Heritage Council of Western Australia in accordance with the Government Heritage Property Disposal Process;
 - 5.15.8 Any application for subdivision and/or development shall have due regard for the revised Conservation Plan for the site and shall demonstrate the conservation of the existing heritage buildings to the satisfaction of the Heritage Council of Western Australia.

APPROVED TOWN PLANNING SCHEME AMENDMENT

Shire of Serpentine-Jarrahdale

Town Planning Scheme No. 2—Amendment No. 134

Ref: 853/2/29/3 Pt 134

It is hereby notified for public information, in accordance with section 7 of the Town Planning and Development Act, 1928 (as amended) that the Minister for Planning and Infrastructure approved the Shire of Serpentine-Jarrahdale town planning scheme amendment on 2 November 2005 for the purpose of—

- 1 Rezoning Pt Lot 7 Thomas Road, Byford from Urban Development to Rural Living 'A' Zone as depicted on the Scheme Amendment Map; and
- 2 Amending Appendix 4A of the Scheme to include special provisions relating to the Rural Living 'A' zone described hereunder—

(a) SPECIFIED AREA OF LOCALITY

Pt Lot 7 Thomas Road, Byford.

SPECIAL PROVISIONS

Within the Rural Living A zone the following land uses are permitted, or are permitted at the discretion of the Council.

Use classes permitted (P)

Single House

Public Recreation

Public Utility

Discretionary Uses (AA)

Ancillary Accommodation

Home Occupation

Stables

All other uses are prohibited.

In exercising its discretion in respect to AA uses, the Council having regard to the Planning Guidelines for Nutrient Management contained in the Shire of Serpentine-Jarrahdale Rural Strategy shall only permit such uses when it is satisfied following consultation with Government agencies that the land use does not involve excessive nutrient application or clearing of land.

- 2 The applicant making arrangements with and to the satisfaction of the Water Corporation of Western Australia for the provision of reticulated sewerage to all lots within the subdivision.
- 3 The applicant making arrangements with and to the satisfaction of the Water Corporation of Western Australia for the provision of reticulated water to all lots within the subdivision.
- 4 No indigenous vegetation and trees shall be destroyed or cleared except, but subject to the developer of the estate/landowner obtaining the prior consent of the Council in writing, where such vegetation is dead, diseased or where the clearing is required for the purpose of a firebreak, dwelling, outbuilding, fence, drainage systems, driveways and/or to accommodate the discretionary uses identified under Provision 1.
- The subdivider shall, in accordance with the endorsed Subdivision Guide Plan prepare a Schedule of Landscaping for this estate and plant indigenous trees and shrubs of a species and a density and distribution to the satisfaction of the Council prior to the transfer of a lot(s) to a new owner.
- 6 The subdivider shall either maintain the trees and shrubs planted until the land is sold, or shall plant sufficient numbers of trees and

- shrubs to allow for natural loss. Thereafter, the owners of the subdivided lots shall be responsible for the maintenance and replacement (if and where necessary) of those trees and shrubs planted by the subdivider to the satisfaction of the Council.
- The subdivider shall prepare and implement a Fire Management Plan that identifies and implements the construction requirements relative to strategic firebreaks, water supplies and equipment and any other fire management requirements that may be deemed necessary, to the specification and satisfaction of the Council and the Fire and Emergency Services.
- 8 Notwithstanding the obligations of the subdivider under Clause 5.12.9e of the Scheme, the subdivider shall drain the land and provide detention areas in accordance with a Drainage Concept Plan approved by the Shire and the Department of Environment, provided prior to the commencement of the on-ground-works. Those easements and reserves required by Council or the Water Corporation shall be provided to the Council or the Water Corporation at the time of subdivision to provide for the ongoing maintenance of the drainage system components.
- 9 At the time of the building application for each lot, a plan of the site shall be submitted by the applicant to the satisfaction and specifications of the Council which shall show site contours, existing trees and stands of vegetation, those trees and vegetation to be removed and retained, and proposals for tree planting and maintenance.
- The Council shall not support any application for subdivision of the land into Rural Living A lot sizes unless the subdivision is consistent with a Subdivision Guide Plan endorsed by Council and the Commission for whole or part of the area.
- A Subdivision Guide Plan for the subdivision of land into Rural Living A lot sizes, shall have regard to the objectives set out in this Scheme for the zone or zones affected by it, and the requirements of Clause 5.9.3.
- The Subdivision Guide Plan referred to in Clause 11 shall include and be accompanied by Technical Guidelines that provide a prescription for development and the implementation of subdivision in areas of planning, roadworks, drainage, effluent disposal, water, bushfire control, protection of the environment, landscaping, easements, landowner coordination, infrastructure cost sharing, controlling developments, or generally regulating or prescribing the use of development of land to overcome problems which would occur, should the land be developed.
- Multiple use trails shall be constructed to the satisfaction of the local authority by the subdivider in accordance with the Subdivision Guide Plan.
- Direct vehicle access is to be restricted in accordance with the endorsed Subdivision Guide Plan with the exception of horse float access via the unmade road reserve to the rear of the lots.

- The effective buffer between the stables on the 4,000 square metre Rural Living A lots providing the buffer to the Byford Trotting Complex is to be not less than 100 metres (including the road reserve) to the southern boundaries of the Urban Development to the north.
- The proposed multiple use trail at the rear of the 4,000 square metre Rural Living A lots providing the buffer to the Byford Trotting Complex is to be retained as an unmade road reserve and may be utilized for access by horse floats to the lots.
- The drainage system is to be designed to maximise infiltration of roof and hard surfaces runoff as close to source as possible. Piped networks, where installed, are to be kept as small as practicable and incorporate gross pollutant and sediment trapping devices prior to outfall to infiltration areas incorporated into Public Open Space or Multiple Use Corridors.
- The subdivider may be required to place a notification on the title of each lot advising potential purchasers that their property is located within an area that has been recognised as posing a "moderate to low" acid sulfate soils risk. Therefore, any proposal that may lead to the disturbance of acid sulphate soils associated with future development of the site should be planned and managed to avoid adverse effects on the natural and built environment, including human health and activities.
- 19 The subdivider is to place a notification on the title of each lot advising potential purchasers that their property is located within the Serpentine Groundwater Area and a groundwater licence will be required before any abstraction can commence.
