#### LOCAL LAW RELATING TO SIGNS AND OTHER ADVERTISING DEVICES AMENDMENT LOCAL LAW 2005

Under the powers conferred by the *Local Government Act 1995* as amended from time to time and under all other powers enabling it, the Council of the Shire of Busselton resolved on the 14th day of December 2005 to make the following amendments to the Local Law Relating to Signs and other Advertising Devices as published in the *Government Gazette* on 9 February 2004.

### 1 Preamble Amended

In the preamble, delete the words "Local Government Model By-Laws (Signs, Hoardings and Billposting) No 13, published in the *Government Gazette* 11 June 1964", and substitute the words "Adoption of Draft Model By-laws Relating to Signs, Hoardings and Billposting. as published in the *Government Gazette* on 29 August 1963, and the amendment By-laws Relating to Signs, Hoardings and Billposting as published in the *Government Gazette* on 22 July 1983".

#### 2 PART I-CITATION AND INTERPRETATION

# Licence Exemption (CSBP) Order 2006

### 1. Citation

This order may cited as the *Licence Exemption (CSBP) Order* 2006.

# 2. Commencement

This order comes into operation on the day after the day on which it is published in the *Gazette*.

## 3. Definitions

In this order —

- "water" means water taken pursuant to a licence under section 5C of the *Rights in Water and Irrigation Act 1914*.
- "Goldfields/South West Region Controlled Area" means the Goldfields/South West Region Controlled Area (Water Supply and Sewerage Services) constituted by the Goldfields/South West Region Controlled Area (Water Supply and Sewerage Services) Order 1999;
- "CSBP" means CSBP Limited (ABN 81 008 668 371) and its successors and assigns;
- "Tiwest" means Tiwest Pty Ltd (ABN) 59 009 343 364) and its successors and assigns.

# 4. Revocation

The *Licence Exemption (Wesfarmers CSBP) Order 2003* is revoked.

# 5. Exemption

CSBP is exempted from the requirement in section 18(1) of the Act for an operating licence (water supply services) in respect of the supply of water to Tiwest at Kwinana in the Goldfields/South West Region Controlled Area pursuant to a valid water supply contract being in force between CSBP and Tiwest.

# 6. Expiry

This order continues in force until revoked.

### FISH RESOURCES MANAGEMENT ACT 1994

WEST COAST ROCK LOBSTER FISHERY MANAGEMENT PLAN AMENDMENT (NO. 2) 2006

### HERITAGE OF WESTERN AUSTRALIA ACT 1990

#### REMOVAL OF AN ENTRY IN THE REGISTER OF HERITAGE PLACES

In accordance with the requirements of Section 54 (5)(b) of the *Heritage of Western Australia Act* 1990, (the Act) the Heritage Council gives notice that the entry in the Register on a permanent basis in relation to the Place being "Crawshaw's House" at 116 Broome Street, Perth, has been removed from the Register pursuant to a direction from the Minister for Heritage under section 54(1)(b) of the Act.

The reason for the removal is that the Development Committee of the Heritage Council determined that retention of the place was not feasible or prudent. 
