MACKEREL FISHERY (INTERIM) MANAGEMENT PLAN 2004

Clause 10(2)

I, Peter Rogers, Executive Director, Department of Fisheries Western Australia, pursuant to clause 10(2) of the Mackerel Fishery (Interim) Management Plan 2004 hereby give notice that notwithstanding the provisions of clauses 10(1)(a) and 10(1)(b) of the Mackerel Fishery (Interim) Management Plan 2004, I consider it to be in the better interests of the Fishery to permit fishing in Area 1 of the Fishery at the times specified in Schedule 1 and in Area 2 of the Fishery at the times specified in Schedule 2.
