Fair Trading Act 1987

Fair Trading (Product Safety Standard) Amendment Regulations 2006

Made by the Governor in Executive Council.

1. Citation

These regulations are the Fair Trading (Product Safety Standard) Amendment Regulations 2006.

2. The regulations amended

The amendments in these regulations are to the *Fair Trading* (*Product Safety Standard*) Regulations 2001*.

3. Parts 16 and 17 inserted

After Part 15 the following Parts are inserted —

Part 16 — Child carrying seats for bicycles

40. Interpretation

In this Part —

"child carrying seat" means a seat attached or capable of being attached to a bicycle and which is principally designed to carry a child as a passenger on the bicycle.

41. Instructions and load labelling

- (1) Every child carrying seat must when supplied
 - (a) be accompanied by instructions for correct fitting to a bicycle
 - (i) printed on the packaging of the seat; or
 - (ii) printed on a leaflet accompanying the seat,

unless it is an integral part of a bicycle; and

- (b) be clearly labelled with a statement of the maximum load which it is designed to carry
 - (i) printed on the seat;
 - (ii) printed on the packaging of the seat; or
 - (iii) printed on a leaflet accompanying the seat.
- (2) This regulation does not apply to the supply of a second-hand child carrying seat.

42. Design

Every child carrying seat must be designed —

- (a) for location immediately behind the seat of the rider;
- (b) so that the occupant of the seat faces towards the front of the bicycle;
- (c) to incorporate a foot rest for the occupant;
- (d) to incorporate a restraining device which is an integral part of the seat comprising a webbed seat belt manufactured from high tenacity synthetic fibre and a buckling device for securing the restraint, which cannot be easily or accidentally released by the occupant of the seat; and
- (e) to be constructed without sharp edges and to be attached to a tubular metal support by which it can be securely fastened to the bicycle frame.

Part 17 — Bean bags

43. Interpretation

In this Part —

- "bean bag" means a cushion or similar item which consists of a bag or cover surrounding the bean bag filling and includes bean bags for use in swimming pools;
- "bean bag cover" means a bag or cover capable of being filled with bean bag filling and which, if filled with bean bag filling, would constitute a bean bag and includes a bag or cover intended as a separate inner lining for a bean bag;
- "bean bag filling" means pellets, or small particles, of polystyrene or other similar synthetic material;
- "child-resistant slide-fastener" means a slide-fastener having a sliding piece which
 - (a) does not have attached to it any tag, handle or other object which would facilitate the movement of the sliding piece; and
 - (b) incorporates a locking mechanism, which prevents the sliding piece opening the slide-fastener unless a wholly separate device is used to disengage the locking mechanism and act as a handle in the moving of the sliding piece between the teeth;
- "slide-fastener" means a device comprising 2 sets of teeth, each set of teeth being located on adjacent edges of the device and having an attached sliding piece, which by moving between the adjacent teeth

of each edge, causes the teeth to interlock, or cease to interlock, as the case may be, with the teeth of the adjacent edge.

44. Requirements for bean bags

(1) Bean bags, bean bag covers and packages of every description containing bean bag filling must have fixed securely to or stamped on them a label or notice in the following form —

"WARNING: Small Lightweight Beads Present a Severe Danger to Children if Swallowed or Inhaled".

- (2) In the label or notice
 - (a) "WARNING" must appear in upper case red letters of not less than 5 mm in height, on a white background;
 - (b) "Small Lightweight Beads Present a Severe Danger to Children if Swallowed or Inhaled", must appear in upper and lower case letters as the case may be, with the upper case letters of not less than 5 mm in height.
- (2) The label or notice must be displayed on the goods in a conspicuous position.
- (3) Every bean bag and every bean bag cover must have a child-resistant slide-fastener fitted to every opening through which bean bag filling can be inserted or removed.

8B. Prescribed records (s. 76N) — exempt vehicles

(1) For the purposes of section 76N, the following records are prescribed for each vehicle in respect of which

section 76D(4), (5) or (5a) applies to the grant or transfer of the licence for the vehicle to a dealer —

- (a) the date of the grant or transfer of the licence for the vehicle;
- (b) for each loan of the vehicle by the dealer described in section 76D(5a)
 - the date the loan of the vehicle commenced and the date the loan ceased;
 - (ii) the name of the charitable organisation, school or individual to which or whom the vehicle is loaned;
 - (iii) the purposes for which the vehicle is loaned;
 - (iv) a description of the vehicle, including type, make, model, licence plate number and engine number; and
 - (v) if the vehicle is loaned to an individual for a philanthropic purpose a copy of the Commissioner's approval of the philanthropic purpose.
- (2) The accuracy of the records for a vehicle is to be attested to by the dealer, and, if the vehicle is loaned as described in section 76D(5a), the person responsible for the vehicle while on loan.

Penalty: \$2 000.

(3) The records must be kept in an approved manner. Penalty: \$2 000.

SWAN RIVER TRUST ACT 1988

DELEGATION

Notice is hereby given the Swan River Trust ('the Trust') by resolution made on 6 February 2006 and acting pursuant to the provisions of section 26 of the Swan River Trust Act 1988 ('the Act') does hereby—

- A. Revoke its delegation notice of powers and functions to various eligible persons and bodies as detailed in a delegation notice published in a *Government Gazette* of 4 August 1998 (pages 3989—3990); and
- B. DELEGATES ITS FUNCTIONS as set out in below Schedules 1-4

A reference in this instrument to a function or a power of the Trust includes and extends to, without limitation or restriction, any of the powers privileges, authorities, discretions, duties and responsibilities vested in the or conferred upon the Trust by the Act or any other written law as the case requires.

SCHEDULE 1—FUNCTIONS DELEGATED TO GENERAL MANAGER

The Trust has resolved, subject to the conditions set out below, to delegate to the officer of the Department of Environment for the time being appointed as General Manager of the Swan River Trust ('the General Manager') the power to make decisions in relation to the following of its functions—

- 1.1 Power to provide advice on behalf of the Trust to the Minister for the Environment in relation to applications pursuant to clause 30A(1)a of the Metropolitan Region Scheme subject to—
 - the proposed development complying with Trust policies and adopted draft policies;
 - the proposal not being considered by the General Manager to be of a controversial nature or significant public interest and the Trust not having requested that the matter be brought before it.
- 1.2 Power to recommend approval to the Western Australian Planning Commission or to local government, of applications pursuant to clause 30A(1)b of the Metropolitan Region Scheme subject to—
 - the proposed development complying with Trust policies and adopted draft policies;
 - filling of the floodway not being required;
 - the proposal not being considered by the General Manager to be of a controversial nature or significant public interest and the Trust not having requested that the matter be brought before it.
- 1.3 Power to provide advice to planning authorities in relation to planning schemes and planning scheme amendments, local planning strategies, development concept plans and other similar documents subject to the advice being consistent with Trust policies and the *Environmental Protection (Swan and Canning Rivers) Policy 1997* and for the purpose of making proper provision for the reservation of river foreshores, protection of public use of land and waters or the protection of wildlife habitat.
- 1.4 Power to provide comment to the Environmental Protection Authority on Public Environmental Reviews and other similar documents or issues subject to the advice being consistent with Trust policies and the *Environmental Protection (Swan and Canning Rivers) Policy 1997* and for the purpose of making proper provision for the reservation of river foreshores, protection of public use of land and waters or the protection of wildlife habitat.
- $1.5\,$ Power to provide advice to the Western Australian Planning Commission in relation to applications to subdivide land subject to—
 - the proposed subdivision not being in conflict with Trust policies or the Environmental Protection (Swan and Canning Rivers) Policy 1997
 - proper provision being made for the setting aside of land on the river foreshore
 - the proposed subdivision being of a suitable form and consisting of suitable lot sizes to allow future development in accordance with Trust policies
- 1.6 Power to provide advice to the Western Australian Planning Commission in relation to the clearance of conditions of subdivision approval recommended by the Trust and to provide advice to the Western Australian Planning Commission in relation to minor amendments to approved subdivision applications, subject to the subdivision and subdivision works being consistent with any conditions recommended by the Trust.
- 1.7 Power to provide advice to the Western Australian Planning Commission in relation to the clearance of conditions of development approval recommended by the Trust in accordance with clause 30A(1)a of the Metropolitan Region Scheme, subject to the development being consistent with any conditions recommended by the Trust.

- 1.8 Power to provide advice to local government authorities in relation to the clearance of conditions of development approval recommended by the Trust in accordance with clause 30A(1)b of the Metropolitan Region Scheme, subject to the development being consistent with any conditions recommended by the Trust.
- 1.9 Power to direct cessation or removal of development contrary to SRT Act section 68(1).
- 1.10 Power to direct the removal of abandoned property under section 69 of the SRT Act.
- 1.11 Power to approve spectator events as set out in the SRT Regulations 1989 subject to-
 - appropriate conditions being imposed indemnifying the Trust against claims for liability and ensuring after event clean up of the site by the event organisers
 - the General Manager being satisfied that approval of the proposed event is not likely to be of a controversial nature.
- 1.12 Power to clear conditions of development approvals issued by the Minister for the Environment in accordance with Part V of the Act subject to the development complying with the approval and conditions issued.
- 1.13 Power to provide advice to the Minister, or persons or bodies advising the Minister in relation to submissions on applications to be determined by the Minister in accordance with Part V of the Act or clause 30A(1)a of the Metropolitan Region Scheme subject to such advice being explanatory and in accordance with any prior resolution of the Trust concerning the matter.
- 1.14 Authorisation to deal with day to day correspondence, advice and information concerning the functions and roles of the Trust.
- 1.15 Power to approve the allocation of funding to implement projects or sub-programs in accordance with environmental management programs subject to the proposed project or sub-program meeting the requirements for inclusion in projects approved in an annual Swan River Trust Business Plan.

SCHEDULE 2—FUNCTIONS DELEGATED TO THE DEVELOPMENT AND REGULATION COMMITTEE

The Trust has resolved, subject to the conditions set out below, to delegate to the Development and Regulation Committee ('the Committee') the power to make decisions in relation to the following of its functions—

- 2.1 Power to provide advice on behalf of the Trust to the Minister for the Environment in relation to applications subject to clause 30A(1)a of the Metropolitan Region Scheme subject to the proposal not being considered by the Committee to be of significant public interest or of a controversial nature and the Trust not having requested that the matter be brought before it.
- 2.2 Power to recommend approval or refusal to the Western Australian Planning Commission or to local government of applications pursuant to clause 30A(1)b of the Metropolitan Region Scheme subject to the proposal not being considered by the Committee to be of a controversial nature or significant public interest and the Trust not having requested that the matter be brought before it.
- 2.3 Power to provide advice to planning authorities in relation to planning schemes and planning scheme amendments, local planning strategies, development concept plans and other similar documents.
- 2.4 Power to provide comment to the Environmental Protection Authority on Public Environmental Reviews and other similar documents or issues.
- 2.5 Power to provide advice to the Western Australian Planning Commission in relation to applications to subdivide land subject to the proposal not being considered by the Committee to be of significant public interest or of a controversial nature and the Trust not having requested that the matter be brought before it.
- 2.6 Power to provide advice to the Western Australian Planning Commission in relation to the clearance of conditions of subdivision approval recommended by the Trust and to provide advice to the Western Australian Planning Commission in relation to minor amendments to approved subdivision applications.
- 2.7 Power to clear conditions of development approvals issued by the Minister for the Environment in accordance with Part V of the Act.
- 2.8 Power to direct cessation or removal of development contrary to SRT Act section 68(1).
- 2.9 Power to direct the removal of abandoned property under section 69 of the SRT Act.
- 2.10 Power to approve spectator events as set out in the SRT Regulations 1989 subject to appropriate conditions being imposed indemnifying the Trust against claims for liability and ensuring after event clean up of the site by the event organisers.

SCHEDULE 3—FUNCTIONS DELEGATED TO THE

PARK AND RIVER PLAN COMMITTEE

- 4.2 Power to recommend approval or refusal to the Western Australian Planning Commission or to local government of applications pursuant to clause 30A(1)b of the Metropolitan Region Scheme subject to the proposal not being considered by the Chairman to be of a controversial nature or significant public interest and the Trust not having requested that the matter be brought before it.
- 4.3 Power to provide advice to planning authorities in relation to planning schemes and planning scheme amendments, local planning strategies, development concept plans and other similar documents.
- 4.4 Power to provide comment to the Environmental Protection Authority on Public Environmental Reviews and other similar documents or issues.
- 4.5 Power to provide advice to the Western Australian Planning Commission in relation to applications to subdivide land subject to the proposal not being considered by the Chairman to be of significant public interest or of a controversial nature and the Trust not having requested that the matter be brought before it.
- 4.6 Power to provide advice to the Western Australian Planning Commission in relation to the clearance of conditions of subdivision approval recommended by the Trust and to provide advice to the Western Australian Planning Commission in relation to minor amendments to approved subdivision applications.
- 4.7 Power to clear conditions of development approvals issued by the Minister for the Environment in accordance with Part V of the Act.
- 4.8 Power to direct cessation or removal of development contrary to SRT Act section 68(1).
- 4.9 Power to direct the removal of abandoned property under section 69 of the SRT Act.
- 4.10 Power to approve spectator events as set out in the SRT Regulations 1989 subject to appropriate conditions being imposed indemnifying the Trust against claims for liability and ensuring after event clean up of the site by the event organisers.
- 4.11 Power to approve the allocation of funding to implement projects or sub-programs in accordance with environmental management programs subject to the proposed project or sub-program meeting the requirements for inclusion in projects approved in an annual Swan River Trust Business Plan.

Interpretations

For the purposes of this notice, terms used shall have the same meanings as those assigned to them in the Swan River Trust Act 1988. Nothing in this notice should be interpreted as obliging the Chairman, General Manager or a Committee to whom powers have been delegated, to exercise those powers in any instance. The exercising of such powers is entirely at the discretion of the Chairman, General Manager or Committee.
