I, the Governor, acting under Section 13 of the Main Roads Act 1930 and on the recommendation of the Commissioner of Main Roads, declare—

- (a) that the sections of roads as shown on the drawings listed in Schedule 1 to this proclamation, excluding any footpaths, shall be highways as from and including 1 May 2006;
- (b) that the sections of roads as shown on the drawings listed in Schedule 2 to this proclamation shall cease to be highways as from and including 1 May 2006;
- (c) that the sections of roads as shown on the drawings listed in Schedule 3 to this proclamation, excluding any footpaths, shall be main roads as from and including 1 May 2006;
- (d) that the sections of roads as shown on the drawings listed in Schedule 4 to this proclamation shall cease to be main roads as from and including 1 May 2006.
