Firearms (Licence Exemption) Notice 2006

(1) In subclause (2) —

"police force" means —

- (a) the police force of another State or of a Territory; or
- (b) the Australian Federal Police.
- (2) Each police force is specified for the purposes of section 8 of the Act in respect of the possession by a member of that police force of a firearm or ammunition for use in the performance of the member's duties as
 - (a) a special constable under the *Police Act 1892* section 35A; or
 - (b) a special officer under the *Terrorism (Extraordinary Powers) Act 2005* section 17.
- (3) Subclause (2) does not limit the *Firearms (Licence Exemption) Notice 1985.*

Acting pursuant to the powers conferred by Regulation 48A of the Navigable Waters Regulations, the department by this notice defines and sets aside the following area of Navigable Water for the purpose of Water Skiing—

Mount Pleasant: On Mondays to Fridays (not including public holidays), all the waters of the Canning River between a line drawn from Deep Water Point due east to the Manning foreshore and a line drawn between points 115° 52.331'E, 32° 1.892'S and 115° 52.331'E, 32° 1.740'S (due north-south roughly 140 metres downstream of Salter Point) but so that no boat or skier shall approach within 60 metres of the foreshore except on—

- the west bank between Deep Water Point and Queens Road,
- the water ski take-off area on the Manning foreshore which commences from a point on the foreshore 73 metres south of the prolongation of the southern side of Edgewater Road and extending for 100 metres in a southerly direction along the foreshore.

No water ski take-off or landing shall be permitted on the Manning foreshore except from the designated water ski take-off area.

All water skiing within this area shall be in an anti-clockwise direction and no person shall engage in water skiing except between the hours of 0900 and sunset.
