Electricity Transmission and Distribution Systems (Access) Act 1994

Electricity Transmission Amendment Regulations (No. 2) 2006

Made by the Governor in Executive Council.

1. Citation

These regulations are the *Electricity Transmission Amendment Regulations (No. 2) 2006*.

2. Commencement

(1) These regulations come into operation at the time at which the first trading day under the market rules commences.

(2) In subregulation (1) —

“**market rules**” means the market rules made under the *Electricity Industry Act 2004* Part 9.

Note: The market rules require the Minister for Energy to publish in the *Gazette* the time at which the first trading day commences.

3. The regulations amended

The amendments in these regulations are to the *Electricity Transmission Regulations 1996**.

4. Regulation 3 amended

Regulation 3(1) is amended as follows:

Electricity Transmission and Distribution Systems (Access) Act 1994

Electricity Distribution Amendment Regulations (No. 2) 2006

Made by the Governor in Executive Council.

1. Citation

These regulations are the *Electricity Distribution Amendment Regulations (No. 2) 2006*.

2. Commencement

- (1) Except as stated in subregulation (2), these regulations come into operation on the day on which they are published in the *Gazette*.

- (2) Regulations 4(b) and 5 to 9 come into operation at the time at which the first trading day under the market rules commences.
- (3) In subregulation (2) —
 “market rules” means the market rules made under the
 Electricity Industry Act 2004 Part 9.

Note: The market rules require the Minister for Energy to publish in the *Gazette* the time at which the first trading day commences.

CONSERVATION AND LAND MANAGEMENT ACT 1984

(Section 14)

PROPOSAL TO RESERVE WESTERN AUSTRALIAN WATERS

Proposed Walpole and Nornalup Inlets Marine Park.

Notice is hereby given under section 14 of the *Conservation and Land Management Act 1984* (CALM Act) of a proposal to reserve Western Australian waters under section 13(1) of the CALM Act as a marine park in the waters of the Walpole and Nornalup Inlets. Notice is also given that it is proposed that the proposed marine park will be classified as Class A.

Any person may make a written submission on this proposal and all persons with an interest in the proposal are encouraged to do so.

Marine parks are created to protect natural features and aesthetic values while at the same time enabling recreational and commercial uses where these activities do not compromise conservation values (the statutory purpose of marine parks is provided in CALM Act section 13B(1)).

The proposed Walpole and Nornalup Inlets Marine Park comprise the waters of the State, including the airspace above those waters and sea-bed to a depth of 200 metres below those waters, bounded by the coordinates described below.

The boundary of the proposed Walpole and Nornalup Inlets Marine Park follows the shoreline of both inlets and the shorelines of the Frankland River to Monastery Landing, the Deep River to the Bibbulmun Track swing-bridge and the Walpole River to the South Coast highway bridge. The boundary extends to low water mark where it is adjacent to the boundary of the Walpole-Nornalup National Park, and elsewhere to high water mark. The ocean boundary is delineated by a line of longitude at 116° 44' 15" East.

All geographic coordinates are expressed in terms of the Geocentric Datum of Australia 1994 (GDA94). High Water Mark (HWM) is the ordinary (mean of) high water mark at spring tides as defined by the *Land Administration Act 1997*. Western Australia's coastal waters are defined by the *Coastal Waters (State Powers) Act 1980*.

An indicative management plan has been prepared outlining how the proposed Walpole and Nornalup Inlets Marine Park would be managed. This plan includes a map and details of the proposed boundaries, zoning and management strategies for the proposed reserve.

Under CALM Act Section 62 (1a), the proposed Walpole and Nornalup Inlets Marine Park is intended to be classified as recreation area in its entirety. The following activities are considered to be incompatible with the purpose of this management zone: all commercial fishing activities; aquaculture; mineral and petroleum drilling and development; recreational netting; spearfishing; and the discharge of boat sewage.

SCHOOL EDUCATION ACT 1999

DECLARATION OF LOCAL-INTAKE AREAS FOR SCHOOLS WITH SECONDARY STUDENTS AFFECTED BY THE ESTABLISHMENT OF PERTH MODERN SCHOOL AS A CENTRE OF EXCELLENCE

(Pursuant to Sections 60, 78, 79 and 80)

The Hon. Minister for Education has declared that the local-intake areas for the secondary schools listed hereunder shall be as stated in this notice. Children of compulsory school age who reside within the local-intake areas of the following secondary schools shall be entitled to attend the schools to which such local-intake areas apply if there is an appropriate educational program for them at that school. The local-intake area of a secondary school may be defined in this notice by listing the names of the contributory primary schools, the local-intake areas and the traditional catchment areas of which, when amalgamated, constitute the local-intake area of that secondary school. Children who reside outside these local-intake areas may apply to attend the schools to which such local-intake areas apply.

Note: The local-intake areas of the following public secondary schools have been changed due to the proposed establishment of Perth Modern School as a centre of academic excellence. Parents have been advised by school newsletters that admission to Perth Modern School from the end of Semester 1, 2006 will be based on a rigorous academic selection process.

BALCATT A SENIOR HIGH SCHOOL

The local-intake area for this school is defined by the local-intake areas of the following primary schools: Balcatta, Takari, West Balcatta and Yuluma, the traditional catchment areas of Lake Gwelup and Osborne Primary Schools and the following exception. Children resident within the traditional catchment area of Osborne Primary School and resident in Main Street (both sides) and west thereof are entitled to attend Balcatta Senior High School. Children resident within the traditional catchment area of Osborne Primary School and resident in the area east of Main Street are entitled to attend either Balcatta Senior High School or Mirrabooka Senior High School.

The following defines an optional area between Carine Senior High School and Balcatta Senior High School—

From the intersection of the Mitchell Freeway and the Reid Highway, south along the Mitchell Freeway to Erindale Road, east along Erindale Road to Boya Way, south along Boya Way to Odin Road, south along Odin Road and its extension to the Mitchell Freeway, south and south east along the Mitchell Freeway to a point due east of the southern arm of Birrale Loop, west from this point between the southern arm of Birrale Loop and Hertha Place to Odin Road, south along Odin Road to Barnes Street, west along Barnes Street to Huntriss Road, north along Huntriss Road and its northern extension through Lake Karrinyup to North Beach Road, west along North Beach Road to Okley Road, north along Okley Road to the Reid Highway and east along the Reid Highway to the Mitchell Freeway. The boundary parts of the Mitchell Freeway (both sections, west side), Erindale Road south side), Boya Way (south side), Odin Road (east of Freeway section, west side), Birrale Loop (southern arm, both sides), Odin Road (west of Freeway section, west side), Barnes Street (north side), North Beach Road (north side) and Reid Highway (south side)

are included with this optional area. The boundary parts of Hertha Place (both sides), Huntriss Road (both sides) and Okley Road (both sides) are excluded from this optional area.

The following defines an optional area between the Churchlands Senior High School and Balcatta Senior High School—

From the intersection of Sackville Terrace and Holbeck Street, east along Sackville Terrace and Barnes Street to Odin Road, north along Odin Road to the southern arm of Birrale Loop, east between the southern arm of Birrale Loop and Hertha Place to the Mitchell Freeway, south and south east along the Mitchell Freeway to Scarborough Beach Road, north west along Scarborough Beach Road to Holbeck Street and north along Holbeck Street to Sackville Terrace. The boundary parts of the Sackville Terrace (south side), Barnes Road (south side), Odin Road (east side), Hertha Place (both sides), Mitchell Freeway (west side) and Scarborough Beach Road (north side) are included with this optional area. The boundary parts of Birrale Loop (both sides) and Holbeck Street (both sides) are excluded from this optional area.

CARINE SENIOR HIGH SCHOOL

The following defines the local-intake area of this school—

From a point on the Indian Ocean coastline due west of the junction of West Coast Highway and West Coast Drive, east from this point to the junction of West Coast Highway and West Coast Drive, north east along West Coast Highway to Karrinyup Road, east and south east along Karrinyup Road to Huntriss Road, north along Huntriss Road and its northern extension through Lake Karrinyup to North Beach Road, west along North Beach Road to Okley Road, north along Okley Road to the Reid Highway, east along the Reid Highway to the Mitchell Freeway, north along the Mitchell Freeway to Warwick Road, west along Warwick Road to Marmion Avenue, south along Marmion Avenue to Freeman Way, west along Freeman Way to High Street, and west along High Street and its extension to the Indian Ocean, and south along the coastline to a point on the Indian Ocean coastline due west of the junction of West Coast Highway and West Coast Drive.

The boundary parts of West Coast Highway (north side), Karrinyup Road (north side), Huntriss Road (both sides), North Beach Road (south side), Okley Road (both sides), Reid Highway (north side), Mitchell Freeway (west side), Warwick Road (south side), Marmion Avenue (east side), Freeman Way (south side) and High Street (south side) are included within the local-intake area of this school.

The following defines an optional area between Carine Senior High School and the Churchlands Senior High School—

From a point on the Indian Ocean coastline due west of the junction of West Coast Highway and West Coast Drive, east from this point to the junction of West Coast Highway and West Coast Drive, north east along West Coast Highway to Karrinyup Road, east and south east along Karrinyup Road to Huntriss Road, south along Huntriss Road to Sackville Terrace, west along Sackville Terrace to Holbeck Street, south along Holbeck Street to Scarborough Beach Road, north west and west along Scarborough Beach Road and its western extension to the coastline and north along the coastline to a point on the coastline due west of the junction of West Coast Highway and West Coast Drive. The boundary parts of West Coast Highway (south side), Karrinyup Road (south side), Huntriss Road (both sides), Sackville Terrace Street (north side), Holbeck Street (both sides) and Scarborough Beach Road (north side) are included within this optional area.

The following defines an optional area between Carine Senior High School and Balcatta Senior High School—

From the intersection of the Mitchell Freeway and the Reid Highway, south along the Mitchell Freeway to Erindale Road, east along Erindale Road to Boya Way, south along Boya Way to Odin Road, south along Odin Road and its extension to the Mitchell Freeway, south and south east along the Mitchell Freeway to a point due east of the southern arm of Birrale Loop, west from this point between the southern arm of Birrale Loop and Hertha Place to Odin Road, south along Odin Road to Barnes Street, west along Barnes Street to Huntriss Road, north along Huntriss Road and its northern extension through Lake Karrinyup to North Beach Road, west along North Beach Road to Okley Road, north along Okley Road to the Reid Highway and east along the Reid Highway to the Mitchell Freeway. The boundary parts of the Mitchell Freeway (both sections, west side), Erindale Road south side, Boya Way (south side), Odin Road (east of Freeway section, west side), Birrale Loop (southern arm, both sides), Odin Road (west of Freeway section, west side), Barnes Street (north side), North Beach Road (north side) and Reid Highway (south side) are included with this optional area. The boundary parts of Hertha Place (both sides), Huntriss Road (both sides) and Okley Road (both sides) are excluded from this optional area.

CHURCHLANDS SENIOR HIGH SCHOOL

The following defines the local-intake area of Churchlands Senior High School—

From a point on the Indian Ocean coastline due west of the junction of West Coast Highway and Rochdale Road, east from the coastline to this junction, north along West Coast Highway to Oceanic Drive, east along Oceanic Drive and its extension into Cambridge Street, east along Cambridge Street to Gregory Street, north along Gregory Street to the junction with Wise Street, east from this junction through Lake Monger to the Mitchell Freeway, north west along the Mitchell Freeway to Scarborough Beach Road, north west and west along Scarborough Beach Road and its western extension to the coastline, and south along the coastline to a point due west of the junction of West Coast Highway and Rochdale Road.

The boundary parts of West Coast Highway (west side), Oceanic Drive (north side), Cambridge Street (north side), Gregory Street (both sides), Mitchell Freeway (west side) and Scarborough Beach Road (south side) are included within the local-intake area of this school.

The following defines an optional area between Churchlands Senior High School and Carine Senior High School—

From a point on the Indian Ocean coastline due west of the junction of West Coast Highway and West Coast Drive, east from this point to the junction of West Coast Highway and West Coast Drive, north east along West Coast Highway to Karrinyup Road, east and south east along Karrinyup Road to Huntriss Road, south along Huntriss Road to Sackville Terrace, west along Sackville Terrace to Holbeck Street, south along Holbeck Street to Scarborough Beach Road, north west and west along Scarborough Beach Road and its western extension to the coastline and north along the coastline to a point on the coastline due west of the junction of West Coast Highway and West Coast Drive. The boundary parts of West Coast Highway (south side), Karrinyup Road (south side), Huntriss Road (both sides), Sackville Terrace (north side), Holbeck Street (both sides) and Scarborough Beach Road (north side) are included within this optional area.

The following defines an optional area between Balcatta Senior High School and Churchlands SHS—

From the intersection of Sackville Terrace and Holbeck Street, east along Sackville Terrace and Barnes Street to Odin Road, north along Odin Road to the southern arm of Birrale Loop, east between the southern arm of Birrale Loop and Hertha Place to the Mitchell Freeway, south and south east along the Mitchell Freeway to Scarborough Beach Road, north west along Scarborough Beach Road to Holbeck Street and north along Holbeck Street to Sackville Terrace. The boundary parts of the Sackville Terrace (south side), Barnes Road (south side), Odin Road (east side), Hertha Place (both sides), Mitchell Freeway (west side) and Scarborough Beach Road (north side) are included with this optional area. The boundary parts of Birrale Loop (both sides) and Holbeck Street (both sides) are excluded from this optional area.

The following defines an optional area between Churchlands Senior High School and Mirrabooka Senior High School—

From the intersection of the Mitchell Freeway and Scarborough Beach Road, east along Scarborough Beach Road to Green Street, east along Green Street to Wanneroo Road, north along Wanneroo Road to Roberts Street, west along Roberts Street to the Mitchell Freeway and south along the Mitchell Freeway to Scarborough Beach Road. The boundary parts of Scarborough Beach Road (north side), Green Street (north side) Wanneroo Road (west side) and the Mitchell Freeway (east side) are included within this option area. Roberts Street (both sides) is excluded from this option area.

The following defines an optional area between Churchlands SHS and Mount Lawley SHS—

From the intersection of the Mitchell Freeway and Scarborough Beach Road, east along Scarborough Beach Road to Green Street, continuing east along Green Street to London Street, south along London Street to Loftus Street, south along Loftus Street to the northern extension of Colin Place, south along this extension and south along Colin Place to Troode Street, east along Troode Street to Sutherland Street, south east and south along Sutherland Street to Wellington Street, west along Wellington Street to Thomas Street, north east along Thomas Street to the Perth-Fremantle railway line, generally west along the railway line to the Subiaco Railway Station, west from the railway station to Station Street (southern section), north along Station Street (southern section) to Salvado Road, west along Salvado Road to Station Street (northern section), north along Station Street (northern section) to Cambridge Street, west along Cambridge Street to Gregory Street, north along Gregory Street to the junction with Wise Street, east from this junction through Lake Monger to the Mitchell Freeway, north west along the Mitchell Freeway to Scarborough Beach Road.

The boundary parts of Scarborough Beach Road (south side), Green Street (south side), London Street (west side), Loftus Street (west side), Colin Place (both sides), Troode Street (both sides), Sutherland Street (southern and western sides), Wellington Street (north side), Thomas Street (east side), Station Street (southern and northern sections, east side), Salvado Road (north side), Cambridge Street (north side) and Mitchell Freeway (north east side). The boundary parts of Gregory Street (both sides) are excluded from this optional area.

The following defines an optional area between Churchlands Senior High School, Mount Lawley Senior High School and Shenton College—

From the junction of Roberts Road and Rokeby Road, north to the Subiaco Railway Station, north east and east along the railway line to Loftus Street, south west along Loftus Street and Thomas Street to Roberts Road, and west along Roberts Road to Rokeby Road. The boundary parts of Loftus Street (west side), Thomas Street (west side) and Roberts Road (north side) are included within this optional area.

MIRRABOOKA SENIOR HIGH SCHOOL

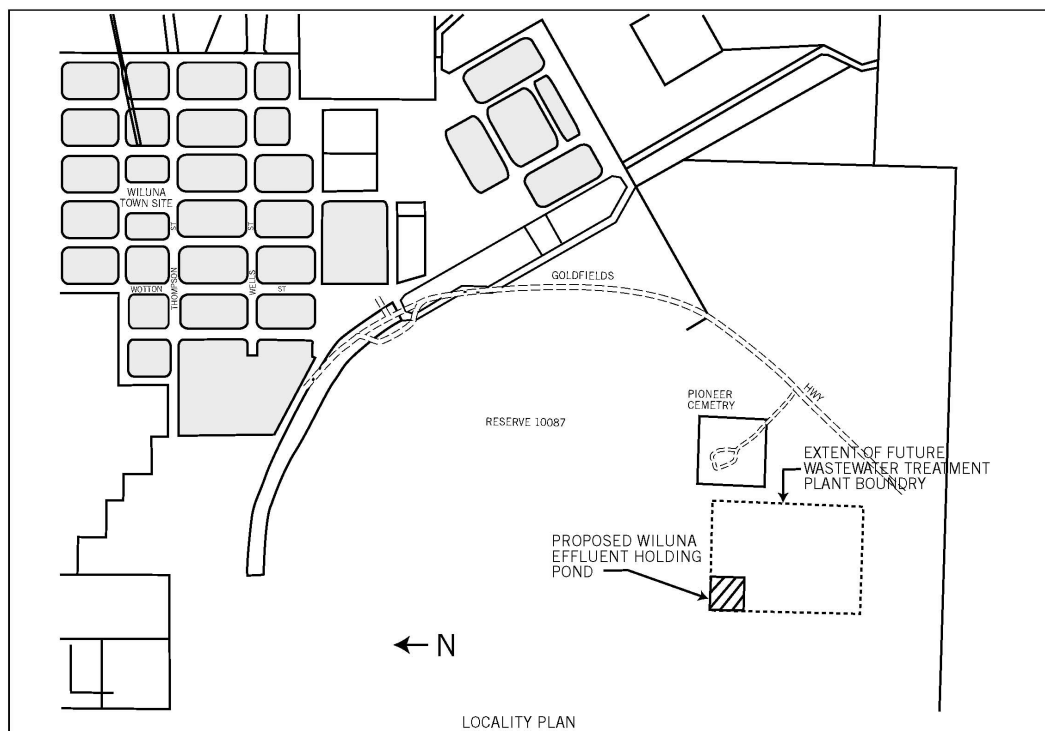
