EXEMPTION CERTIFICATE PURSUANT TO REGULATION 2.13

(No. 18 of 2006)

I, Wendy Clarkson, Director Reviews and Legal Services, WorkSafe Division, Department of Consumer and Employment Protection, having been delegated the WorkSafe Western Australia

Commissioner's power in regulation 2.13, hereby grant an exemption to Wanneroo Crane Hire Pty Ltd from the requirements of the following regulations of the Occupational Safety and Health Regulations 1996—

- Regulation 4.53(2)(a) through to Regulation 4.53(2)(e), inclusive; and
- Regulation 4.54(4)(c) insofar as it relates to the requirements of Section 6.18 of AS 2550.1 2002

insofar as the above require a person suspended from a crane to be accommodated in a workbox, and the requirements therefor, in relation to suspending an aerial performer, Dawn Strindberg, from a crane during the City of Wanneroo Agricultural Show held on 24 and 25 November 2006.

I further grant an exemption from the requirements of Regulation 4.54(3) in relation to the use of the crane in the abovementioned performance.

These exemptions are subject to the following conditions—

- The exemptions apply only to the use of a Linmac 14 tonne rated capacity crane, serial number 14009, WorkSafe registration number B16163;

- The crane operator shall remain at the controls of the crane at all times during the performance;
- The only crane motion permitted whilst a person is suspended from the crane hook is hoist up or down at slow speed;
- Suitable lighting is provided to enable the performer to see her equipment;
- The plant is suitably stabilised at all times during the performance;
- A means of lowering the person in the event of an emergency or failure of the power supply to the crane is provided; and
- A certificated rigger oversees the attachment of the lifting gear to the crane hook.

This exemption is valid on 24 and 25 November 2006 only.
