    - (a) the ticket produced to an authorised person is a ticket belonging to a person who is registered with the Authority as the owner of the ticket; and
    - (b) the owner has notified the Authority that the ticket has been lost or stolen,

the authorised person may retain the ticket.

".

(4) If the ticket produced to an authorised person is not valid under regulation 5(f) because it is not being used in accordance with a condition that it be used only by the person to whom it was issued, the authorised person may retain the ticket and return it to the person to whom it was issued.

1.1 Title

#### LOCAL GOVERNMENT ACT 1995 HEALTH ACT 1911

Town of Cambridge

AMENDMENT LOCAL LAW 2006

Under the powers conferred by the *Local Government Act 1995*, the *Health Act 1911* and all other powers enabling it, the Council of the Town of Cambridge decided to make the following local law on 25 July 2006.

#### PART 1-PRELIMINARY

This local law may be referred to as the Town of Cambridge Amendment Local Law 2006.

#### 1.2 Objective

The objective of this local law is to—

- (1) amend various clauses in the Town of Cambridge Local Government and Public Property, Trading in Public Places, Private Property, Animals and Health Local Laws to remove difficulties identified in their application and better clarify the requirements of the local laws.
- (2) amend various clauses in the Town of Cambridge Parking Local Law to make minor corrections to terminology, to introduce changes to provisions relating to parking on verges and increase modified penalties.

#### **1.3 Commencement**

This local law comes into operation 14 days after the date of its publication in the *Government Gazette*.

#### **1.4 Application**

This local law applies throughout the district.

#### PART 2—PARKING

#### 2. Amendment

The Town of Cambridge Parking Local Law published in the *Government Gazette* on Friday, 22 March 2002 is hereby amended in the following manner—

#### 2.1 Clause 1.5(1)

Amend the definition of the term "Code" by deleting the numerals "1975" and substituting the numerals "2000".

#### 2.2 Clause 4.8

Amend sub clause 4.8(2) by adding the words "unless parking is prohibited on the verge by a sign" after the words "on the verge".

#### 2.3 Clause 4.15

Amend sub clause 4.15(a) by deleting the words "for the purpose of exposing it for sale" and substituting the words "if that vehicle is exposed for sale".

#### 3. Amendment

"shark" "means all sharks except those species identified as totally protected fish in Schedule 2 Part 2 Division 2 of the Fish Resources Management Regulations 1995."

3.3 Clause 5.19

Delete Clause 5.19 Limit on liability.

#### **3.4 Clause 9.4**

Delete sub clause 9.4(a) and substitute the following sub clause—

"(a) repair and make good any damage to the verge treatment at such owner's or occupier's expense;"

#### PART 4—TRADING IN PUBLIC PLACES

#### 4. Amendment

The Town of Cambridge Trading in Public Places Local Law published in the *Government Gazette* on Friday, 22 March 2002 is hereby amended in the following manner—

#### 4.1 Clause 2.1

In the definition of the term "**trading**", delete the words "but does not include-", sub clauses 2.1(d) through to 2.1(g) and the words "which are sold directly to consumers and not through a shop.".

#### 4.2 Clause 5.4

Delete clause 5.4 Limit on liability.

#### 4.3 Clause 6.4

Amend sub clause 6.4(1) by deleting the words "Police Force" and substituting the words "Western Australia Police Service".

#### 4.4 Clause 6.7

Amend sub clause 6.7(2)(a) by deleting the words "or a boat" and "or the boat" where they appear.

#### PART 5—PRIVATE PROPERTY

#### 5. Amendment

The Town of Cambridge Private Property Local Law published in the *Government Gazette* on Friday, 22 March 2002 is hereby amended in the following manner—

#### 5.1 Clause 2.1

Amend sub clause 2.1(4) by deleting the reference to "Schedule 1" and substituting "Schedule 2".

5.2 Clause 2.5

Delete clause 2.5 Graffiti protection.

#### 5.3 Clause 2.6

Delete clause 2.6 Record of graffiti protection treatment.

#### 5.4 Clause 5.1

Delete sub clause 5.1(1) and substitute the following sub clause—

"(1) The owner or occupier of a lot shall not keep, or permit to remain on the lot, any refuse, rubbish or disused material of whatsoever nature or kind which in the opinion of the local government or an authorised person is likely to give the lot an unsightly appearance and does not conform with the general appearance of other land in that particular part of the district.".

#### 5.5 Clause 9.4

Delete clause 9.4 Limit on liability.

#### 5.6 Clause 9.5

Amend sub clause 9.5(1) by deleting the words "Police Force" and substituting the words "Western Australia Police Service".

#### 5.7 Schedule One

Amend Schedule One Offences and Modified Penalties as follows-

- 5.7.1 Delete Items 2.5(1), 2.5(2), 2.5(3) and 2.6.
- 5.7.2 Following the line item 8.4(1) insert a new line item as follows—

"Part 9" "Miscellaneous"

"9.5(2)" "Refusal to give name, date of birth or residential address or give false name, date of birth or residential address on a demand being made Modified Penalty \$100".

#### 6. Amendment

#### PART 6-ANIMALS

The Town of Cambridge Animals Local Law published in the *Government Gazette* on Friday, 22 March 2002 is hereby amended in the following manner—

#### 6.1 Clause 1.6

In the appropriate alphabetical position, insert the following definition-

**"small animal"** "means small animals kept as pets such as rabbits, ferrets, guinea pigs, rats, mice and any other domestic rodents;".

#### 6.2 Clause 5.10A

Following sub clause 5.10(e)(ii), insert a new clause 5.10A as follows-

#### "Keeping of small animals"

"5.10A A person who keeps a small animal or permits a small animal to be kept shall—

- (1) not permit that small animal to stray or to be at large in a street, public place or upon private property without the consent of the property owner;
- (2) ensure that the small animal is kept in a properly constructed and securely fastened structure or enclosure.".

#### 6.3 Clause 8.6

Delete clause 8.6 Limit on liability.

#### 6.4 Clause 8.7

Amend sub clause 8.7(1) by deleting the words "Police Force" and substituting the words "Western Australia Police Service".

#### 7. Amendment

#### PART 7—HEALTH

The Town of Cambridge Health Local Law 2001 published in the *Government Gazette* on Friday, 22 March 2002 is hereby amended in the following manner—

#### 7.1 Clause 1.5

7.1.1 Within sub clause 1.5(1), amend the definition of "Act" by deleting the words "and includes subsidiary legislation made under that Act".

7.1.2 In the appropriate alphabetical position insert the following definitions—

- "AS 1668.2:2002" "means the standard published by the Standards Association of Australia as AS 1668.2:2002 and called "The use of mechanical ventilation and air conditioning in buildings—Ventilation design for indoor-air contaminant control.".
- "AS 2001.1:1995" "means the standard published by the Standards Association of Australia as AS 2001.1:1995 and called "Methods of test for textiles—Conditioning procedures.".
- "AS/NZS 3666.2:2002" "means the standard published by the Standards Association of Australia as AS/NZS 3666.2:2002 and called "Air-handling and water systems of buildings—Microbial control—Operation and maintenance.".

#### 7.2 Clause 3.1

Amend sub clause 3.1(m) by deleting the words "the Office of Energy" and substituting the words "Energy Safety".

#### 7.3 Clause 3.2

- 7.3.1 Amend sub clause 3.2(2)(b) by deleting "AS 1668.2" and substituting "AS 1668.2:2002".
- 7.3.2 Amend sub clause 3.2(3)(a) by deleting "AS 3666" and substituting "AS/NZS 3666.2:2002".

#### 7.4 Clause 4.2

Delete clause 4.2 and substitute the following clause—

"4.2" "An owner or occupier of premises shall maintain any footpath, pavement, area or right of way immediately adjacent to the premises clear of any rubbish, matter or other things coming from or belonging to the premises.".

#### 7.5 Clause 4.11

Amend sub clause 4.11(1)(b) by deleting "AS 1668.2" and substituting "AS 1668.2:2002".

#### 7.6 Clause 5.1

Delete the definition "street alignment".

#### 7.7 Clause 5.3

Amend sub clause 5.3(1) by deleting the words and numerals "sub clause 5.2(b)" and substituting the words and numerals "sub clause 5.2(d)".

#### 7.8 Clause 6.5

Amend sub clause 6.5(3) by inserting after the last word "clause" the following words ", except to the extent the person has suffered unreasonable loss or damage because the action taken by the Council was negligent or in breach of its duty.".

#### 7.9 Clause 6.15

Amend clause 6.15 by deleting the words "Norway rat" after the words "*rattus rattus*" and substituting the words "Roof rat" and then deleting the words "Roof rat" after the words "*Rattus norvegicus*" and substituting the words "Norway rat".

#### 7.10 Clause 6.17

Amend sub clause 6.17(b) by inserting the word "stored" before the word "food".

#### 7.11 Clause 8.2

Delete sub clause 8.2(d) and substitute the following sub clause-

"(d)" "the keeper of a lodging house shall not be absent from the lodging house at all unless he or she arranges for a reputable person to have the care and management of the lodging house.".

#### 7.12 Clause 8.9

Amend sub clause 8.9(1)(b) by inserting the word "either" before the words "a shower or bath".

#### 7.13 Clause 8.18

Amend sub clause 8.18(8)(a) as follows-

- 7.13.1 Delete "AS 1530.2" and substitute "AS 1530.2:1993".
- 7.13.2 Delete "AS 1530.3" and substitute "AS 1530.3:1999".
- 7.13.3 Delete "AS 2001.5.4-1987" and substitute "AS 2001.1:1995".

#### 7.14 Clause 9.2

Amend sub clause 9.2(1)(a) by deleting the numerals "10.3" and substituting the numerals "9.3".

#### 7.15 Clause 9.3

Amend clause 9.3 by deleting the numerals "10.2" and substituting the numerals "9.2".

#### 7.16 Clause 9.4

Amend sub clause 9.4(b) by deleting the word "Trade" and substituting the word "Trades".
