The Department of Environment and Conservation advises on behalf of the Conservation Commission of Western Australia that an amendment to the *Canning River Regional Park Management Plan 1997-2007* was approved by the Minister for the Environment on 16 November 2006.

The amendment will enable the Department of Environment and Conservation to construct a higher grade path (dual use path), should the need arise, from Riverton Bridge to the southern end of Watts Road in Wilson. This amendment reflects the increased recreational use of the area.

The amendment to the management plan was prepared in accordance with section 61 of the Conservation and *Land Management Act 1984*. No modifications were made to the amendment under section 60(2) of the Act, and it comes into operation with this *Government Gazette* notice.
