(DISCONTINUATION OF WARD SYSTEM) ORDER 2007

Made by the Governor in Executive Council on the recommendation of the Minister for Local Government.

1. Citation

This order may be cited as the District of Waroona (Discontinuation of Ward System) Order 2007.

2. Discontinuation of ward system (s.2.2(1)(d) of the Act)

All wards in the Shire of Waroona are abolished immediately before the first ordinary elections day of the district after the commencement of this order.

- (2) For the avoidance of doubt, clause 2 does not affect the term of office of any councillor.
