**LOCAL GOVERNMENT ACT 1995***Shire of Mundaring***REPEAL LOCAL LAW 2006**

Under the powers conferred by the *Local Government Act 1995* the Council of the Shire of Mundaring resolved on 27 February 2007 to make the "*Shire of Mundaring Repeal Local Law 2006*".

**1. Local laws repealed**

1. Inserting the following interpretation into clause 1.1.11 after the 'Shop' interpretation—  
*Short-Stay Accommodation: means a dwelling designed or intended to be used for the purpose of human habitation on a temporary basis for a single person or single family, and includes a serviced apartment, but does not include a Residential Building, Hotel or Motel.*

2. Insert 'short-stay accommodation' as a use class in Table 1: Zoning Table, with applicable symbols being as per those for a 'holiday unit' use class;
3. Delete Clause 1.3.5.1 (k);
4. Insert the following text as Clause 1.3.5.1 (f); and then renumber the existing clauses (f)-(j) following it accordingly—
  - (f) *The local government in considering an application for planning approval is to have due regard to such of the following matters as are in the opinion of the local government relevant to the use or development the subject of the application—*
    - (i) *the objectives and provisions of the Scheme and any other relevant town planning schemes operating within the Scheme area (including the Metropolitan Region Scheme);*
    - (ii) *the requirements of orderly and proper planning including any relevant proposed new town planning scheme or amendment, or region scheme or amendment, which has been granted consent for public submissions to be sought;*
    - (iii) *any approved statement of planning policy of the Commission;*
    - (iv) *any approved environmental protection policy under the Environmental Protection Act 1986;*
    - (v) *any relevant policy or strategy of the Commission and any relevant policy adopted by the Government of the State;*
    - (vi) *any Local Planning Policy adopted by the local government under clause 1.4.3, any heritage policy statement or guidelines adopted for heritage protection areas as detailed in Clause 2.2.3, and any other plan or guideline adopted by the local government under the Scheme;*
    - (vii) *in the case of land reserved under the Scheme, the ultimate purpose intended for the reserve;*
    - (viii) *the conservation of any place that has been entered in the Register within the meaning of the Heritage of Western Australia Act 1990, or which is included in the Heritage List under clause 1.4.5.1, and the effect of the proposal on the character or appearance of a heritage area;*
    - (ix) *the compatibility of a use or development with its setting;*
    - (x) *any social issues that have an effect on the amenity of the locality;*
    - (xi) *the cultural significance of any place or area affected by the development;*
    - (xii) *the likely effect of the proposal on the natural environment and any means that are proposed to protect or to mitigate impacts on the natural environment;*
    - (xiii) *whether the land to which the application relates is unsuitable for the proposal by reason of it being, or being likely to be, subject to flooding, tidal inundation, subsidence, landslip, bush fire or any other risk;*
    - (xiv) *the preservation of the amenity of the locality;*
    - (xv) *the relationship of the proposal to development on adjoining land or on other land in the locality including but not limited to, the likely effect of the height, bulk, scale, orientation and appearance of the proposal;*
    - (xvi) *whether the proposed means of access to and egress from the site are adequate and whether adequate provision has been made for the loading, unloading, manoeuvring and parking of vehicles;*
    - (xvii) *the amount of traffic likely to be generated by the proposal, particularly in relation to the capacity of the road system in the locality and the probable effect on traffic flow and safety;*
    - (xviii) *whether public transport services are necessary and, if so, whether they are available and adequate for the proposal;*
    - (xix) *whether public utility services are available and adequate for the proposal;*
    - (xx) *whether adequate provision has been made for access for pedestrians and cyclists (including end of trip storage, toilet and shower facilities);*
    - (xxi) *whether adequate provision has been made for access by disabled persons;*
    - (xxii) *whether adequate provision has been made for the landscaping of the land to which the application relates and whether any trees or other vegetation on the land should be preserved;*
    - (xxiii) *whether the proposal is likely to cause soil erosion or land degradation;*
    - (xxiv) *the potential loss of any community service or benefit resulting from the planning approval;*
    - (xxv) *any relevant submissions received on the application;*
    - (xxvi) *the comments or submissions received from any authority consulted under clause 10.1.1;*
    - (xxvii) *any other planning consideration the local government considers relevant.*
5. replace Clause 1.3.5.3 (f) with the following text—
  - (f) *For an increase in density under the provisions of Clause 1.4.5.4;  
Note: this does not apply when a minimum lot size has been reduced, where the number of dwellings that would otherwise be permitted on the site is unchanged.*

6. delete Clause 2.2.8 Aged Persons' Dwellings, and renumber the clauses following it accordingly;
7. replace Clause 2.2.11.1 (a) with the following text—
  - (a) *Application is made in accordance with Clause 1.3.5.1 (c);*
8. replace the words 'Heritage Protection Area Design Guidelines' with 'Character Retention Design Guidelines' in Clause 2.2.3.2 (c);
9. In Schedule 17—
  - (i) *delete Clause 2.1.2, Clause 2.1.3, Clause 2.1.5 (b), and Clause 2.1.6; and renumber the clauses following accordingly;*
  - (ii) *replace Clause 2.1.10 (a) with the following text—*
    - (a) *if located within the street setback of any land used for residential or non-residential purposes—*
      - (i) *does not exceed 1.8 metres in height (2.0 metres to piers or columns) above natural ground level, and that portion of the fence above 0.75 metres in height is visually permeable (ie. is 'open' or 'see-through'—pickets, if used, should be no wider than 75mm, and the distance between pickets should be no less than half of the width of the picket);*
      - (ii) *does not exceed 1.2 metres in height above natural ground level if the fence is not visually permeable;*
      - (iii) *is constructed in materials similar to, or the same as, the predominant dwelling or building on the site, but in any case, not being fibre cement or metal sheeting;*
      - (iv) *does not, and can not, obstruct any vehicular or pedestrian movement outside the lot boundaries, or obstruct access to visitor parking bays.*
    - (iii) *replace Clause 2.1.10 (b) with the following text;*
  - (b) *does not exceed 0.75 metres in height above natural ground level if located in the street setback of any land within a Heritage Protection Area.*
