# 2. Exemption from licensing requirements

The Police of New Zealand is a specified disciplined force for the purposes of section 8(1) of the Act in respect of the possession of a firearm or ammunition by a member of that force for use during counter terrorism training —

- (a) conducted by the Commonwealth; and
- (b) in which the member is participating.

## Schedule

EDITH COWAN UNIVERSITY Statute No. 22 Student Conduct

### 1. Preliminary

- (1) Under the provisions of sections 26(3) and 26(7) of the *Edith Cowan University Act 1984* ("the Act") Rules may be made under this Statute with respect to matters concerning the conduct of students and allegations of misconduct by students.
- (2) These Rules may prescribe the responsibilities and obligations of those persons, classes of persons and bodies of persons within the University necessary for the preservation of order, whilst also protecting the freedom of students and encouraging their cooperation.
- (3) These Rules may stipulate—
  - (a) the forms of conduct that constitute misconduct;
  - (b) the procedures for making complaints of misconduct;
  - (c) the procedures for the consideration of complaints of alleged misconduct and appeals against findings of and penalties imposed for proven misconduct;
  - (d) the persons, classes of persons and bodies of persons who may make complaints, hear complaints and exercise disciplinary powers and determine appeals made against the exercise of such powers;
  - (e) such other matters regarding the conduct and discipline of the University that the Council considers necessary.

## 2. Investigations and appeals

- (1) Investigations and appeals instigated under this Statute must be conducted in accordance with the principles of equity and good conscience and the substantial merits of the case without regard to technicalities or legal forms. Subject to the requirements of natural justice, those conducting investigations and deciding appeals will not be bound by any rules of evidence and may inform themselves of any matter they believe to be relevant.
- (2) When investigating whether an activity constitutes misconduct or when hearing an appeal against a finding of misconduct—
  - (a) freedom of speech and freedom of expression shall be permitted where such speech or expression is consistent with like freedoms given to others and the rights of any person affected;
  - (b) the burden of proving an allegation of misconduct will rest with the University, and the standard of proof is the balance of probabilities;
  - (c) the accused must be—
    - (i) given sufficient particulars to enable him/her to answer the allegation; and
    - (ii) provided with an opportunity to be heard (although not necessarily face to face or even orally); and
  - (d) when a finding of misconduct is made, or an appeal dismissed, the student must be—
    - (i) notified of the outcome; and
    - (ii) provided with sufficient reasons to explain the outcome.
- (3) Sub-sections (1) and (2) do not apply to the exercise of summary powers prescribed in a rule under this Statute.

#### 3. Penalties and appeals

- (1) Penalties that may be imposed for proven misconduct may include any one or all of the following—
  - (a) fines for any one offence, not exceeding the amount prescribed by section 26(3)(b) of the Act;
  - (b) restitution, not exceeding the amount prescribed by section 26(3)(d) of the Act, for damage to University property arising out of the commission of a disciplinary offence;
  - (c) deprivation of credit for academic work;
  - (d) cancellation or suspension of all or any of a student's rights and privileges, including suspension from the University or parts of the University; and
  - (e) expulsion from the University.
- (2) Appeals against findings of and penalties imposed for proven misconduct must be lodged in accordance with the procedures and in the timeframe specified in Rules made under this Statute, except in exceptional circumstances approved by the Vice-Chancellor.
- (3) In all other circumstances, time limits established in Rules under this Statute should, where practicable, be complied with provided that—
  - (a) the Vice-Chancellor may, upon such terms as he or she believes to be appropriate, extend or abridge any period of time fixed by a provision of a rule made under this Statute, and may do so after the expiration of any such period; and
  - (b) no action will be invalidated because a time limit is exceeded.
- (4) Hearings instigated under this Statute must be in private unless the presiding member of the body hearing the appeal decides otherwise.
- (5) Any money owed by any person pursuant to this Statute is payable as a debt and may be recovered by the University.
- (6) No academic award shall be conferred on a student charged with a breach of obligation until after the charge has been dealt with in accordance with this Statute, unless otherwise decided by the Vice-Chancellor.

#### **EDITH COWAN UNIVERSITY**

Statute No. 30 Admission, Enrolment and Academic Progress

#### 1. Preliminary

- (1) Under the provisions of section 26(1) of the *Edith Cowan University Act 1984* ("the Act") Rules may be made under this Statute with respect to the admission, enrolment and academic progress of students.
- (2) These Rules may prescribe the responsibilities and obligations of those persons, classes of persons and bodies of persons within the University necessary to regulate, or provide for the regulation of—
  - (a) the admission of students to the University at all levels of academic program;
  - (b) the enrolment and re-enrolment of students;
  - (c) the granting of advanced standing, the recognition of prior learning and credit transfer;
  - (d) the assessment and grading of student performance;
  - (e) the academic progress of students, including student appeals; and
  - (f) other such matters that may be required to fulfil the functions and responsibilities of the University with respect to the objects of the Act and the academic progress of students.
- (3) The Rules may provide for the maintenance, promotion and improvement of the academic standards of the University, whilst giving due consideration to the rights and freedoms of students, the academic support required generally by students and the specific needs of designated student populations including students with disabilities, students in other defined equity groups and international students.

#### 2. Investigations and appeals

- (1) Appeals instigated under this Statute must be conducted in accordance with the principles of equity and good conscience and the substantial merits of the case without regard to technicalities or legal forms. Subject to the requirements of natural justice, those deciding appeals will not be bound by any rules of evidence and may inform themselves of any matter they believe to be relevant.
- (2) When hearing an appeal—
  - (a) freedom of speech and freedom of expression shall be permitted where such speech or expression is consistent with like freedoms given to others and the rights of any person affected;
  - (b) the student must be provided with an opportunity to be heard (although not necessarily face to face or even orally); and
  - (c) when a conclusion is reached, the student must be—
    - (i) notified of the outcome; and
    - (ii) provided with sufficient reasons to explain the outcome.
- (3) Appeals must be lodged in accordance with the procedures and in the timeframe specified in Rules made under this Statute, except in exceptional circumstances approved by the Vice-Chancellor.
- (4) In all other circumstances, time limits established in Rules under this Statute should, where practicable, be complied with provided that—
  - (a) the Vice-Chancellor may, upon such terms as he or she believes to be appropriate, extend or abridge any period of time fixed by a provision of a Rule made under this Statute, and may do so after the expiration of any such period; and
  - (b) no action shall be invalidated because a time limit is exceeded.
- (5) Hearings instigated under this Statute will be in private unless the presiding member of the body hearing the appeal decides otherwise.

# EDITH COWAN UNIVERSITY

# Statute No. 31 Fees

#### 1. Definitions

In this Statute, unless the contrary intention appears—

"Act" means the Edith Cowan University Act 1984;

"Council" means the Council of the University as established by section 8 of the Act;

"fees" means statutory fees and charges collected by the University under Commonwealth and State legislation and other such fees, charges, penalties, fines, late fees, deposits and rental payments imposed by the University under this Statute other than an amenities and services fee payable under section 41A of the Act;

"HES Act" means the  ${\it Higher Education Support Act~2003}$  (Cth);

"Rules" means rules pursuant to section 6;

"tuition fees" means fees for a course of study or instruction; and

"Vice-Chancellor" means the person for the time being appointed as the Chief Executive Officer of the University under section 30 of the Act, or a person acting in that position.

#### 2. Categories of fees

- (1) The University may impose fees and collect payments from students as permitted under the HES Act and other relevant Commonwealth and State legislation.
- (2) Subject to section 2(1), the University may impose other fees, and collect payments for penalties, fines and late charges, in respect of—
  - (a) a course of study or instruction ("tuition fees");
  - (b) examinations, degrees, diplomas and certificates of the University;
  - (c) the use of equipment and materials;
  - (d) the supply of books, documents and other materials;
  - (e) student accommodation; and
  - (f) such other facilities and privileges of the University as are prescribed.

#### 3. Setting fees

- (1) Council, by resolution, may determine the principles for setting the level of Student Contribution Fees for Commonwealth-supported places as allowed under the HES Act.
- (2) The Vice-Chancellor must determine from time to time, but at least annually—
  - (a) the matters referred to in section 2 that will attract fees, charges, penalties, fines and/or late charges; and
  - (b) the level of fees, charges, penalties, fines and/or late charges that will apply for each such course of study, facility, service and privilege.
- (3) The various fees prescribed under this Statute will continue to apply from year to year in the absence of a replacement or updated schedule or schedules being issued in any particular year.

#### 4. Exemption from fees

Subject to the Act, the University Statutes and other relevant legislation, the Vice-Chancellor may exempt for good reason any person or class of persons from liability to pay any, or part of any, fee payable under this Statute.

### 5. Payment of fees

- (1) All fees payable pursuant to this Statute must be paid in full by the due date.
- (2) Failure by a student to pay by the due date all or part of the fee payable by that student under this Statute does not constitute a breach of obligation under the provisions of Statute 22. However, money owed by any person pursuant to this Statute is payable as a debt and may be recovered by the University.
- (3) The Vice-Chancellor may direct that one, some or all of the following actions be taken if a student fails to pay by the due date all or part of the fee payable by that student under this Statute—
  - (a) to suspend access to the University or parts of the University;
  - (b) to withhold official notification of the student's examination or other assessment results (except for notice of eligibility for supplementary or deferred examinations or assessment);
  - (c) to cancel an enrolment;
  - (d) to defer the conferral of a degree, diploma or certificate on the relevant student; and
  - (e) to not permit the relevant student to re-enrol in a subsequent semester,
  - until the outstanding fees, or portion outstanding, is paid in full.

#### 6. Rules

The Council may make Rules, not inconsistent with this Statute, for regulating or providing for the regulation of any matter referred to in this Statute or for carrying out or giving effect to this Statute. The Rules may define—

- (1) the categories of tuition fees;
- (2) the classes (or categories) of students liable for each tuition fee;

- (3) due dates for payment;
- (4) the circumstances in which students may be exempt from liability, or have payment waived or deferred;
- (5) the circumstances in which students will be liable for service fees, late charges, penalties and fines;
- (6) the circumstances in which refunds will be granted and the basis for calculation of the amount of such refunds;
- (7) any other matters which the Council considers necessary to give effect to the Rules and/or this Statute.

### STATUTE NO. 18—INTELLECTUAL PROPERTY

- 1. Regulations will be made under this Statute dealing with intellectual property rights as between the University, its staff and students. Without limiting the generality of the foregoing, the regulations will:
  - 1.1 specify the respective rights and obligations of each of the University, its employees and students in relation to intellectual property owned by, or created or developed at, the University;
  - 1.2 specify procedures for identifying, protecting and commercially exploiting the intellectual property referred to in sub-section 1.1;
  - 1.3 establish a mechanism by which the University will provide equitable returns to contributors involved in the creation or development of intellectual property that is exploited by the University for commercial return.

2.1 Statute No. 18—Patents is hereby repealed.
