## CITY OF SOUTH PERTH (CHANGE OF WARD BOUNDARIES) ORDER 2007

Made by the Governor in Executive Council on the recommendation of the Minister for Local Government.

**1. Citation**

This order may be cited as the *City of South Perth (Change of Ward Boundaries) Order 2007*.

**2. Alteration of ward boundaries (s.2.2 (1) (c) of the Act)**

On the first ordinary elections day after the commencement of this order, the boundaries of the Civic Ward, Como Beach Ward, Manning Ward, McDougall Ward, Mill Point Ward and the Moresby Ward in the district of the City of South Perth shall be described in the Schedule to this order.

**3. Elections (s.4.11 and 9.62 of the Act)**

(1) Part 4 of the Act applies to preparing for and conducting the election as if the changes effected by clauses 2 had taken effect on the day on which this order commenced.

(2) For the purposes of subclause (1)—

- (a) Part 4 of the Act is modified to the extent necessary to give effect to subclauses (1); and
- (b) Without limiting paragraph (a), a reference in Part 4 of the Act to a ward, in relation to the district of the City of South Perth, is to be read as including a reference to the wards altered under clause 2 as it is or will be, as a result of the operation of that clause, on the first ordinary elections day after the commencement of this order.

**Schedule****AMENDMENT AND REDESCRIPTION OF THE WARDS  
OF THE CITY OF SOUTH PERTH****MILL POINT WARD**

All that portion of land bounded by lines starting from the intersection of the left bank of the Swan River with the prolongation northeasterly of the centreline of Coode Street, a point on a present northern boundary of the City of South Perth and extending southwesterly to and southwesterly and southerly along that centreline to the centreline of Eric Street; thence westerly along that centreline and onwards to the left bank of the Swan River, a point on a present southwestern boundary of the City of South Perth and thence generally northwesterly, generally southeasterly and generally easterly along boundaries of that city to the starting point.

**CIVIC WARD**

All that portion of land bounded by lines starting from the intersection of the left bank of the Swan River with the prolongation northeasterly of the centreline of Coode Street, a point on a present northern boundary of the City of South Perth and extending southwesterly to and southwesterly and southerly along that centreline to the centreline of Eric Street; thence easterly along that centreline and onwards to the centreline of McDonald Street; thence northeasterly along that centreline to the centreline of Comer Street; thence southeasterly along that centreline and onwards to the centreline of Canning Highway; thence generally northeasterly along that centreline to the prolongation southeasterly of the centreline of Ellam Street, a point on a present northeastern boundary of the City of South Perth and thence northwesterly, generally westerly, generally southwesterly and again generally westerly along boundaries of that city to the starting point.

**MORESBY WARD**

All that portion of land bounded by lines starting from the intersection of the centreline of Kent Street with the centreline of Hayman Road, a point on a present eastern boundary of the City of South Perth and extending generally westerly and generally northwesterly along the centreline of Hayman Road to the prolongation easterly of the centreline of the eastern section of Thelma Street; thence westerly to and generally westerly along that centreline to the centreline of Murray Street; thence northerly along that centreline to the centreline of Todd Avenue; thence westerly along that centreline and onwards to the centreline of Canning Highway; thence generally northeasterly along that centreline to the prolongation southeasterly of the centreline of Ellam Street, a point on a present northeastern boundary of the City of South Perth and thence southeasterly, southwesterly, northwesterly, again southwesterly, again southeasterly, generally southwesterly and generally southerly along boundaries of that city to the starting point.

**COMO BEACH WARD**

All that portion of land bounded by lines starting from the intersection of the left bank of the Swan River with the prolongation westerly of the centreline of Eric Street, a point on a present southwestern boundary of the City of South Perth and extending easterly to and along that centreline and onwards to the centreline of McDonald Street; thence northeasterly along that centreline to the centreline of Comer Street; thence southeasterly along that centreline and onwards to the centreline of Canning Highway; thence generally southwesterly along that centreline to the centreline of Henley Street; thence generally easterly along that centreline to the centreline of Ley Street; thence generally southerly along that centreline and onwards to the centreline of Cloister Avenue; thence westerly along that centreline and onwards to the centreline of Mount Henry Road; thence southerly along that centreline to the northeastern corner of Lot 4 as shown on Plan 3383 (sheet 1); thence westerly along the northern boundary of that lot and westerly along the southern boundary of Lot 3944 as shown on Deposited Plan 219097 to its southwestern corner; thence southwesterly to the northeastern corner of Lot 3946 as shown on Deposited Plan 219097; thence southwesterly along the northwestern boundary of that lot to its northernmost northwestern corner, a point on a present southwestern boundary of the City of South Perth and thence generally northwesterly along boundaries of that city to the starting point.

**McDOUGALL WARD**

All that portion of land bounded by lines starting from the intersection of the centreline of Kent Street with the centreline of Hayman Road, a point on a present eastern boundary of the City of South Perth and extending generally westerly and generally northwesterly along the centreline of Hayman Road to the prolongation easterly of the centreline of the eastern section of Thelma Street; thence westerly to and generally westerly along that centreline to the centreline of Murray Street; thence northerly

along that centreline to the centreline of Todd Avenue; thence westerly along that centreline and onwards to the centreline of Canning Highway; thence generally southwesterly along that centreline to the centreline of Henley Street; thence generally easterly along that centreline to the centreline of Ley Street; thence generally southerly along that centreline to the centreline of Manning Road; thence northeasterly, easterly, southeasterly, generally easterly and generally southeasterly along that centreline to the prolongation southwesterly of the centreline of Kent Street; thence northeasterly along that prolongation to a southwestern side of the Manning Road widening as shown on Deposited Plan 211864, a point on a present southeastern boundary of the City of South Perth and thence generally northeasterly, generally northwesterly and generally northerly along boundaries of that city to the starting point.

#### **MANNING WARD**

All that portion of land bounded by lines starting from the northernmost northwestern corner of Lot 3946 as shown on Deposited Plan 219097, a point on a present southwestern boundary of the City of South Perth and extending northeasterly along the northwestern boundary of that lot to its northeastern corner; thence northeasterly to the southwestern corner of Lot 3944 as shown in Deposited Plan 219097; thence easterly along the southern boundary of that lot and easterly along the northern boundary of Lot 4 as shown on Plan 3383 (sheet 1) to the centreline of Mount Henry Road; thence northerly along that centreline to the prolongation westerly of the centreline of Cloister Avenue; thence easterly to and along that centreline to the prolongation southerly of the centreline of Ley Street; thence northerly to and along that centreline to the centreline of Manning Road; thence northeasterly, easterly, southeasterly, generally easterly and generally southeasterly along that centreline to the prolongation southwesterly of the centreline of Kent Street; thence northeasterly along that prolongation to a southwestern side of the Manning Road widening as shown on Deposited Plan 211864, a point on a present northeastern boundary of the City of South Perth and thence southeasterly, northeasterly, generally southeasterly, generally southwesterly and generally northwesterly along boundaries of that city to the starting point.

#### **DISTRICTS OF ALBANY AND PLANTAGENET (CHANGE OF BOUNDARIES) ORDER 2007**

Made by the Governor in Executive Council on recommendation of the Minister for Local Government.

#### **1. Citation**

This order may be cited as the *Districts of Albany and Plantagenet (Change of Boundaries) Order 2007*.

#### **2. Commencement**

This order comes into operation on the date of publication in the *Government Gazette*.

#### **3. Boundary changes—City of Albany (s.2.1 and s.2.2 of the Act)**

##### **3.1 District Boundary Change**

The boundaries of the district of Albany are changed by excluding from the district the portion of land described in the Schedule.

##### **3.2 Ward Boundary Change**

The boundaries of the Kalgan Ward are to be changed by excluding from the ward the portion of land described in the Schedule.

#### **4. Boundary changes—Shire of Plantagenet (s.2.1 and s.2.2 of the Act)**

##### **4.1 District Boundary Change**

The boundaries of the district of Plantagenet are changed by including in the district the portion of land described in the Schedule.

#### 4.2 Ward Boundary Change

The boundaries of the East Ward are to be changed by including in the ward the portion of land described in the Schedule.

All that portion of land bounded by lines starting from the northeastern corner of Lot 150 as shown on Deposited Plan 51997, a point on a present northern boundary of City of Albany; thence generally southerly along the eastern boundaries of that lot to the southern most southwestern corner of Lot 151; thence generally easterly along the southern boundaries of that lot and northerly along the eastern boundary of that lot to its intersection with the prolongation easterly of the southern most southern boundary of Lot 4911 as shown on Deposited Plan 157872, a point on a present northern boundary of the City of Albany and thence westerly along that boundary to the starting point.

#### **SHIRE OF GOOMALLING (CHANGE OF WARDS AND REPRESENTATION) ORDER 2007**

Made by the Governor in Executive Council on the recommendation of the Minister for Local Government.

#### **1. Citation**

This order may be cited as the *Shire of Goomalling (Change of Wards and Representation) Order 2007*.

#### **2. Abolition of existing wards (s.2.2 (1) (d) of the Act)**

The Central and North Wards in the district of Goomalling are abolished immediately before the first ordinary elections day after the commencement of this order.

#### **3. New ward created (s.2.2 (1) (b) of the Act)**

(1) On and after the first ordinary elections day after the commencement of this order, a new ward is created in the district of the Shire of Goomalling, named the Central/North Ward.

(2) The Central/North Ward consists of the land described in Schedule 1.

#### **4. Number of Councillors**

On and after the first ordinary elections day after the commencement of this order the number of offices of councillor for the ward created under clause 3 is three (3).

#### **5. Continuing councillor allocated to new ward (s.9.62 of the Act)**

(1) In this Clause—

“continuing councillor” means a person—

- (a) who was a councillor immediately before the commencement of this order; and
- (b) whose term of office as councillor continues beyond the day of the first ordinary elections after the commencement of this order.

(2) A person who was a continuing councillor for the Central and North Wards immediately before the abolition of that ward under clause 2 is, on and after the first ordinary elections day, to be taken to have been elected as a councillor for the Central/North Ward created under clause 3.

(3) For the avoidance of doubt, it is declared that this clause does not affect the term of office of any continuing councillor.

#### **6. Election to fill vacancies (s.4.11 and 9.62 of the Act)**

(1) Part 4 of the Act applies to preparing for and conducting the election as if the changes effected by clauses 2, 3, 4 and 5 had taken effect on the day on which this order commenced.

(2) For the purposes of subclause (2)—

- (a) Part 4 of the Act is modified to the extent necessary to give effect to subclauses (1) and (2); and



- (b) without limiting paragraph (a), a reference in Part 4 of the Act to a ward, in relation to the district of the Shire of Goomalling, is to be read as including a reference to the wards created under clause 3 as they are or will be, as a result of the operation of that clause, on the first ordinary elections day after the commencement of this order.

**APPLICATION DETAILS**

Central to any application made is the program of work proposed for each of the years of the six year term. Applications are to be made in accordance with Section 31 of the Petroleum Act 1967 and Section 21 of the Petroleum (Submerged Lands) Act 1982 as appropriate. Consideration of an application for the grant of a Permit shall take into account work programs relative to the whole of the area applied for, the adequacy of the work program and the applicant's technical and financial ability to undertake the work. Permits are awarded on the understanding that the first two years work commitment will be fulfilled without variation.

Where there is more than one applicant to the application, the percentage participating interests of each party to the application is to be supplied including evidence that a satisfactory settlement has been, or can be, reached on a Joint Operating Agreement (a copy of a Heads of Agreement dealing will generally suffice).

Applicants should also make themselves aware of the existence of any areas, which have the potential to restrict exploration activities eg, National Parks, Nature Reserves, Marine Parks, World Heritage Areas, Conservation Reserves, Defence Areas and Mining Titles.

In this regard, the RAAF Curtin Defence Area lies within Area L07-1. The defence area is private land under the Petroleum Act 1967 and any access to that land would need to observe the access and compensation provisions under the Act.

Insofar as Reserved Land is concerned, entry for exploration purposes is subject to approval by the Minister. In this regard, it should be noted that Government policy, at least, is such that petroleum extraction from within National Parks, Nature Reserves and access to Conservation Estates should not be presumed.

In respect to offshore areas, impacts on fishing activities should also be considered.

Any applications over the above onshore areas may be subject to the provisions of the Commonwealth Native Title Act 1993 and applicants should be prepared to negotiate with Native Title parties

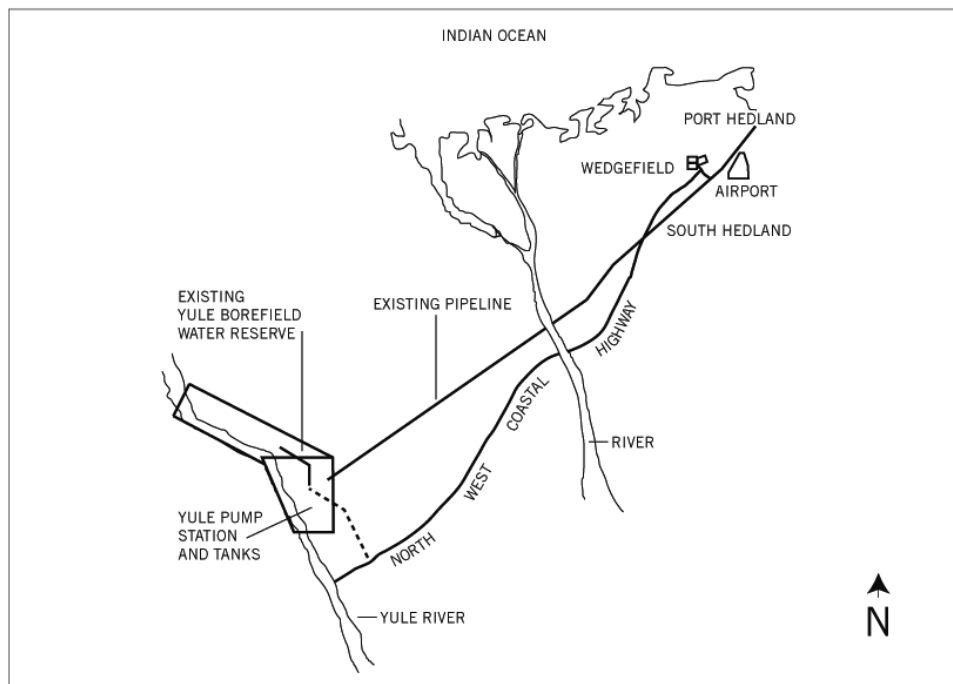
