Retail Trading Hours Act 1987

Retail Trading Hours (Wanneroo Holiday Resort) Order 2007

Made by the Minister for Consumer Protection under section 12A of the Act.

1. Citation

This order is the *Retail Trading Hours (Wanneroo Holiday Resort) Order 2007*.

2. Commencement

This order comes into operation on the day on which the *Retail Shops and Fair Trading Legislation Amendment Act 2006** section 9 comes into operation.

[* *Act No. 47 of 2006.*]

3. Interpretation

In this order —

“**school term**” means a school term determined by order published in the *Gazette* under the *School Education Act 1999* section 117 by the chief executive officer under that Act.

4. Applicable periods

This order applies to the periods commencing on the first-mentioned day in each of the following paragraphs and ending at the close of business on the second-mentioned day in each of those paragraphs, namely —

- (a) 1 January to the second Sunday in February;
- (b) the Saturday preceding Labour Day to the following Monday;
- (c) the Saturday following the end of the first school term to the Sunday preceding the second school term;
- (d) the Saturday following Good Friday to Easter Monday;
- (e) the Saturday preceding Foundation Day to Foundation Day;
- (f) the Saturday following the end of the second school term to the Sunday preceding the third school term;

- (g) the Saturday following the end of the third school term to the Sunday preceding the fourth school term;
- (h) the Saturday preceding the Queen's Birthday public holiday to the Queen's Birthday public holiday;
- (i) the first Sunday in December to Christmas Eve;
- (j) Boxing Day to the last day of December.

5. Closing times

General retail shops in the Wanneroo holiday resort are to be closed on the days set out in clause 4 until 8.00 a.m. and from and after 9.00 p.m.

6. Revocation

The *Retail Trading Hours (Wanneroo) Exemption Order 1995* is revoked.

Retail Trading Hours Act 1987

Retail Trading Hours (Filling Stations) Revocation Order 2007

Made by the Minister for Consumer Protection under section 12E of the Act.

1. Citation

This order is the *Retail Trading Hours (Filling Stations) Revocation Order 2007*.

2. Commencement

This order comes into operation on the day on which the *Retail Shops and Fair Trading Legislation Amendment Act 2006** section 9 comes into operation.

3. Revocation

- (1) The *Retail Trading Hours (Filling Stations) Exemption Order 1995* is revoked.
- (2) The *Retail Trading Hours (Filling Stations) Exemption Order (No. 2) 1995* is revoked.
- (3) The *Retail Trading Hours (Filling Stations) Exemption Order (No. 3) 1995* is revoked.

Retail Trading Hours Act 1987

Retail Trading Hours (Tourism Precincts) Order 2007

Made by the Minister for Consumer Protection under section 12A of the Act.

1. Citation

This order is the *Retail Trading Hours (Tourism Precincts) Order 2007*.

2. Commencement

This order comes into operation on the day on which the *Retail Shops and Fair Trading Legislation Amendment Act 2006** section 9 comes into operation.

[* *Act No. 47 of 2006.*]

3. Retail trading hours — Fremantle tourism precinct

General retail shops in the Fremantle tourism precinct are required to be closed —

- (a) on those days during the hours specified opposite and corresponding to those days in column 2 of the Table; and
- (b) on any day that is appointed or declared a public holiday for that precinct or throughout the State by or under the *Public and Bank Holidays Act 1972*.

Column 1 <i>Days</i>	Column 2 <i>Hours closed</i>
Sunday	until 12 p.m. and from and after 6 p.m.
Monday, Tuesday, Wednesday	until 8 a.m. and from and after 7 p.m.
Thursday (before 27 September 2007)	until 8 a.m. and from and after 9 p.m.
Thursday (on or after 27 September 2007)	until 8 a.m. and from and after 7 p.m.
Friday (before 28 September 2007)	until 8 a.m. and from and after 7 p.m.
Friday (on or after 28 September 2007)	until 8 a.m. and from and after 9 p.m.
Saturday	until 8 a.m. and from and after 5 p.m.

4. **Retail trading hours — Perth tourism precinct**

General retail shops in the Perth tourism precinct are required to be closed —

- (a) on those days during the hours specified opposite and corresponding to those days in column 2 of the Table; and
- (b) on any day that is appointed or declared a public holiday for that precinct or throughout the State by or under the *Public and Bank Holidays Act 1972*.

Column 1 <i>Days</i>	Column 2 <i>Hours closed</i>
Sunday	until 12 p.m. and from and after 6 p.m.
Monday, Tuesday, Wednesday, Thursday	until 8 a.m. and from and after 7 p.m.
Friday	until 8 a.m. and from and after 9 p.m.
Saturday	until 8 a.m. and from and after 5 p.m.

Retail Trading Hours (Rottnest Island Holiday Resort) Order 2007

Made by the Minister for Consumer Protection under section 12A of the Act.

1. Citation

This order is the *Retail Trading Hours (Rottnest Island Holiday Resort) Order 2007*.

2. Commencement

This order comes into operation on the day on which the *Retail Shops and Fair Trading Legislation Amendment Act 2006** section 9 comes into operation.

3. Closing times

General retail shops in the Rottnest Island holiday resort are to be closed until 7.00 a.m. and from and after 9.30 p.m.

4. Revocation

The *Retail Trading Hours Exemption Order (No. 3) 1993* is revoked.

Retail Trading Hours Act 1987

Retail Trading Hours (Rockingham Holiday Resort) Order 2007

Made by the Minister for Consumer Protection under section 12A of the Act.

1. Citation

This order is the *Retail Trading Hours (Rockingham Holiday Resort) Order 2007*.

2. Commencement

This order comes into operation on the day on which the *Retail Shops and Fair Trading Legislation Amendment Act 2006** section 9 comes into operation.

[* *Act No. 47 of 2006.*]

3. Interpretation

In this order —

“**Public Holiday**” means on any day that is appointed or declared a public holiday for the Rockingham holiday resort or throughout the State by or under the *Public and Bank Holidays Act 1972* but does not include Anzac Day, Christmas Day or Good Friday;

“**school term**” means a school term determined by order published in the *Gazette* under the *School Education Act 1999* section 117 by the chief executive officer under that Act.

4. Applicable periods

This order applies to the periods commencing on the first-mentioned day in each of the following paragraphs and ending at the close of business on the second-mentioned day in each of those paragraphs, namely —

- (a) 1 January to the second Sunday in February;
- (b) the Saturday preceding Labour Day to the following Monday;
- (c) the Saturday following the end of the first school term to the Sunday preceding the second school term;

- (d) the Saturday following Good Friday to Easter Monday;
- (e) the Saturday preceding Foundation Day to Foundation Day;
- (f) the Saturday following the end of the second school term to the Sunday preceding the third school term;
- (g) the Saturday following the end of the third school term to the Sunday preceding the fourth school term;
- (h) the Saturday preceding the Queen's Birthday public holiday to the Queen's Birthday public holiday;
- (i) the first Sunday in December to Christmas Eve;
- (j) Boxing Day to the last day of December.

5. Closing times

General retail shops in the Rockingham holiday resort are to be closed on the days set out in clause 4 during the hours set out in the Table to this clause.

Table

Days	Closing times
If the day is a Monday, Tuesday, Wednesday, Thursday or Friday (and if the day is not a Public Holiday)	Until 8.00 a.m. and from and after 9.00 p.m.
If the day is a Saturday (but not a Public Holiday or Anzac Day)	Until 8.00 a.m. and from and after 6.00 p.m.
If the day is a Sunday or a Public Holiday	Until 10.00 a.m. and from and after 5.00 p.m.

6. Revocation

The *Retail Trading Hours (Rockingham) Exemption Order 1995* is revoked.
