HEALTH (AMENDMENT) LOCAL LAW 2007

Under the powers conferred by Section 342 of the *Health Act 1911* and sub-division 2 of Division 2 of Part 3 of the *Local Government Act 1995*, the Council of the Shire of Dandaragan resolved on the 12 April 2007 to make the *Shire of Dandaragan Health (Amendment) Local Law 2007*.

1. Citation

This Health Local Law may be cited as the Shire of Dandaragan Health (Amendment) Local Law 2007.

2. Principal Local Laws

The Shire of Dandaragan Health Local Laws 2005, as published in the Government Gazette on 13 September 2005, and as amended and published in the Government Gazette on 19 September 2006, are referred to as the principal local laws.

These principal local laws are amended.

3. Schedule of Amendments

The amendments to the principal local laws are as follows-

Under "Division 5—Keeping of Animals and Birds" the following amendments are to occur—

(a) 5.5.1—after the definition of "animal" remove "and" and the full-stop after the end of the definition of "bird" should be deleted and replaced with a semi-colon then the word "and".

following the definitions for "animal" and "bird" a definition for "pest species" is to be included as follows.

" "pest species" includes rabbits, foxes, pigs, cats and goats or the like that have become feral."

- (b) 5.5.6 (2)—the word "immediately" is to be deleted and replaced with the words "as soon as possible".
- (c) 5.6.2 (1)—from this subsection after "A cow or large animal" delete the following "or animal of potential burden or animals in such numbers that may cause a nuisance as determined by the Council".
- (d) 5.6.3—the wording of this subsection should be deleted and replaced with "An owner or occupier of premises, who has an approved animal shall ensure the approved animal does not approach within 20 metres of a dwelling house".
- (e) 5.7.8 (1)—in this subsection following the final word "health" add—"to members of the general public".
