Community Protection (Offender Reporting) Act 2004

Community Protection (Offender Reporting) Amendment Regulations 2007

Made by the Governor in Executive Council.

1. Citation

These regulations are the Community Protection (Offender Reporting) Amendment Regulations 2007.

2. The regulations amended

The amendments in these regulations are to the *Community Protection (Offender Reporting) Regulations 2004**.

[* Published in Gazette 31 December 2004, p. 7025-39. For amendments to 14 December 2006 see Western Australian Legislation Information Tables for 2005, Table 4, and Gazette 8 September 2006.]

3. Regulation 3 replaced

Regulation 3 is repealed and the following regulation is inserted instead —

"

3. Definitions

In these regulations —

- "Department of Corrective Services" means the department of the Public Service principally assisting in the administration of the *Prisons Act 1981*;
- "foreign court" means a court of a foreign jurisdiction;
- "recognised order" means a corresponding prohibition order recognised under regulation 23(1);
- "registrar" has the same meaning as it has in
 - (a) the Children's Court of Western Australia Act 1988; or
 - (b) the District Court of Western Australia Act 1969,

as the case requires;

"relevant court", in relation to a corresponding prohibition order, means —

- (a) if the order is made by a foreign court that corresponds to the Children's Court the Children's Court;
- (b) otherwise, the District Court.

4. Regulation 6A inserted

After regulation 6 the following regulation is inserted —

6A. Sentences (s. 3)

A pre-sentence order made under the *Sentencing Act 1995* Part 3A, in force on or after the commencement of this regulation, is prescribed to be a sentence for the purposes of the definition of that term in section 3 of the Act.

5. Regulation 22 replaced by regulations 22 to 26

Regulation 22 is repealed and the following regulations are inserted instead —

22. Application for recognition of corresponding prohibition orders (s. 108(2)(a))

- (1) A police officer may, on behalf of the Commissioner, apply to the relevant court for the recognition in Western Australia of a corresponding prohibition order.
- (2) An application does not need to be served on the person who is subject to the corresponding prohibition order.

23. Recognition of corresponding prohibition orders (s. 108(2)(b))

- (1) If an application is made under regulation 22, the relevant court is to recognise the corresponding prohibition order that is the subject of the application.
- (2) When the relevant court recognises a corresponding prohibition order, the registrar is to
 - (a) notify—
 - (i) the foreign court in which the recognised order was made; and
 - (ii) the Commissioner; and
 - (iii) the person who is subject to the recognised order,

of that recognition; and

(b) cause a copy of the recognised order to be delivered to the Commissioner.

24. Effect of recognition of corresponding prohibition orders (s. 108(2)(d))

- (1) A recognised order operates in Western Australia as if it were a child protection prohibition order made under Part 5 of the Act
 - (a) with the terms (including as to its duration) set out in the recognised order or applying to it under the law under which it was made; and
 - (b) from the day on which the recognition of the recognised order was notified to the person who is subject to it,

and the provisions of the Act apply to the recognised order as if it were a child protection prohibition order.

- (2) Without limiting subregulation (1), for the purposes of applying Part 5 of the Act to a recognised order
 - (a) a reference in that Part to varying a child protection prohibition order is to be read as a reference to making an order varying the operation in Western Australia of the recognised order; and
 - (b) a reference in that Part to revoking a child protection prohibition order is to be read as a reference to making an order revoking the recognition of the recognised order.
- (3) In proceedings for failing to comply, in Western Australia, with a recognised order, no proof is required of
 - (a) the making of the recognised order or a variation of it that operates under regulation 25; or
 - (b) the service of such an order or variation on the person who is subject to the order.

25. Variation or revocation of recognised order in a foreign jurisdiction

- (1) If—
 - (a) a recognised order is varied by a foreign court of the foreign jurisdiction in which the order was made; and
 - (b) notice of the variation is given to the registrar of the relevant court by an officer of the foreign court,

the variation operates in Western Australia as if the recognised order, as varied, was recognised under regulation 23 on the day on which the registrar received notice of the variation.

- (2) If—
 - (a) a recognised order is revoked by a foreign court of the foreign jurisdiction in which the order was made; and
 - (b) notice of the revocation is given to the registrar of the relevant court by an officer of the foreign court,

the recognition in Western Australia of the recognised order is revoked from the day on which the registrar receives notice of the revocation.

(3) A registrar who is given notice of the variation or revocation of a recognised order by a foreign court is to notify the Commissioner accordingly.

26. Forms

The forms set out in Schedule 1 are prescribed in relation to the matters specified in those forms.

6. Schedule 1 amended

Schedule 1 is amended by deleting "[r. 22]" and inserting instead —

" [r. 26] ".

WASTE MANAGEMENT AND RECYCLING ACCOUNT

Changes to Funded Programs

1. INTRODUCTION OF ZERO WASTE PLAN DEVELOPMENT SCHEME

In August 2006, the Waste Management Board oversaw the release of a discussion paper foreshadowing a requirement that all organisations wishing to access funds from the Waste Management and Recycling Account need to firstly develop, maintain and implement an approved Zero Waste Plan. This paper can be downloaded at http://www.zerowastewa.com.au/communication/publications/wm/

The State Government considers the adoption and implementation by local government of Zero Waste Plans to be a vital first step in facilitating the behavioural changes required to work towards zero waste in Western Australia. Zero Waste Plans will also aid in the collection of waste data as stakeholders demonstrate their progress towards achieving the outcome of zero waste.

The Department of Environment and Conservation has worked closely with local government representatives on the Zero Waste Plan Working Group to further develop the concept.

This new scheme is one of a number of schemes that will replace the former Resource Recovery Rebate Scheme, following the review of the Waste Management and Recycling Fund in September 2004. As other new schemes are developed, details will be published accordingly.

1.1 Principles of the Zero Waste Plan Development Scheme

The principle of the Zero Waste Plan Development Scheme is to assist local government with the preparation of Zero Waste Plans. The Scheme is designed to facilitate enhanced planning for municipal waste management and recycling by local governments and regional councils and to align these efforts with the State's vision of *Towards Zero Waste*.

1.2 Objectives of the Zero Waste Plan Development Scheme

An objective of the Scheme is to assist local government in Western Australia to move towards the vision of zero waste. Under this vision—

- · All Western Australians will move towards a waste-free society.
- The Government is to promote a shift away from solely focusing on reducing the amount of
 waste disposed to landfill towards the management of the whole lifecycle of every product and
 its wastes, from creation to disposal.
- The prevention of waste will become the main focus.
- Waste prevention will be achieved through active decisions made to anticipate where the generation of waste begins, and to stop this from occurring.
- Everyone in the community has a role in preventing waste, being more efficient in the use of resources and in the management of waste.
- We must also continue to manage the wastes that are being created through recovery and responsible disposal.

A further objective of the Scheme is to encourage local governments to take a regional view of waste management and recycling and to develop collaborative approaches with neighbouring local governments to work towards the vision of Zero Waste in Western Australia.

1.3 Two Phase Release of the Scheme

The Scheme will include a financial incentive to work collaboratively with other local governments and to produce regional Zero Waste Plans. The Scheme will be split into two funding phases with the total cost of the Scheme being approximately \$3.1 million, which will be funded from the Waste Management and Recycling Account.

Phase 1 of the Scheme will include an initial funding arrangement with local governments and regional councils for the completion of an online data-gathering survey. Each local government will be allocated \$5000 to assist with costs associated with the completion of this survey.

Phase 2 of the Scheme will involve additional funding arrangements with local governments and regional councils to assist with costs associated with developing their Zero Waste Plans. Funding amounts will vary between local governments depending on whether they are metropolitan or non-metropolitan-based, a member of a regional council or are working collaboratively with neighbouring local governments. It is anticipated that the details of Phase 2 will be released later in the year. It is important for all local governments to note that Phase 2 will constitute a separate funding arrangement and will be Gazetted accordingly.

1.4 Funding for Phase 1 of the Scheme

In order to receive funding for Phase 1 of the Scheme each local government or regional council must submit an Application for Funding (Application) along with a valid claim for payment made out to the Department of Environment and Conservation in the form of a Tax Invoice. The form for the Application will be sent to each local government and regional council with information on how to apply.

Ministerial Conditions (**Conditions**) are imposed on the granting of each Application. The Conditions are published in this issue of the Gazette. The Conditions include completing and submitting electronically the 'Zero Waste Plan Development Scheme Phase 1 on-line Survey' accessible on (www.zerowastewa.com.au/zerowasteplans/survey).

1.5 Enforcement

Pursuant to section 110H(6)(a) any person or body who fails to ensure that fund monies are expended for the purposes of the Scheme and in accordance with the Conditions commits an offence the maximum penalty for which is \$5000.00.

Ministerial Conditions for Phase 1 of the Zero Waste Plan Development Scheme

In accordance with section 110H(5) (when read with s110H(6)) of the *Environmental Protection Act 1986*, I, David Templeman, being the Minister for the Environment; Climate Change; Peel, on granting a local government's or a regional council's application for funding from the Waste Management and Recycling Account for Phase 1 of the Zero Waste Plan Development Scheme (**Phase 1 of the Scheme**) impose the following conditions—

- 1. Information regarding Phase 1 of the Scheme concerning baseline characteristics of municipal waste management in this State is to be provided in the form of the 'Zero Waste Plan Development Scheme Phase 1 on-line Survey' accessible on (www.zerowastewa.com.au/zerowasteplans/survey) (the Survey Form).
- 2. The Survey Form is to be completed electronically on-line, in its entirety, at the website described in paragraph 1 of these conditions by typing responses to all of the relevant questions that appear on the Survey Form.
 - (The Survey Form completed in the manner described in paragraphs "1" and "2" of these conditions is hereinafter referred to as the "Completed Survey")
- 3. The Completed Survey is to be submitted electronically on-line at the website described in paragraph "1" of these conditions by following the instructions appearing after the final question of the Completed Survey by no later than 4:00pm on 29 June 2007.
- 4. The record/s (including any "document" as defined in section 5 of the *Interpretation Act 1984*) from which information is used for the Completed Survey are securely stored and properly maintained for a period of not less than five years from the date that the Completed Survey is submitted as described in paragraph "3" of these conditions.
- 5. The local government or regional council Chief Executive Officer (**CEO**) is to comply with the Undertaking made by the CEO in the Application for Funding for the local government or regional council that the CEO represents.

Any person or body who fails to ensure that fund monies are expended for the purposes of the Scheme and in accordance with the Conditions commits an offence, the maximum penalty for which is \$5000.00 (section 110H(6)(a)).

Notice of Areas Closed to Fishing for Prawns

Notice No. 1 of 2007

- I, Peter Millington, Chief Executive Officer of the Department of Fisheries, in accordance with clause 12 of the *Broome Prawn Managed Fishery Management Plan 1999* (the Plan), do hereby—
 - 1 Cancel Notice No. 1 of 2006, dated 8 May 2006; and
 - 2 Prohibit fishing for prawns in those parts of the Broome Prawn Managed Fishery (the Fishery), as described in the Plan, between the dates and times provided for in paragraphs (a) and (b) below—
 - (a) Fishing for prawns is prohibited in all waters described in Schedule 2 of the Plan from the date of gazettal of this notice until 1700 hours Western Standard Time (WST) on 8 June 2007; and
