Local Government Act 1995

# **Northam District Order 2007**

Made by the Governor in Executive Council.

### 1. Citation

This order is the Northam District Order 2007.

# 2. Terms used in this Order

In this Order —

"Act" means the Local Government Act 1995;

"new district" means the district declared, named and designated under clause 4;

"new shire" means the local government of the new district;

### "poll day 2007" means —

- (a) 20 October 2007; or
- (b) if another day for the holding of polls is fixed under section 4.7(2) of the Act
  - (i) for all local governments; or
  - (ii) for the new shire or for local governments, or a class of local governments, including the new shire,

that other day.

### 3. Districts abolished

The districts called the Shire of Northam and the Town of Northam are abolished on 1 July 2007.

# 4. District declared

- (1) As from and including 1 July 2007 the area of the State described in Schedule 1 is declared to be a district.
- (2) The district is named Northam.
- (3) The district is designated a shire.

### 5. District divided into wards

- (1) The new district is divided into 4 wards.
- (2) The 4 wards are named
  - (a) Central Ward;
  - (b) East Ward;
  - (c) Town Ward;
  - (d) West Ward.
- (3) The boundaries of each of the 4 wards are set out in Schedule 2.

### 6. Councillors for new shire

- (1) The number of offices of councillor on the council of the new shire is 10.
- (2) The number of offices of councillor for each ward is
  - (a) for the Central Ward -2;
  - (b) for the East Ward 1;
  - (c) for the Town Ward 5;
  - (d) for the West Ward -2.

(3) The first president of the new shire is to be elected by the council of the new shire from among the councillors under Schedule 2.3 Division 1 of the Act.

### 7. Polling day for inaugural election

Any poll needed for the elections to be held under section 4.2 of the Act to elect councillors of the first council of the new shire is to be held on poll day 2007.

### 8. Commissioner for the new shire appointed

- (1) Gavan John Troy of 64 Ellenbrook Drive, The Vines, is appointed to be the commissioner of the new shire.
- (2) The appointment made by this clause takes effect on 1 July 2007 and ends when the offices of members of the council of the new shire are filled for the first time and the council holds its first meeting.

### 9. Statutory appointments continued

If immediately before 1 July 2007 a person holds an appointment made under a written law by the Shire of Northam or the Town of Northam for the purpose of enforcing or administering that written law, then on 1 July 2007 the person is to be taken to have been appointed by the new shire under that law for those purposes.

# 10. Plan for the future, Act s. 5.56 modified

The new shire is not required to prepare a plan under section 5.56 of the Act in the financial year ending on 30 June 2008.

# Schedule 1 — Northam district boundaries

The Northam district is that portion of land bounded by lines starting from the northernmost north-western corner of Lot 50, as shown on Diagram 8012, and extending south-easterly, southwesterly and again south-easterly along boundaries of that lot to a north-western corner of Lot 3995, as shown on Deposited Plan 224749;

then south-westerly and south-easterly along the northernmost northwestern and south-western boundaries of that lot to the north-eastern corner of Lot 2727, as shown on Deposited Plan 257267;

then south-easterly and south-westerly along the north-eastern and the southernmost south-eastern boundaries of that lot and onwards to the north-eastern boundary of Lot 16441, as shown on Deposited Plan 252400;

then south-easterly along that boundary and south-easterly along the north-eastern boundaries of Lot 16507, as shown on Deposited Plan 252428, and Lot 3274, as shown on Deposited Plan 255058, to the easternmost north-eastern corner of Lot 16988, as shown on Deposited Plan 255057;

then south-easterly along the easternmost north-eastern boundary of that lot and south-easterly along the north-eastern boundary of the western severance of Lot 10985, as shown on Deposited Plan 133769, and onwards to the north-western boundary of Lot 5, as shown on Plan 12085;

then south-westerly and south-easterly along the north-western and south-western boundaries of that lot and onwards to the north-western corner of Lot 12, as shown on Plan 21769;

then south-easterly along the south-western boundary of that lot and south-easterly along the westernmost south-western boundary of Lot 11, to the north-western corner of Lot 100, as shown on Deposited Plan 300062;

then south-easterly along the south-western boundary of that lot and onwards to and south-easterly along the south-western boundary of Lot 101, to the north-western corner of the north-western severance of Lot 256, as shown on Deposited Plan 132674;

then south-easterly and easterly along the south-western and southern boundaries of that severance to the western corner of Lot 24442, as shown on Deposited Plan 224897;

then easterly along the southern boundary of that lot and easterly along the southern boundary of the south-eastern severance of Lot 256, as shown on Deposited Plan 132674 to the south-western boundary of the north-western severance of Lot 2294, as shown on Deposited Plan 249166;

then south-easterly along that boundary and onwards to the northwestern corner of the central severance of that lot;

then south-easterly along the south-western boundary of that severance and onwards to the north-western corner of the southern severance of Lot 2294;

then south-easterly along the south-western boundary of that lot and onwards to the south-eastern boundary of the south-western severance of Lot 7540, as shown on Deposited Plan 119640;

then south-westerly along that boundary to the eastern corner of Lot 7239, as shown on Deposited Plan 119422;

then generally south-westerly along boundaries of that lot to the northernmost north-western corner of Lot 3022, as shown on Deposited Plan 224856;

then south-westerly and south-easterly along the north-western and south-western boundaries of that lot to its southern corner;

then easterly to the western corner of Lot 600, as shown on Deposited Plan 302943;

then south-easterly along the westernmost south-western boundary of that lot and south-easterly along the south-western boundary of

Lot 3113, as shown on Deposited Plan 224856, to the north-western corner of Lot 101, as shown on Deposited Plan 300100;

then south-westerly, south-easterly, north-easterly, and again southeasterly along boundaries of that lot to the north-eastern corner of the north-eastern severance of Lot 2833, as shown on Deposited Plan 100717;

then south-easterly and south-westerly along the north-eastern and south-eastern boundaries of that severance and onwards to the southeastern corner of the south-western severance of that lot;

then south-westerly along the south-eastern boundary of that severance and south-westerly along the south-eastern boundaries of Lot 1251, as shown on Deposited Plan 249081, and Lot 19080, as shown on Deposited Plan 87148 and onwards to the south-eastern corner of the north-western severance of Lot 1233, as shown on Deposited Plan 247348;

then south-easterly to and along the north-eastern boundary of the south-eastern severance of Lot 1233 to the north-western boundary of Lot 1417, as shown on Deposited Plan 249054;

then north-easterly, south-easterly and south-westerly along boundaries of that lot to the south-eastern corner of Lot 1, as shown on Deposited Plan 224602;

then north-westerly and generally south-westerly along the northeastern and north-western boundaries of that lot and south-westerly along the north-western boundary of Lot 2 to the north-eastern corner of Lot 3;

then south-westerly and north-westerly along boundaries of that lot to its north-western corner;

then south-westerly to the right bank of the Mortlock River;

then generally westerly downwards along that bank to the prolongation north-westerly of the south-western boundary of Caljie Agricultural Area Lot 64 (Reserve 826), as shown on Deposited Plan 127881;

then south-easterly to and south-easterly and north-easterly along the south-western and south-eastern boundaries of that lot and northeasterly along the southernmost south-eastern boundary of Caljie Agricultural Area Lot 41 (Reserve 826), as shown on Deposited Plan 22433 to the left bank of the Mortlock River; then generally south-easterly upwards along that bank and the left bank of the Mortlock River East Branch to the prolongation northeasterly of the southernmost south-eastern boundary of Lot 65, as shown on Deposited Plan 127882;

then south-westerly to and along that boundary and south-westerly along the westernmost south-eastern boundary of Lot 25

(Reserve 2454), as shown on Deposited Plan 37644, to the northeastern corner of the north-western severance of Lot 3, as shown on Plan 15998;

then south-westerly along the north-western boundary of that severance to a north-eastern corner of Lot 102, as shown on Diagram 91610;

then south-easterly and south-westerly along the easternmost northeastern and southernmost south-eastern boundaries of that lot to the eastern corner of Lot 1, as shown on Diagram 72227;

then north-westerly, south-westerly, again north-westerly and again south-westerly along boundaries of that lot to an eastern side of Parker Road;

then southerly along that side and onwards to the westernmost northwestern corner of Lot 35, as shown on Deposited Plan 224282;

then southerly along the western boundary of that lot to the prolongation north-easterly of the south-eastern boundary of the north-western severance of Lot 4383, as shown on Deposited Plan 224709;

then south-westerly along that prolongation to the prolongation southeasterly of the north-eastern boundary of that lot;

then north-westerly to and along that boundary to the south-eastern corner of Lot 1459, as shown on Deposited Plan 249065;

then north-westerly and south-westerly along the north-eastern and north-western boundaries of that lot to the easternmost north-eastern boundary of the eastern severance of Lot 1641, as shown on Deposited Plan 247055;

then north-westerly, south-westerly, south-easterly, again southwesterly and again north-westerly along boundaries of that severance and onwards to a south-western side of Grass Valley South Road;

then north-westerly, north-easterly and again north-westerly along sides of that road to the south-eastern corner of Lot 1, as shown on Diagram 93692;

then north-westerly along the easternmost south-western boundary of that lot to the southernmost south-eastern corner of portion of former Avon Location 1807, as shown on Deposited Plan 247302 (cancelled Certificate of Title Volume 1343 Folio 462);

then north-westerly and generally north-easterly along boundaries of that former location to a south-western side of Grass Valley South Road;

then north-westerly and south-westerly along sides of that road to the south-eastern side of Gentle Road;

then south-westerly along that side to the north-eastern corner of Lot 368, as shown on Deposited Plan 224709;

then south-westerly along the northernmost north-western boundary of that lot and south-westerly along the north-western boundary of Lot 4, as shown on Diagram 14053 to the south-eastern corner of Lot 8, as shown on Diagram 10231;

then north-westerly along the north-eastern boundary of that lot to the easternmost south-eastern corner of Lot 7, as shown on Diagram 5699;

then north-westerly and south-westerly along the easternmost northeastern and north-western boundaries of that lot to the north-eastern boundary of Lot 50, as shown on Deposited Plan 45701;

then north-westerly and generally south-westerly along north-eastern and north-western boundaries of that lot to a north-eastern side of the Northam-York Road;

then north-westerly along that side to the prolongation north-easterly of the southernmost south-eastern boundary of Lot 550, as shown on Deposited Plan 302411;

then south-westerly to and along that boundary and south-westerly along the south-eastern boundaries of Lot 2, as shown on Plan 3125 and Lot 301 (Reserve 30718), as shown on Deposited Plan 46601, and onwards to the south-eastern corner of Lot 300 (Reserve 30718); then south-westerly along the south-eastern boundary of that lot and onwards to the south-eastern corner of Lot 57, as shown on

Plan 24167;

then south-westerly along the south-eastern boundary of that lot and south-westerly along the south-eastern boundary of Lot 56, as shown on Diagram 100323 to its south-western corner;

then south-westerly to a south-eastern side of Leaver Road;

then south-westerly and south-easterly along sides of that road to the easternmost north-eastern corner of Lot 27712, as shown on Deposited Plan 210570;

then south-easterly and south-westerly along the easternmost northeastern and south-eastern boundaries of that lot and onwards to the north-eastern boundary of Lot 27706, as shown on Deposited Plan 210571;

then north-westerly along that boundary to the south-eastern corner of Lot 27707, as shown on Deposited Plan 210570;

then westerly, north-westerly and northerly along boundaries of that lot to the easternmost south-eastern boundary of Lot 5, as shown on Plan 15239;

then south-westerly, south-easterly and generally south-westerly along boundaries of that lot to the prolongation north-westerly of the easternmost north-eastern boundary of Lot 27695, as shown on Deposited Plan 207011;

then south-easterly to the north-eastern corner of that lot;

then south-easterly, southerly and generally south-easterly along sides of Berry Brow Road to the north-western corner of Lot 27700, as shown on Deposited Plan 207014;

then generally southerly, easterly, southerly and generally southeasterly along boundaries of that lot to the prolongation north-easterly of the north-western side of former unnamed road (Road Number 6109), as shown on Deposited Plan 201913;

then south-westerly to and generally south-westerly along sides of that former road to the north-eastern corner of the northern severance of Lot 5, as shown on Plan 6754;

then westerly along the northern boundary of that severance and westerly along the northern boundaries of the northern severance of Lot 4 and the north-eastern severance of Lot 3 and onwards to the northernmost north-eastern corner of the south-western severance of Lot 3;

then westerly along the northern boundary of that severance and westerly along the northern boundaries of Lots 2 and 1 and onwards to the north-eastern corner of Lot 5, as shown on Diagram 28855; then westerly along the northern boundary of that lot and westerly along the northern boundaries of Lot 4 and Lot 11, as shown on

Diagram 32848 to the north-eastern corner of Location 28808 (Reserve 6203);

then westerly along the northern boundary of that location and westerly along the northern boundary of the eastern severance of Location 28380 (State Forest Number 13) and onwards to and westerly along the northern boundary of the northern severance of Location 28380 to the eastern boundary of Lot 2, as shown on Diagram 42237;

then northerly along that boundary and onwards to the southern boundary of Lot 9249, as shown on Deposited Plan 125192;
