LA301*

Land Administration Act 1997

Land Administration (Land Management) Amendment Regulations 2007

Made by the Governor in Executive Council.

1. Citation

These regulations are the *Land Administration (Land Management) Amendment Regulations 2007*.

2. Commencement

These regulations come into operation as follows:

- (a) regulations 1 and 2 — on the day on which these regulations are published in the *Gazette*;
- (b) the rest of the regulations — on the day after that day.

3. The regulations amended

The amendments in these regulations are to the *Land Administration (Land Management) Regulations 2006**.

[* *Published in Gazette 14 June 2006, p. 2085-106.*]

4. Regulation 2 amended

Regulation 2 is amended by inserting in the appropriate alphabetical position —

“

“**owner**” in relation to something on regulated land,
means a person who has a right to immediate
possession of that thing;

”.

5. Regulation 10 amended

Regulation 10(6) is repealed and the following subregulation is inserted instead —

“

(6) A person must not move or otherwise interfere with a vehicle parked on regulated land unless the person is —

- (a) the owner of the vehicle; or
- (b) an authorised person acting under regulation 18.

Penalty:

- (a) in the case of a vehicle that was brought onto the regulated land by an authorised person acting in the course of the person's duties, a fine of \$1 000;
- (b) in any other case, a fine of \$500.

”

6. Regulation 11 replaced

Regulation 11 is repealed and the following regulation is inserted instead —

“

11. Protection of property

(1) A person must not, on regulated land, deface, damage or otherwise interfere with any —

- (a) building, fence, jetty, sign or other structure; or
- (b) road, track or path,

unless the person is an authorised person acting in the course of the person's duties.

Penalty: a fine of \$1 000.

(2) A person must not deface, damage, move or otherwise interfere with any vessel, aircraft, machinery or equipment on regulated land unless the person is —

- (a) the owner of the vessel, aircraft, machinery or equipment; or
- (b) an authorised person acting under regulation 18.

Penalty:

- (a) in a case where the vessel, aircraft, machinery or equipment was brought onto the regulated land by an authorised person acting in the course of the person's duties, a fine of \$1 000;
- (b) in any other case, a fine of \$500.

”

7. Regulation 18 amended

Regulation 18(3)(a) is amended by deleting “property” and inserting instead —

“ a thing ”.

8. Regulation 21 amended

Regulation 21(4) is repealed.

LIBRARY ADVISORY COMMITTEE AMENDMENT LOCAL LAW 2007

Under the powers conferred by the *Local Government Act 1995* and under all other powers enabling it, the City of Fremantle resolved on 25 July 2007 to make the *City of Fremantle Library Advisory Committee Amendment Local Law 2007*.

In this local law, the *City of Fremantle Library Advisory Committee Local Law* as published in the *Government Gazette* on 18 May 2001 is referred to as the principal local law. The principal local law is amended as follows:

1. Subclause 2(a) amended

Delete subclause 2(a) and substitute—

“ 2(a) At its first meeting after each local government ordinary election, the Council shall appoint an Advisory Committee for the purpose of advising the Council regarding the management and control of the Library. ”

2. Subclause 3(a) amended

Delete subclause 3(a) and substitute—

“ (a) The Chairperson shall be elected at the first meeting of the Committee after each local government ordinary election. ”

City of Bunbury

AMENDMENT LOCAL LAW RELATING TO ADVERTISING DEVICES 2007

Under the powers conferred by the *Local Government Act 1995* and under all other powers enabling it, the Council of the City of Bunbury resolved on 3rd July 2007 to make the *City of Bunbury Amendment Local Law Relating to Advertising Devices 2007*.

The City of Bunbury Local Law Relating to Advertising Devices published in the *Government Gazette* on 24 March 2003 is referred to as the principal local law. The principal local law is amended as follows.

1. Repeal

Delete the Repeal clause and substitute with—

“The Municipality of the City of Bunbury By-laws Relating to Signs, Hoardings and Bill Posting as published in the Government Gazette on 27 January 1984 and as amended and published in the Government Gazette on 29 October 1999 is hereby repealed.”

2. Definitions

Delete after the Citation clause the word “Definitions”.

3. Application

Insert, after the Citation clause the words—

“Application

This Local Law shall apply to all land within the District of the City of Bunbury.”

4. Clause 1.1

In the heading of clause 1.1, delete the word “Definitiiions” and substitute with the word “Definitions”.

5. Clause 2.3

In subclause 2.3(i), after the words “unless exempted under this” delete the word “policy” and substitute with the words “Advertising Devices Policy”.

6. Clause 2.6

Delete subclauses 2.6.1, 2.6.2 and 2.6.3.

7. Clause 2.13

Delete clause 2.13.

8. Clause 3.2

In subclause 3.2.3 after the words “offence under section 3.2.2” delete the words “or against a clause of the Advertising Devices Policy (where the policy states that a breach of the clause is an offence)”.

9. Clause 3.6

In subclause 3.6.2 after the words “damages or otherwise, against” delete the words “the local government or” and substitute with the word “an”.

10. Clause 3.7

In subclause 3.7.1, after the words “An offence against section 2.1.2, 2.3, 2.8, 2.11” delete “3.2.1 or against a clause of the Advertising Devices Policy (where the policy states that a breach of the clause is an offence)”. Delete “,” before “2.11” and substitute with the word “or”.

11. Clause 3.8

Delete the words “Offender for Purposes of Section 2.1.2” in the heading of clause 3.8 and substitute with the word “Averments”.

12. Clause 3.8

Delete subclause 3.8.1.

13. Clause 3.8

In subclause 3.8.2 delete the subclause number “3.8.2” and substitute with “3.8.1”.

14. Clause 4.1

In subclause 4.1.1 after the word “means” delete “Sign, Hoardings and Bill Posting Local Laws” and insert the words “*The Municipality of the City of Bunbury By-laws Relating to Signs, Hoardings and Bill Posting as published in the Government Gazette on 27 January 1984 and as amended and published in the Government Gazette on 29 October 1999.*”

15. Division 5

Delete clauses 5.1, 5.2, 5.3 and 5.4.

16. Schedule 1 Form 1

In Schedule 1 Form 1 after the words “Contrary to the Advertising Devices Local” the word “Laws” is to be deleted and substituted with the word “Law”.

17. Schedule 1

In Schedule 1, Form 2 is to be inserted after Form 1 as follows—

Under the powers conferred by the *Local Government Act 1995* and under all other
powers enabling it, the Council of the City of Bunbury resolved on 12 June 2007 to
make the *City of Bunbury Private Property Amendment Local Law 2007*.

The City of Bunbury Private Property Local Law as published in the *Government
Gazette* on 3 December 2003 is referred to as the principal local law. The principal
local law is amended as follows.

- 1. Heading of Clause 2.8 amended**
Delete the heading of clause 2.8 and insert—
‘Electrified or razor wire fences and broken glass’.

2. Clause 2.8(1) amended

Delete clause 2.8(1) and insert—

‘2.8(1) An owner or occupier of a lot shall not wholly or partly install, construct or use electrified fencing on the lot, without first obtaining the written approval of the local government.’

3. Clause 2.8(2) amended

Delete clause 2.8(2) and insert—

‘(2) An owner or occupier of a lot shall not on the lot—

- (a) install, use or construct a fence made wholly or partially of razor wire; or
- (b) affix or allow to remain as part of any fence or wall on the lot, whether internal or external, any broken glass.’

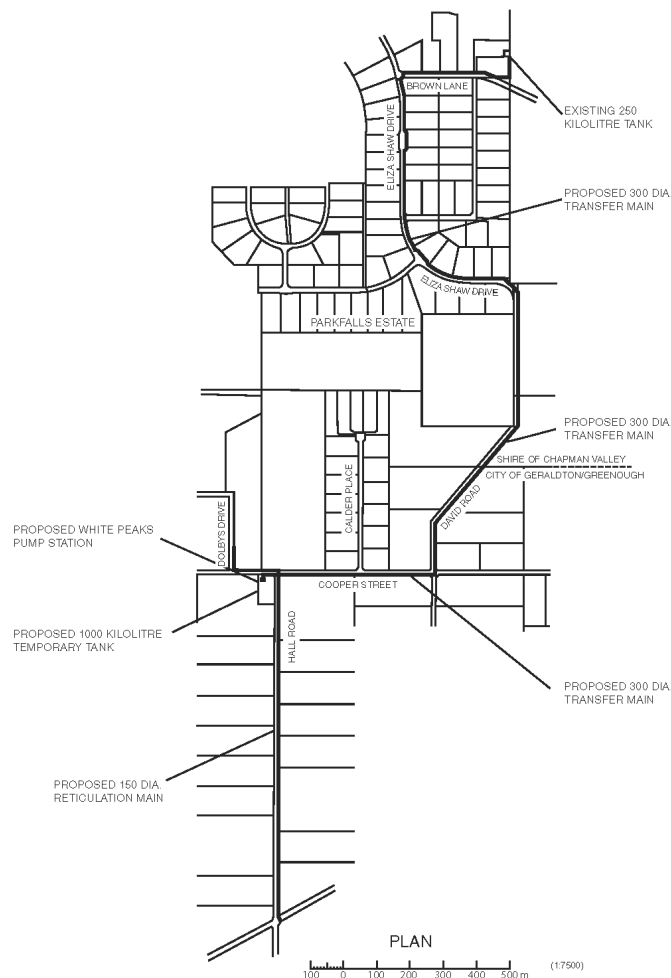
Proposal to Construct a Temporary Steel Tank, Pump Station, 300mm DIA. Transfer Main and 150mm DIA. Reticulation Main

To service the new Parkfalls Estate within the Shire of Chapman Valley and the City of Geraldton/Greenough, and the areas north with water, the Water Corporation proposes to construct the following works—

- A pump station of approximately 6 metres square x 3 metres high constructed from colourbond steel sheeting.
- A 1000 kilolitre capacity temporary storage tank approximately 6 metres high and 18 metres diameter, constructed from colourbond steel sheeting
- Approximately 3851m of 300mm diameter PVC main connecting from the proposed pump station site to the Parkfalls Estate.
- Approximately 1700m of 150mm diameter PVC reticulation main.

The location of the proposed works is within the Shire of Chapman Valley and the City of Geraldton/Greenough as shown on the plan. The proposed works are scheduled to commence in September 2007, and will continue for a duration of approximately 4 months. The pipeline will be laid below ground and constructed using open trench excavation, which will be backfilled and restored.
