Made by the Minister under Section 4(2).

1. Citation

This order may be cited as the *Exotic Diseases of Animals (Equine Influenza) Order 2007*.

2. Declaration

The disease Equine Influenza is hereby declared to be a disease to which the *Exotic Diseases of Animals Act 1993* applies.

EXOTIC DISEASES OF ANIMALS ACT 1993**DISEASE CONTROL ORDER**

Made by the Minister for Agriculture and Food under section 41(1) of the *Exotic Diseases of Animals Act 1993*.

EXOTIC DISEASES OF ANIMALS ACT 1993**IMPORT RESTRICTION ORDER NO. 01/2007**

Made by the Minister of Agriculture and Food under section 24 of the *Exotic Diseases of Animals Act 1993*.

Equine Influenza has been strongly suspected in the state of NSW.

The entry or importation into Western Australia of the following things is prohibited—

All horses, donkeys and mules from all states and territories outside of Western Australia are prohibited from being brought in to Western Australia.

This order applies until 23 September 2007.

EXOTIC DISEASES OF ANIMALS ACT 1993**CONTROLLED AREA ORDER NO. 01/2007**

Made by the Minister for Agriculture and Food under section 40 of the *Exotic Diseases of Animals Act 1993*.

For the purposes of prevention of infection and control of the spread of equine influenza the whole of the state of Western Australia is declared to be an area in relation to which a Control Order may be made.

A Control Order made for the declared area may be made for the control of the following species of animals and classes or description of animals and animal products—

Horses, mules and donkeys

EXOTIC DISEASES OF ANIMALS ACT 1993**CONTROL ORDER NO. 03/2007**

Made by the Chief Veterinary Officer / Veterinary Inspector under section 40(3) of the *Exotic Diseases of Animals Act 1993*.

This Control Order is in relation to the Controlled Area described in Controlled Area Order No. 02/2007, dated 25 August 2007.

The following disease control measures apply to the listed species of animals and listed classes or descriptions of animals and animal products—

Item	Disease control measure
Horse, Donkey, Mule	National standstill Racing clubs and other equine organisations are required to cancel or postpone any meetings or events until further notice. For events already underway, organisers are requested to contact the State Department of Agriculture regarding advice on how to manage the standstill in relation to these events.
