#### PARKING AND PARKING FACILITIES AMENDMENT LOCAL LAW 2007

Under the powers conferred by the Local Government Act 1995, and under all other powers enabling it, the Council of the City of Armadale resolved on 2 July 2007 to make the 'City of Armadale Parking and Parking Facilities Amendment Local Law 2007'

In this local law, the City of Armadale Parking and Parking Facilities Local Law as published in the *Government Gazette* on 29 April 2003 is referred to as the principal local law. The principal local law is amended as follows—

#### Clause 1.3 is amended

(a) In clause 1.3 the definition of a "motorcycle" and note is deleted and replaced with—

'motorcycle' has the meaning given to it by the Code;

Note: The Code defines 'motorcycle' to mean-

"a motor vehicle that has 2 wheels and includes—

- (a) a 2-wheeled motor vehicle with a sidecar attached to it that is supported by a third wheel; and
- (b) a motor vehicle with 3 wheels that is ridden in the same way as a motor vehicle with 2 wheels,

but does not include any trailer"

(b) In clause 1.3 the definition of 'symbol' the reference to Australian Standard 1742.11-1989 is deleted and replaced with Australian Standard 1742.11.1999.

#### Clause 2.3 is amended

- (a) Clause 2.3(2) is deleted.
- (b) Clause 2.3(3) is amended by deleting "(3)" and inserting "(2)".

#### Clause 3.5 is amended

Clause 3.5(2) is amended by deleting the words "A person shall not park a vehicle so that any portion of the vehicle is" and inserting "Subject to any law relating to intersections within traffic control signals a person shall not park a vehicle so that any portion of the vehicle is"

#### Clause 5.1 is amended

Clause 5.1(b) is amended by deleting the words "a motor vehicle taking up or setting down passengers" and inserting "a motor vehicle that completes the dropping off or picking up of passengers within two (2) minutes of stopping and then drives on".

- (c) Clause 9.1(3) is amended by replacing the words "these Local Laws" with "this Local Law".
- (d) Clause 9.1(4) is amended by replacing the words "Local Government" with "local government".
- (e) Clause 9.1 is amended by-
  - (i) Inserting paragraph number "(5)" before "Where an authorised person finds...."
  - (ii) Inserting paragraph number "(6)" before "Where an authorised person removes...."; and
  - (iii) Inserting paragraph number "(7)" before "A notice".
- (e) The newly numbered clause 9.1(5) is amended by replacing the words "authorised person" with "Authorised Person".
- (f) The newly numbered clause 9.1(6) is amended by replacing the words "Local Government" with "local government", "these Local Laws" with "this local law" and "authorised person" with "Authorised Person".
- (g) The newly numbered clause 9.1(7) is amended by replacing the words "these Local Laws" with "this local law" and inserting a full stop after "3"

#### Schedule 2 is amended

# Shire of Carnarvon (Change of Ward Boundaries and Representation) Order 2007

Made by the Governor in Executive Council, on the recommendation of the Minister.

#### 1. Citation

This order is the *Shire of Carnarvon (Change of Ward Boundaries and Representation) Order 2007.* 

#### 2. Terms used in this order

In this order —

# "Gascoyne/Minilya North Ward" means the

Gascoyne/Minilya North Ward described in the *Shire of Carnarvon (Ward Boundaries and Representation) Order No. 1, 1995 (Gazette 13 January 1995)* as amended by the *Districts of Carnarvon and Exmouth (Change of Boundaries) Order 2000 (Gazette 28 April 2000)*;

# "Gascoyne/Minilya South Ward" means the

Gascoyne/Minilya South Ward described in the *Shire of Carnarvon (Ward Boundaries and Representation) Order No. 1, 1995 (Gazette* 13 January 1995);

"next election day" means the first ordinary elections day after this order takes effect.

#### 3. Abolition of wards (s. 2.2 of the Act)

On the next election day the Gascoyne/Minilya North Ward and the Gascoyne/Minilya South Ward are abolished.

# 4. Creating new wards (s. 2.2 of the Act)

- (1) On the next election day the Coral Bay Ward is created, and consists of the land described in Schedule 1.
- (2) On the next election day the Gascoyne/Minilya Ward is created, and consists of the portion of land comprising the former Gascoyne/Minilya North Ward and the former Gascoyne/Minilya South Ward that is not included in the Coral Bay Ward.

# 5. Number of councillors in the Shire (s. 2.18 of the Act)

On and from the next election day the number of offices of councillor for the Shire of Carnaryon is 7.

## 6. Number of councillors in each ward (s. 2.18 of the Act)

On and from the next election day the number of offices of councillor for —

- (a) the Town Ward is 4; and
- (b) the Coral Bay Ward is 1; and
- (c) the Gascoyne/Minilya Ward is 1; and
- (d) the Plantation Ward is 1.

# 7. Councillor for Coral Bay Ward (s. 9.62 of the Act)

- (1) The person who is the councillor for the Gascoyne/Minilya North Ward immediately before the next election day is taken to have been elected, on the next election day, as the councillor for the Coral Bay Ward.
- (2) Subclause (1) does not affect the term of office of the councillor.

# Schedule 1 — Description of Coral Bay Ward

All that portion of land bounded by lines starting from the intersection of the prolongation northwesterly of the northeastern boundary of Lot 306 as shown on Deposited Plan 52556, with the Low Water Mark of the Indian Ocean, a point on a present western boundary of the Shire of Carnarvon; thence southeasterly to and along that boundary to the northwestern boundary of Lot 308; thence northwesterly along that boundary and westerly and southerly along northern and eastern boundaries of that lot to the northwestern corner of Lot 309; thence southeasterly along the northeastern boundary of that lot and onwards to the western corner of Lot 513 as shown on Deposited Plan 53813; thence southeasterly and southerly along southwestern and western boundaries of that lot and onwards to an easternmost northeastern corner of Lot 320 as shown on Deposited Plan 53672; thence southerly and westerly along eastern and southern boundaries of that lot to the eastern boundary of Lot 315 as shown on Deposited Plan 54580; thence southerly, westerly and northerly along eastern, southern and western boundaries of that lot to a southeastern corner of Lot 320 as shown on Deposited Plan 53672; thence westerly along a southern boundary of that lot to the easternmost northeastern corner of Lot 316 as shown on Deposited Plan 54580; thence southerly, westerly, northwesterly, again westerly, again southerly, again westerly and northerly along boundaries of that lot to the westernmost southeastern corner of Lot 320 as shown on Deposited Plan 53672; thence westerly along a southern boundary of that lot to an eastern boundary of Lot 321; thence southerly, generally southwesterly, southeasterly, again southwesterly, northwesterly, generally northeasterly, again southeasterly, generally northeasterly

and northerly along boundaries of that lot to the southernmost southeastern corner of Lot 319; thence westerly along the southern boundary of that lot and onwards to the Low Water Mark of the Indian Ocean, a point on a present western boundary of the Shire of Carnarvon and thence generally northwesterly, generally northwesterly, generally northwesterly along that mark to the starting point.
