I, the Governor, acting under Sections 13 and 24 of the Main Roads Act 1930 and on the recommendation of the Commissioner of Main Roads, declare—

- (a) that the roads or sections of roads as shown on the drawings listed in Schedule 1 to this proclamation, excluding any footpaths, shall be highways;
- (b) that the roads or sections of roads as shown on the drawings listed in Schedule 2 to this proclamation, including any footpaths, shall be highways;
- (c) that the roads or sections of roads as shown on the drawings listed in Schedule 3 to this proclamation shall cease to be main roads.
- (d) that the roads or sections of roads as shown on the drawings listed in Schedule 4 to this proclamation, excluding any footpaths, shall be main roads;
- (e) that the roads or sections of roads as shown on the drawings listed in Schedule 5 to this proclamation shall cease to be secondary roads.

Town Planning Scheme No. 3—Amendment No. 218

It is hereby notified for public information, in accordance with section 87 of the Planning and Development Act 2005 that the Minister for Planning and Infrastructure approved the City of Albany local planning scheme amendment on 3 September 2007 for the purpose of—

- (1) Rezoning Lot 5 Rocky Crossing Road, Albany from the 'Rural' zone to 'Special Residential' zone and Parks & Recreation Reserve.
- (2) Incorporating Lot 5 within Area 12 of Schedule IV—Special Residential Zones—Provision Relating to Specified Areas, of the Scheme Text.
- (3) Incorporating the following additional provisions within Area 12 of Schedule IV—Special Residential Zones—Provisions relating to Specified areas, of the Scheme Text—
 - 1.3 Council will not recommend lots sizes less than 4000m² except where lots are located directly opposite public open space /foreshore reserves and are separated from that reserve by a public road, in which case a minimum lot size of 3000m² may be recommended.
 - 12.0 Site Remediation & Stormwater Management (lot 5)
 - 12.1 Council may request the Commission to impose a condition at the time of subdivision requiring a geotechnical site investigation of the former sand and landfill areas to determine and implement, to the satisfaction of the Department for Environment and Conservation, Land and Water Quality Branch, any remediation and decontamination measures necessary to ensure suitability of the land for residential development.
 - 12.2 Council will request the Commission to impose a condition at the time of subdivision requiring the preparation of a Stormwater Management Plan utilising water sensitive design principles.
 - 12.3. The Manmade dam within the public open space is to be landscaped as part of the recreational node.
- (4) Renumbering of existing Provisions 12.0, 12.1 & 12.2 to 13.0, 13.1 & 13.2
- (5) Amending the Scheme Maps accordingly.
