

Real Estate and Business Agents Act 1978

Real Estate and Business Agents (General) Amendment Regulations (No. 5) 2007

Made by the Governor in Executive Council.

1. Citation

These regulations are the *Real Estate and Business Agents* (General) Amendment Regulations (No. 5) 2007.

2. Commencement

These regulations come into operation as follows:

- (a) regulations 1 and 2 on the day on which these regulations are published in the *Gazette*;
- (b) the rest of the regulations on the day after that day.

3. The regulations amended

The amendments in these regulations are to the *Real Estate and Business Agents (General) Regulations 1979*.

4. Regulation 2 amended

Regulation 2 is amended by inserting in the appropriate alphabetical positions —

۲,

"approved educational activity" means —

- (a) for the calendar year beginning
 1 January 2007 an educational activity
 approved under regulation 4AA(3) of the
 previous regulations; or
- (b) otherwise an educational activity approved under regulation 4AB(1)(a)(ii) or (b);

"mandatory professional development subject" means a professional development subject approved under regulation 4AB(1)(a)(i);

"points", in respect of an approved educational activity, means —

(a) for the calendar year beginning
1 January 2007 — the number of points

"

calculated in accordance with regulation 4AA(7) of the previous regulations; or

(b) otherwise — the number of points specified in respect of that activity under regulation 4AB(1);

"previous regulations" means these regulations as in force immediately before the commencement of the Real Estate and Business Agents (General)
Amendment Regulations (No. 5) 2007;

5. Regulation 4AA replaced by regulations 4AA and 4AB

Regulation 4AA is repealed and the following regulations are inserted instead —

4AA. Prescribed educational requirements — section 31(3)(b)

- (1) This regulation applies only in respect of a licensee
 - (a) who is a natural person; and
 - (b) whose triennial certificate is due to expire on or after 1 January 2008.
- (2) The educational requirements prescribed for the purposes of section 31(3)(b) of the Act are that during each of the preceding 3 full calendar years before the year in which a triennial certificate is due to expire
 - (a) approved educational activities to the total value of at least 10 points have been undertaken; and
 - (b) those activities include at least one activity
 - (i) approved under regulation 4AA(3) in respect of each of the subjects listed in Schedule 1A Division 1 of the previous regulations; or
 - (ii) approved under regulation 4AB(1)(a)(ii) in respect of each mandatory professional development subject approved for that year.
- (3) In respect of a triennial certificate that is due to expire
 - (a) in 2008, the educational requirements prescribed in subregulation (2)(a) and (b) are to be met only in respect of the calendar year beginning 1 January 2007; and
 - (b) in 2009, the educational requirements prescribed in subregulation (2)(a) and (b) are to

be met only in respect of the calendar years beginning 1 January 2007 and 1 January 2008.

- (4) Nothing in these regulations is to be taken to affect the time within which a licensee is to undertake an educational activity under the previous regulations and such activity is to be taken to have been undertaken in respect of the calendar year beginning 1 January 2007.
- (5) In respect of a triennial certificate that is due to expire for the first time after it was granted, the educational requirement prescribed in subregulation (2)(a) and (b) are to be met only in respect of each of the preceding 2 full calendar years before the year in which the certificate is due to expire.
- (6) The value in points accrued by a person in a calendar year is the sum of the points specified for each approved educational activity undertaken by the person in that year.

4AB. Board to approve educational activities

- (1) In respect of each calendar year, commencing with the calendar year beginning 1 January 2008, the Board
 - (a) is to
 - (i) approve 3 of the subjects listed in Schedule 1A as mandatory professional development subjects for that year; and
 - (ii) approve one or more educational activity referred to in subregulation (3) in respect of each subject approved under subparagraph (i);

and

(b) may approve one or more educational activity referred to in subregulation (5) in respect of each other professional development subject listed in Schedule 1A,

and, in respect of each educational activity approved, is to specify the value in points that is to be allotted to undertaking the activity.

- (2) The Board is to ensure that there is published on its website on or before 1 January of the calendar year to which an approval under subregulation (1) relates a notice setting out
 - (a) sufficient details to identify—
 - (i) the 3 mandatory professional development subjects approved under subregulation (1)(a)(i); and

(ii) the educational activity or activities approved in respect of each of those subjects under subregulation (1)(a)(ii);

and

- (b) the value in points that is to be allotted to undertaking each of the activities approved.
- (3) If, in respect of a calendar year, the Board approves one or more educational activity under subregulation (1)(b) it is to ensure that there is published on its website a notice setting out
 - (a) sufficient details to identify
 - (i) each activity approved; and
 - (ii) the professional development subject to which it relates;

and

- (b) the value in points that is to be allotted to undertaking each of the activities approved.
- (4) If a person undertakes, or commences to undertake, an educational activity the details of which are later published on the Board's website as an approved educational activity, then the person does not accrue any points in respect of that activity.
- (5) The following types of educational activities that may be approved under subregulation (1) are
 - (a) attendance, including by means of audiolink or videolink, at a training course provided by a specified body or person and successful completion of any assessment requirements for that course;
 - (b) attendance, including by means of audiolink or videolink, at a seminar presented by a specified body or person and successful completion of any assessment requirements for that seminar;
 - (c) viewing of a specified recording, and successful completion of any assessment requirements for that viewing;
 - (d) participation in a specified course of study, or a specified component of a course of study, and successful completion of any assessment requirements for that course or component.
- (6) In subregulations (1) and (5)
 - "**specified**" means specified by the Board in the notice published under subregulation (2) or (3).
- (7) An approval under subregulation (1) may apply in relation to all licensees to whom regulation 4AA applies, or to any class of such licensees.

"

Settlement Agents Amendment Regulations (No. 4) 2007

Made by the Governor in Executive Council.

1. Citation

These regulations are the Settlement Agents Amendment Regulations (No. 4) 2007.

2. Commencement

These regulations come into operation as follows:

- (a) regulations 1 and 2 on the day on which these regulations are published in the *Gazette*;
- (b) the rest of the regulations on the day after that day.

3. The regulations amended

The amendments in these regulations are to the *Settlement Agents Regulations 1982*.

4. Regulation 2 amended

Regulation 2 is amended by inserting in the appropriate alphabetical positions —

- "approved educational activity" means an educational activity approved under regulation 4C(1)(a)(ii) or (b);
- "core professional development subject" means a professional development subject approved under regulation 4C(1)(a)(i);
- "points", in respect of an approved educational activity, means the number of points specified in respect of that activity under regulation 4C(1);

"

5. Regulations 4B and 4C inserted

After regulation 4A the following regulations are inserted —

"

4B. Prescribed educational requirements — section 31(2a)

- (1) This regulation applies only in respect of a licensee
 - (a) who is a natural person; and
 - (b) whose triennial certificate is due to expire on or after 1 January 2009.
- (2) The educational requirements prescribed for the purposes of section 31(2a) of the Act are that during each of the preceding 3 full calendar years before the year in which a triennial certificate is due to expire
 - (a) approved educational activities to the total value of at least 6 points have been undertaken; and
 - (b) those activities include at least one activity approved under regulation 4C(1)(a)(ii) in respect of 2 of the core professional development subjects approved for that year.

- (3) In respect of a triennial certificate that is due to expire
 - (a) in 2009, the educational requirement prescribed in subregulation (2)(a) and (b) are to be met only in respect of the calendar year beginning 1 January 2008; and
 - (b) in 2010, the educational requirement prescribed in subregulation (2)(a) and (b) are to be met only in respect of the calendar years beginning 1 January 2008 and 1 January 2009.
- (4) In respect of a triennial certificate that is due to expire for the first time after it was granted, the educational requirement prescribed in subregulation (2)(a) and (b) are to be met only in respect of each of the preceding 2 full calendar years before the year in which the certificate is due to expire.
- (5) The value in points accrued by a person in a calendar year is the sum of the points specified for each approved educational activity undertaken by the person in that year.

4C. Board to approve educational activities

- (1) In respect of each calendar year, commencing with the calendar year beginning 1 January 2008, the Board
 - (a) is to
 - (i) approve 4 of the subjects listed in Schedule 1A as core professional development subjects; and
 - (ii) approve one or more educational activity referred to in subregulation (5) in respect of each core professional development subject approved under subparagraph (i);

and

(b) may approve one or more educational activity referred to in subregulation (5) in respect of any other professional development subject listed in Schedule 1A.

and, in respect of each educational activity approved, is to specify the value in points that is to be allotted to undertaking the activity.

- (2) The Board is to ensure that there is published on its website on or before 1 January of the calendar year to which an approval under subregulation (1)(a) relates a notice setting out
 - (a) sufficient details to identify—
 - (i) the 4 core professional development subjects approved under subregulation (1)(a)(i); and

(ii) the educational activity or activities approved in respect of each of those subjects under subregulation (1)(a)(ii);

and

- (b) the value in points that is to be allotted to undertaking each of the activities approved.
- (3) If, in respect of a calendar year, the Board approves one or more educational activity under subregulation (1)(b) it is to ensure that there is published on its website a notice setting out
 - (a) sufficient details to identify
 - (i) each activity approved; and
 - (ii) the professional development subject to which the activity relates;

and

- (b) the value in points that is to be allotted to undertaking each of the activities approved.
- (4) If a person undertakes, or commences to undertake, an educational activity the details of which are later published on the Board's website as an approved educational activity, then the person does not accrue any points in respect of that activity.
- (5) The following types of educational activities that may be approved under subregulation (1) are
 - (a) attendance, including by means of audiolink or videolink, at a training course provided by a specified body or person and successful completion of any assessment requirements for that course;
 - (b) attendance, including by means of audiolink or videolink, at a seminar presented by a specified body or person and successful completion of any assessment requirements for that seminar;
 - (c) viewing of a specified recording and successful completion of any assessment requirements for that viewing;
 - (d) participation in a specified course of study, or a specified component of a course of study, and successful completion of any assessment requirements for that course or component.
- (6) In subregulations (1) and (5) —"specified" means specified by the Board in the notice published under subregulation (2) or (3).
- (7) An approval under subregulation (1) may apply in relation to all licensees to whom regulation 4B applies or to any class of such licensees.

Architects Act 2004

Architects Amendment Regulations 2007

Made by the Governor in Executive Council.

1. Citation

These regulations are the Architects Amendment Regulations 2007.

2. Commencement

These regulations come into operation as follows:

- (a) regulations 1 and 2 on the day on which these regulations are published in the *Gazette*;
- (b) the rest of the regulations on 1 January 2008.

3. The regulations amended

The amendments in these regulations are to the *Architects Regulations 2005*.

4. Part 3 Division 4 inserted

After regulation 16 the following Division is inserted in Part 3 —

۲,

Division 4 — Other matters relating to registration and licensing

16A. Duration of registration and licences

For the purposes of section 35 —

- (a) a registration that occurs after 2007 has effect until 30 June in the year following that in which the registration occurs; and
- (b) a licence that is granted after 2007 has effect until 30 June in the year following that in which the licence is granted.

16B. Renewal period

For the purposes of section 36(1), the renewal of a registration or a licence in 2008 is to be for a period of 18 months.

16C. When renewal fees fall due

- (1) For the purposes of section 37(1), the day on which the fee for the renewal, in 2008, of a person's registration or a corporation's licence falls due is
 - (a) 31 March 2008: or
 - (b) the day set by the Board under subregulation (3).
- (2) A registered person may apply to the Board for the Board to set a day after 31 March 2008 to be the day on which the fee for the renewal of the person's registration in 2008 falls due.
- (3) On an application under subregulation (2) the Board, if satisfied that the applicant is experiencing hardship, may set a day after 31 March 2008 but before 1 October 2008 to be the day on which the fee for the renewal of the person's registration in 2008 falls due.

- (4) For the purposes of section 37(1), the day on which the fee for the renewal, in a year after 2008, of a person's registration or a corporation's licence falls due is
 - (a) 30 September of that year ("the renewal year"); or
 - (b) the day set by the Board under subregulation (6).
- (5) A registered person may apply to the Board for the Board to set a day after 30 September of the renewal year to be the day on which the fee for the renewal of the person's registration in that year falls due.
- (6) On an application under subregulation (5) the Board, if satisfied that the applicant is experiencing hardship, may set a day after 30 September in the renewal year but before 1 April in the following year to be the day on which the fee for the renewal of the person's registration in the renewal year falls due.

16D. Reduction or refund of renewal fee for registered persons

The Board may, of its own volition, reduce or refund part of a renewal fee payable or paid by a registered person if the Board —

- (a) does not impose a condition of the kind mentioned in section 30(2)(a) in respect of the renewal of the registration; and
- (b) is satisfied that that part of the renewal fee would relate to the functions that the Board would have if such a condition were imposed.

Rights in Water and Irrigation Act 1914

Rights in Water and Irrigation Amendment Regulations (No. 3) 2007

Made by the Governor in Executive Council in Executive Council under the *Rights in Water and Irrigation Act 1914* section 27 and the *Water Agencies (Powers) Act 1984* section 37.

1. Citation

These regulations are the *Rights in Water and Irrigation Amendment Regulations (No. 3) 2007.*

2. Commencement

These regulations come into operation as follows:

- (a) regulations 1 and 2 on the day on which these regulations are published in the *Gazette*;
- (b) the rest of the regulations on the day after that day.

3. The regulations amended

The amendments in these regulations are to the *Rights in Water* and *Irrigation Regulations 2000*.

4. Regulation 3 amended





"5A. Bycatch of deep sea crab

- (1) The master of an authorised boat that is being used for fishing in the Fishery must ensure that any deep sea crab taken from the sea and brought on board the boat—
 - (a) is released to the sea within 5 minutes of being taken; and
 - (b) if taken by means of a rock lobster pot, is released to the sea before any other rock lobster pot is pulled.
- (2) Despite subclause (1) the master of an authorised boat may allow—
 - (a) not more than 12 deep sea crabs to be on the boat at any time; and
 - (b) not more than 12 deep sea crabs to be landed ashore from the boat in any one day.
- (3) The master of an authorised boat must not permit any deep sea crab to be transferred—
 - (a) from that boat to another boat; or
 - (b) to that boat from another boat.
- (4) For the purposes of this clause "one day' has the same meaning as in regulation 3 of the regulations.".


